Grand Junction, Colorado

February 19, 1941

The City Council of the City of Grand Junction, Colorado, met in regular adjourned session, in lieu of the regular 7:30 o'clock meeting, at 5:00 o'clock P.M. Councilmen present and answering at roll call were - Robb, Garrison, Boston, Carson, Treece, and President Ross. Councilman Campbell was absent. City Manager Brownson, City Attorney Hinman, and City Clerk Tomlinson were present.

The minutes of the regular meeting held February 5th were read and approved.

The Proof of Publication to the proposed ordinance entitled "An Ordinance Amending Section 29 (a) of Article VI of Ordinance No. 529", was introduced and read. It was moved by Councilman Garrison and seconded by Councilman Carson that the Proof of Publication be accepted and filed. Motion carried.

Upon motion of Councilman Carson and seconded by Councilman Robb the ordinance was then called up for final passage. Motion carried.

Councilman Boston then moved, seconded by Councilman Carson that the proposed ordinance be amended as follows: at the end of Section 29 (a), following "between Tenth Street and Twelfth Street", add "and on the North Side of Main Street between First Street and Second Street". Motion carried.

It was then moved by Councilman Carson and seconded by Councilman Boston that the ordinance be passed and adopted as amended, numbered 644 and ordered published. Roll was called on the motion with all members of the Council present voting AYE. The President declared the motion carried.

The Proof of Publication to the Proposed ordinance entitled, "An Ordinance Amending that Portion of Section 1 of Ordinance No. 606 Which Relates to and Defines Milk Products for the Purpose of said Ordinance", was introduced and read. It was moved by Councilman Carson and seconded by Councilman Robb that the Proof of Publication be accepted and filed. Motion carried.

It was moved by Councilman Robb and seconded by Councilman Treece that the Ordinance be brought up for final passage. Motion carried.

The ordinance was then read and upon motion of Councilman Boston and seconded by Councilman Garrison was passed, adopted, and ordered published. Roll was called on the motion with all members of the Council present voting AYE. The President declared the motion carried.

The N.Y.A. Girls' Residence Center project has been established with the girls' dormitory being located at 1044 Ute and the work shop at 431 Colorado. Mesa County has agreed to pay the rent on the two buildings which will amount to \$100.00 per month. The City has been asked to furnish the water on the two buildings, and \$50.00 per month for other expenses.

The following resolution was presented and read:

RESOLUTION

WHEREAS, it is deemed proper and beneficial to the City at large that Grand Junction cooperate with the Mesa County authorities in sponsoring a N.Y.A. Girls' Residence center in this City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Grand Junction:

That the City Manager be authorized and directed to assign \$50.00 per month of the rent received by said City from Mesa County on the Surplus Commodities Building to said N.Y.A. Girls' Residence Center.

It was moved by Councilman Carson and seconded by Councilman Garrison that the Resolution be passed and adopted as read. Roll was called on the motion with all members of the Council present voting AYE. The President declared the motion carried.

Mr. Brownson explained that the Chamber of Commerce had rendered a statement in the amount of \$67.00 for1/3 of the expense of the trip to Washington of W. C. Kurtz, in the interests of the community. It was moved by Councilman Carson and seconded by Councilman Treece that the City Manager be authorized to pay \$67.00 to the Chamber of Commerce, from the Miscellaneous Fund for this share of expenses. Roll was called on the motion with all members of the Council present voting AYE. The President declared the motion carried.

The report of the audit of the City's books for the year 1940 by Mr. James E. Ragan was presented. It was moved by Councilman Carson and seconded by Councilman Garrison that the report be referred to the Finance Committee. Motion carried.

Mr. Brownson made a report on the survey of the condition of the old sidewalks and the need for additional walks.

Bonds for George Unfred and P. C. Lowe, plumbers and Earl Van Gundy junk dealer, having been approved as to form by the City Attorney were presented. It was moved by Councilman Carson and seconded by Councilman Boston that the bonds be accepted and filed. Motion carried.

It was moved by Councilman Carson and seconded by Councilman Boston that the meeting adjourn. Motion carried.
