## April 9, 1941

The City Council of the City of Grand Junction, Colorado, met in regular adjourned session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Robb, Garrison, Campbell, Boston, Carson, Treece and President Ross. Councilmen absent - None. City Manager Brownson, City Attorney Hinman and City Clerk Tomlinson were present.

The Council met as a Canvassing Board to canvas the returns of the election held April 8th, and as five members were candidates, the following Notaries were appointed to act in their places - Alvin E. Borschell, Marion Fletcher, Cleo O. Diemer, Phabian L. Welch and Helen C. Tomlinson. The Board then proceeded to canvas the returns and made the following report to the Council:

#### TALLY SHEET

We, the undersigned, acting as canvassing board, hereby certify that we have canvassed the returns of the municipal election held in the City of Grand Junction, Colorado, on April 8th, 1941, and from the said canvas find the results to be as follows: that 147 ballots were cast in District "A"; that 175 ballots were cast in District "B"; that 141 ballots were cast in District "C"; that 180 ballots were cast in District "D"; that 171 ballots were cast in District "E"; making a total number of 814 ballots cast in all the Districts at said election. It was moved by Councilman Treece and seconded by Councilman Campbell that the report of the Canvassing Board be approved and accepted and that the following named persons be declared elected: O. E. Boston, Councilman from District "A" for a four-year term; Glen L. Robb, Councilman from District "B" for an unexpired two-year term; Porter Carson, Councilman from District "D" for a four-year term; and C. E. Ross, Councilman from District "E" for a four-year term; and Carl F. Fox, Councilman from the City at Large for a four-year term. That People's Ordinance No. 27 be declared passed and adopted by the people. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

A request was made that water be extended to the new Tope School, and a guarantee for 10% of the cost in water rent, was made. It was moved by Councilman Carson and seconded by Councilman Campbell that the request be granted and a water main extension to Tope School and the west half of Block "A", College Subdivision be constructed. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

It was moved by Councilman Carson and seconded by Councilman Robb that the meeting adjourn. Motion carried.
