

Grand Junction, Colorado

July 2, 1941

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Carson, Fox, Ross, Boston, Robb, Treece and President Campbell. City Manager Brownson, City Attorney Hinman, and City Clerk Tomlinson were present.

The minutes of the regular meeting held June 18th were read and approved.

It was moved by Councilman Carson and seconded by Councilman Fox that notice be published advertising for bids for the construction of Sidewalk District No. 11. Said bids to be presented and opened July 16th at 10:00 o'clock, A. M. Motion carried.

All of the property owners on Tenth Street between Belford and North Avenue have requested that the sidewalk to be constructed along this street be placed at the curb line, rather than the usual location, two feet from the property line. Sidewalks constructed two feet from the property line would interfere with numerous trees and shrubs, and the property owners do not want the sidewalk constructed at all at this time, unless it can be placed at the curb line. It was moved by Councilman Carson and seconded by Councilman Fox that the request of the property owners be granted, and the following resolution passed and adopted. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

RESOLUTION

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That on and along the east and west sides of Tenth Street from Belford Avenue to North Avenue, where curbs have been or will be hereafter constructed at the same time or prior to the installation of sidewalk, said sidewalk shall be constructed with the outer edge of the walk in line with and against the back line of said curb.

Mr. Flannery has requested permission to construct a 10-foot driveway at 342 Colorado Avenue to replace the wooden incline which has been in use at this location since 1926. It was moved by Councilman Carson and seconded by Councilman Boston that the request be granted. Motion carried.

Copeland's Apothecary requested that their liquor license be transferred to their new location at 500 Main St. They have already had their State license transferred. It was moved by

Councilman Robb and seconded by Councilman Boston that the request be granted and the license transferred. Motion carried.

The N.Y.A. have given up their locations at 1044 Ute and 431 Colorado for their Girls Residence Center and have made tentative arrangements to take over 1045 Grand Ave for the dormitory for this project, with the work project being at the Mesa College farm. The new fiscal year begins July 1st, and the N.Y.A. are requesting that the City and County sponsor the project again, the County to donate \$400.00 and the City \$200, including sewer and water rentals for the year ending June 30, 1942.

Several of the residents in the neighborhood of 1045 Grand Ave. were present and protested against the establishment of the Girls Residence center at that location. The Council finally agreed to help sponsor the project but at a different location, if a suitable one could be found.

Some discussion was had about a vacation for Judge Cherrington, but no definite decision reached.

City Manager Brownson stated that there had been a request made to him from the City employees who work by the hour, that they receive a vacation each year with pay. The Council suggested that Mr. Brownson try to work out some plan to given their request consideration.

It was moved by Councilman Boston and seconded by Councilman Carson that the meeting adjourn until Wednesday evening July 9th at 7:30 o'clock. Motion carried.
