Grand Junction, Colorado

October 1, 1941

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Carson, Ross, Boston, Robb, Treece and President Campbell. City Manager Brownson, City Attorney Hinman and City Clerk Tomlinson were also present.

Minutes for the regular meeting held September 17th and the special meeting held September 24th were read and approved.

Councilman Fox has been forced to leave Grand Junction on account of his wife's health, and he therefore filed his resignation, effective October 1st. It was moved by Councilman Carson and seconded by Councilman Ross that the resignation of Carl F. Fox be accepted. Motion carried.

There were several names mentioned in connection with appointment of a Councilman to take Mr. Fox's place, but the matter was deferred until the next regular meeting of the City Council.

The Proof of Publication to the ordinance entitled, "AN ORDINANCE REGULATING THE SALE OF FERMENTED MALT BEVERAGES", was introduced and read. It was moved by Councilman Carson and seconded by Councilman Robb that the Proof of Publication be accepted and filed. Motion carried.

It was then moved by Councilman Robb and seconded by Councilman Boston that the ordinance be called up for final passage. Motion carried.

The ordinance was then read, and it was moved by Councilman Ross and seconded by Councilman Treece that it be passed and adopted, numbered 651 and published. Roll was called on the motion with the following result: Councilmen voting AYE - Carson, Ross, Boston, Robb, Treece. Councilmen voting NO - Campbell. A majority of the Councilmen voting AYE, the President declared the motion carried.

Mr. Willsea, of the Central Chevrolet Co. again requested that he be allowed to construct a fifteen-foot driveway in front of Lot 27, Block 118. He stated in his letter to the Council that he intended to create a parking lot on this location, enclosing these lots with a neat woven wire fence and graveling the lots. Much of the sidewalk in front of the property will be replaced during the time Sidewalk District No. 11 is constructed and it would be the best time to have the driveway built. It was moved by Councilman Ross and seconded by Councilman Treece that the request be granted. Motion carried, with Councilman Carson voting NO.

Ann Easley and Jennette Christensen presented an application for a 3.2 beer license for Grace's Cafe at 120 Pitkin Ave. They having purchased this restaurant from Mrs. Hulda Lehman. A letter from Chief of Police Scott was read, in which he stated that Mrs. Christensen, under the name of Jennette Lloyd was convicted by the Federal Alcohol Tas Unit October 5th, 1936, of "Bootlegging", and received a fine and sentence of \$100.00 and 30 days in jail. Therefore, he could only report his findings to the Council.

It was moved by Councilman Ross and seconded by Councilman Carson that the license for Ann Easley and Jennette Christensen be denied for reasons set forth in Chief of Police Scott's report. Motion carried.

Considerable discussion was had concerning regulations for bicycles and it was suggested that a proposed ordinance concerning same be drawn up and submitted for the Council's consideration.

Estimate No. 2 for Sidewalk District No. 11 was presented. The work performed to September 30 amounts to \$10,366.88, less 10% retained, \$1,036.69, leaving the total amount due, \$9,330.19, less previous payment \$5,136.78, leaving \$4,193.41, due. It was moved by Councilman Carson and seconded by Councilman Robb that the Estimate No. 2 be allowed and the City Clerk instructed to draw a warrant in the amount of \$4,193.41 in favor of J. A. Cox and Son. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

It was moved by Councilman Carson and seconded by Councilman Ross that the meeting adjourn. Motion carried.
