

Grand Junction, Colorado

November 5, 1941

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Carson, Ross, Hoisington, Boston, Robb, Treece, and President Campbell. City Manager Brownson, City Attorney Hinman and City Clerk Tomlinson were also present.

The minutes of the regular meeting held October 15th and the regular adjourned meetings held October 22nd and 29th were read and approved.

Estimate No. 3 for J. A. Cox and Son for Sidewalk District No. 11 was presented. The work performed to October 31st amounts to \$15,465.30, less 10% retained, \$1,546.53, leaving the total amount due on contract of \$13,918.77. Previous payments in the amount of \$9,330.19 have been made, which leaves a balance of \$4,588.58 due Mr. Cox at this time. It was moved by Councilman Carson & seconded by Councilman Ross that the estimate be allowed and the City Clerk instructed to write a warrant to Mr. Cox in the amount of \$4,588.58. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

The following resolution was presented and read:

RESOLUTION

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That on and along Thirteenth Street between Colorado and Ute Avenues, where curbs have been constructed prior to the installation of sidewalk, said sidewalk shall be constructed with the outer edge of the walk in line with and against the back line of said curb.

It was moved by Councilman Ross and seconded by Councilman Carson that the Resolution be passed and adopted as read. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

The C. A. A. have advised the City that the lease with Eddie Drapela for the use of the airport is not altogether satisfactory, so City Attorney Hinman and City Manager Brownson have drawn up an addendum to the present lease incorporating all the requested changes, This addendum was read to the Council.

It was moved by Councilman Ross and seconded by Councilman Treece that the City Manager be authorized to execute the addendum to the airport lease. Roll was called on the motion with all

members of the Council voting AYE. The President declared the motion carried.

A committee representing the cigarette dealers appeared before the Council and requested that the license fee for cigarettes be reduced to \$10.00. A petition signed by 38 cigarette dealers was also presented. It was moved by Councilman Carson and seconded by Councilman Treece that the petition be accepted and filed, and consideration be given to the license fee reduction when the 1942 budget is worked out in detail. Motion carried.

A request was made by the American Legion that the Council lower the rental for the auditorium for the three days the Polack circus showed there. The usual fee of \$25.00 per day had been charged for the use of the auditorium. It was pointed out that the Legion only made \$138.00 on the circus. It was moved by Councilman Carson and seconded by Councilman Robb that the American Legion pay \$38.00 for the use of the auditorium for the three days Polack circus. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

It was moved by Councilman Ross and seconded by Councilman Carson that the meeting adjourn until November 17th at 7:30 o'clock. Motion carried.
