Grand Junction, Colorado February 4, 1942

The City Council of the City of Grand Junction, Colorado, met in regular session at 8:00 o'clock P. M. Councilmen present and answering at roll call were Carson, Ross, Hoisington, Boston, Treece and President Campbell. City Manager Brownson, City Attorney Hinman and City Clerk Tomlinson were present.

The minutes of the regular meeting held January 21st were read and approved.

Mr. E. R. Thomas appeared before the Council in connection with the granting of the LaCourt Hotel restaurant liquor license. It was moved by Councilman Carson and seconded by Councilman Treece that the LaCourt Hotel be granted a restaurant liquor license when they have received their State license. Roll was called on the motion with the following result: Councilmen voting AYE - Carson, Ross, Hoisington, Boston, Treece and Campbell. Councilmen voting No - None. All of the Councilmen present voting AYE, the President declared the motion carried.

The City Clerk reported that no protests had been filed against the assessments for Sidewalk District No. 11. The following proposed ordinance was introduced and read: "An Ordinance Approving the Whole Cost of the Improvements Made in and for Sidewalk District No. 11, in the City of Grand Junction, Colorado, Pursuant to Ordinance No. 178, Adopted and Approved the 11th Day of June, 1910, As Amended; Approving the Apportionment of said Cost to Each Lot or Tract of Land or Other Real Estate in said District; Assessing the Share of said Cost Against each Lot or Tract of Land or Other Real Estate in said District; and Prescribing the Manner for the Collection and Payment of said Assessments." It was moved by Councilman Carson and seconded by Councilman Ross that the proposed ordinance be passed for publication. Motion carried.

Councilman Robb came in at this time.

City Manager Brownson read a letter from David Lawrence, representing Boettcher and Co., regarding the refunding of the special assessment refunding bonds, showing that he could make a saving to the City of about \$3,000.00. In the discussion, it was brought out that most of the bonds that were to be refunded were held by local investors. It was moved by Councilman Carson and seconded by Councilman Ross that this matter be laid over until the next meeting of the Council, for further consideration.

City Manager Brownson reported that meetings had been held on January 14th and 20th by a group representing the various service clubs in connection with traffic regulations and most particularly discussed the question of parallel parking vs. diagonal parking. After considerable discussion, it was moved by Councilman Carson

and seconded by Councilman Hoisington that the matter of traffic regulations be tabled. Motion carried.

Safeway Stores, Inc. made an application for the renewal of their 3.2 beer license for the store at 217 North 7th St. It was moved by Councilman Carson and seconded by Councilman Hoisington that the license be granted. Motion carried.

Bonds for John Fuite, dba Mt. Garfield Plumbing Co. P.C. Lowe, plumber and Ralph Spence, Cement Contractor, were presented, having been approved as to form by City Attorney Hinman. It was moved by Councilman Robb and seconded by Councilman Treece that the bonds be accepted and filed. Motion carried.

City Manager Brownson reported that he had received a proposal for power rates from Chas. Rump, manager of the Public Service Co. It was proposed to charge 2 1/2 per Kwh on the combined use for power for the filtration plant, sewage disposal plant and gravel plant and Moyer Pool, with a minimum for a year of \$720.00. Mr. Brownson reported that he had not had an opportunity to thoroughly check this proposal. It was moved by Councilman Carson and seconded by Councilman Boston that the proposed rate be approved subject to the approval of the City Manager and City Attorney. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

It was moved by Councilman Boston and seconded by Councilman Hoisington that the meeting adjourn. Motion carried.
