Grand Junction, Colorado April 1, 1942

The City Council of the City of Grand Junction, Colorado met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were; Carson, Ross, Hoisington, Boston, Robb, Treece and President Campbell. Also present were City Manager Brownson, City Attorney Hinman, and City Clerk Tomlinson.

The minutes of the regular meeting held March 18th were read and approved.

The report of James E. Ragan, auditor, for the affairs of the City for the year 1941 was presented and the letter of transmittal was read by the City Clerk. It was moved by Councilman Carson and seconded by Councilman Ross that the report be referred to the financial committee, Councilmen Treece and Hoisington. Motion carried.

Applications for the renewal of 3.2 beer licenses for City Market, Interstate Cigar Store and Safeway Stores, were presented. It was moved by Councilman Robb and seconded by Councilman Hoisington that the applications be approved and licenses granted. Motion carried.

City Manager Brownson reported that numerous residents of Henderson Heights Subdivision, which is located east of Twelfth Street and south of Elm Avenue have indicated their desire to bring this subdivision into the City. Many of the property owners residing in the territory between Twelfth and Fifteenth Streets and North and Elm Avenues do not desire to come into the City at this time. Considerable discussion was had by the Council in regard to taking in property, and what the policy should be in annexing same. It was moved by Councilman Hoisington and seconded by Councilman Carson that the City Council favored taking in contiguous territory, and that all the property between North Avenue and Elm Avenue, including Henderson Heights Subdivision, be annexed together. Motion carried.

The matter of parking bicycles in the business district was brought up and discussed. Mr. Brownson stated that he had been working on a tentative draft of a bicycle ordinance regulating these vehicles and wanted an expression of the Council on various phases of the matter. It was agreed that Mr. Brownson should find out about parking spaces and racks in the business district and report back to the Council.

A supplemental agreement to our lease covering the site for CCC Camps BR-22-C and G-2-C was received from the office of the District Quartermaster. This supplement provides that "The existing permission granted the Civilian Conservation Corps continues in effect, and the armed forces of the United States are hereby authorized use of the above described premises to be determined by proper governmental authority, for the duration of the emergency or until such time as need by the armed forces no longer exists." It was moved by Councilman Carson and seconded by Councilman Treece that the City Manager be authorized to execute the supplemental agreement on behalf of the City of Grand Junction. Motion carried.

It was reported that C. E. Cherrington had resumed his duties as Judge of the Municipal Court after a leave of absence of several months due to illness.

Mr. Brownson reported that Mr. Munro, C.A.A. engineer had been in the City and they had made additional investigations and inspections in regard to the airport.

The bond of Fred McKenzie, having been approved as to form by the City Attorney was presented. It was moved by Councilman Boston and seconded by Councilman Treece that the bond be accepted and filed. Motion carried.

It was moved by Councilman Carson and seconded by Councilman Boston that the meeting adjourn. Motion carried.
