

Grand Junction, Colorado  
May 20, 1942

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Carson, Ross, Hoisington, Boston, Robb, Campbell, and President Treece. Also present were City Manager Brownson, City Attorney Hinman, and City Clerk Tomlinson.

The minutes of the regular meeting held May 6th were read and approved.

Applications for the renewal of beer licenses for Arthur Burgess, 904 North 7th St., Eugene Longo, 322 South 2nd St., and Barbour's Money Saver Grocery, 616 North Ave., were presented. It was moved by Councilman Robb and seconded by Councilman Campbell that the applications be approved and licenses granted. Motion carried.

A request was made for the use of the auditorium on June 9th for a banquet and meeting of Boy Scout leaders. They requested that they be allowed the use of the auditorium for \$10.00. It was moved by Councilman Carson and seconded by Councilman Ross that the request be granted.

The Crescent Creamery made a request that they be allowed to put tires made from wood, with steel rims on their truck, so that deliveries could be made oftener than once a day. It was explained that new regulations would prohibit any motor-propelled vehicle from making more than one delivery a day, regardless of the tires used. It was the sense of the Council that whatever regulations were allowed by the State Highway would be satisfactory with the City.

City Manager Brownson suggested that a \$5.00 raise be allowed to all City employees during the emergency of the high prices because of the war. He explained to the Council that there were about 90 employees, which would mean around \$450.00 per month increase. It was moved by Councilman Carson and seconded by Councilman Robb that the City Manager and City Attorney be directed to draw up an ordinance raising the pay of all City employees \$5.00 per month, until further action of the City Council. Motion carried.

The Colorado Municipal League convention meets in Ft. Collins on June 12 and 13. City Attorney Hinman has been scheduled to appear on the program and City Manager Brownson to act on the Resolutions Committee. Mr. Brownson stated that there were several things of interest on the program this year.

Some discussion was had on the airport question and particularly the new lease for the use of the hanger and port when complete.

It was moved by Councilman Campbell and seconded by Councilman Robb that the City Manager and City Attorney be authorized to go do Denver and investigate matters pertaining to the airport and to go on to Ft. Collins and attend the Municipal League Convention. Roll was called upon the motion with all members of the Council voting AYE. The President declared the motion carried.

City Manager Brownson reported that several dairies had gone out of business, leaving just three who are now producing Grade A milk. Two of these are prepared to pasteurize all the milk. It had been suggested that the ordinance concerning the regulation of milk be changed allowing only Pasteurized milk. The Council agreed that it was best to make no changes in the milk ordinance at the present time.

It was moved by Councilman Robb and seconded by Councilman Campbell that the meeting adjourn. Motion carried.
