

Grand Junction, Colorado
June 3, 1942

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Carson, Ross, Hoisington, Boston, Robb, Campbell and President Treece. City Manager Brownson, City Attorney Hinman and City Clerk Tomlinson were also present.

The minutes of the regular meeting held May 20th were read and approved.

City Manager Brownson reported that he had received the notice of the Renewal of the agreement for the site of CCC Camps BR 22 C and G 2 C on May 22nd, with the request that it be signed and returned at once. He had, therefore, signed and returned the agreement. He had also received notice from the CCC District Quartermaster that the U. S. Government will not exercise the option of renewal of the least covering buildings and land now occupied by the Grand Junction Distributing Point, and that the lease will be terminated effective June 30, 1942. So far no other agency had been interested in leasing this property.

It was moved by Councilman Campbell and seconded by Councilman Ross that the City Council ratify the action of the City Manager in executing the renewal of the agreement for the CCC Camps BR 22 C and G 2 C. Motion carried.

B. C. Reynolds, County Treasurer, in a letter to the Council stated that an error had been made on Tax Sale Certificate No. 50792. The property was sold with this description: The S 20 ft. of Lot 18, S. of canal except the S. 125 ft. thereof in Block 2, Craig's Subdivision of Lot 17, Capitol Hill Subdivision. It should have been the S. 20 ft. of Lot 18, S. of canal except the S. 125 ft. thereof in Capitol Hill Subdivision. The certificate is for Paving District No. 46.

It was moved by Councilman Carson and seconded by Councilman Campbell that the following resolution be passed and adopted. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

RESOLUTION

WHEREAS, Error in the description appearing in Tax Sale Certificate No. 50792 covering tax sale of December 26th, 1941 on Paving District No. 46, City of Grand Junction, Colorado; and

WHEREAS, The County Treasurer has requested that the City Council authorize the cancellation of said certificate for the year 1941;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the

City of Grand Junction that the request of the County Treasurer be granted and the tax sale certificates be canceled in accordance therewith; provided, however, that the cancellation of the erroneous tax sale certificate as above described shall in no way effect or invalidate the regular assessments on the property that should have been properly included.

The following entitled ordinance was introduced and read - "An Ordinance Temporarily Increasing Wages and Salaries of City Employees". It was moved by Councilman Ross and seconded by Councilman Campbell that the Ordinance be passed and adopted as an emergency ordinance, numbered 655, and ordered published. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

It was reported that Judge C. E. Cherrington, was ill and had gone to Denver for medical care. It was moved by Councilman Carson and seconded by Councilman Boston that Virgil P. Groves be appointed Judge of the Municipal Court Pro-tem, effective June 2nd, 1942, and to continue during the absence of Judge Cherrington. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

Applications for the renewal of beer licenses for the following were presented: Moslander's Cigar Store, 541 Main St.; White Kitchen, 120 North Fourth St.; Bryant's Cafe, 529 Main St. It was moved by Councilman Campbell and seconded by Councilman Carson that the beer license be granted. Motion carried.

So far it has been impossible to invest all of the water funds satisfactorily. Mr. Brownson reported that he had been advised that another Treasury Department offering will be made in June, and suggested that the Council authorize the purchase of bonds when they were available and if medium maturities are offered. He also suggested the purchase of Series G Bonds as an alternate.

It was moved by Councilman Campbell and seconded by Councilman Robb that the City Manager be authorized to purchase bonds for investment of water monies in Treasury Department offering of the class and maturities which he may deem advisable and to the extent of the availability of the Water Funds. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

J. W. Hayden appeared before the Council and presented a plan to cut down the mileage on his buses. He proposed to cut off his buses at 10:30 P.M. and to only run one bus on Sunday. It was moved by Councilman Carson and seconded by Councilman Boston that the matter be tabled for further action at a later meeting. Motion carried.

President Treece announced the following Committees would

serve during his term as President.

It was moved by Councilman Carson and duly seconded that the meeting adjourn. Motion carried.
