## Grand Junction, Colorado July 29, 1942

The City Council of the City of Grand Junction, Colorado, met in regular adjourned session at 7:30 o'clock P.M. Councilmen present and answering at roll call were: Carson, Ross, Hoisington, Boston, Robb and President Treece. Councilman Campbell was absent. Also present were City Manager Brownson, City Attorney Hinman, and City Clerk Tomlinson.

It was moved by Councilman Carson and seconded by Councilman Robb that the meeting adjourn to the Y.M.C.A. for inspection of the building, as a Committee of the whole. Motion carried.

After a considerable time, the Council reconvened, in the Council room, all members excepting Councilman Campbell being present.

A committee of the Y.M.C.A. Board of Directors composed of James Gormley, Eugene Mast and Warren Ferrin met with the Council then, discussing the proposal of the Y.M.C.A. Board to make a gift of the Y.M.C.A. property to the City, subject to the existing indebtedness of approximately \$12,500.

After considerable discussion, it was moved by Councilman Carson and seconded by Councilman Robb that the proposal be accepted and that upon tender of proper deeds of conveyance, approved by the City Attorney, the same be accepted. Motion carried.

A committee from the Chamber of Commerce consisting of Wyatt Wood and M. N. Due met with the Council and discussed the proposal of the U.S. Army postponing any action upon the erection of a hospital near Grand Junction for some time. From reliable sources they had learned that if the City would offer the "Teller 40" to the U. S. Army for hospital purposes, it might change the decision to postpone any action upon the hospital for another year. After considerable discussion it was moved by Councilman Boston and seconded by Councilman Hoisington that the City Manager be authorized to offer to appropriate Army Medical officials the "Teller 40" (the NW 1/4 of the NE 1/4, Section 13, T. 1 S., R. 1 W., Ute Meridian) for use as an army hospital and to communicate such decision of the City Council immediately to the proper officials. Roll was called on the motion with the following result: Councilmen voting AYE - Carson, Ross, Hoisington, Boston, Robb, Treece. Councilmen voting No, None. All of the Councilmen voting AYE, the President declared the motion carried.

The matter of the liquor license for Howard Ponder and O. K. Osborne was brought up and discussed. It was moved by Councilman Carson and seconded by Councilman Robb that the license be granted when they have received their State license. Motion carried.

The Proof of Publication to the proposed ordinance entitled, "AN ORDINANCE FIXING TANK WATER RATES, AND REPEALING CONFLICTING ORDINANCES", was introduced and read. It was moved by Councilman Carson and seconded by Councilman Hoisington that the Proof of Publication be accepted and filed. Motion carried.

It was then moved by Councilman Robb and seconded by Councilman Boston that the ordinance be called up for final passage. Motion carried.

The ordinance was then read, and upon motion of Councilman Robb and seconded by Councilman Carson was passed and adopted, numbered 657 and ordered published. Roll was called on the motion with all members of the Council present voting AYE. The President declared the motion carried.

It was moved by Councilman Boston and seconded by Councilman Ross that the meeting adjourn. Motion carried.
