Grand Junction, Colorado August 19, 1942

The City Council of the City of Grand Junction, Colorado, met in regular session at 8:00 o'clock P.M. Councilman present and answering roll call were: Ross, Carson, Hoisington, Boston, Robb, Campbell, and President Treece. Also present were City Manager Brownson, City Attorney Hinman, and City Clerk Tomlinson.

The minutes of the regular meeting held August 5th were read and approved.

Mr. Brownson reported that a number of investment firms had indicated a desire to submit proposals for the refunding of Grand Junction Refunding Improvement bonds. There are now outstanding bonds in this issue, in the amount of \$214,000.00, and it has been indicated that considerable money could be saved by refunding them about November 1st. It was moved by Councilman Carson and seconded by Councilman Hoisington that the City Manager be authorized to notify various investment firms that the City Council would consider sealed proposals for refunding Grand Junction Refunding Improvement Bonds and Sidewalk District No. 11 and Paving District No. 47 bonds, and that such sealed proposals be submitted to the City Manager and he in turn to submit them to the Council at their next regular meeting on September 2nd. All bids and proposals to be subject to rejection by the Council. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.
