## Grand Junction, Colorado October 7, 1942

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P.M. Councilmen present and answering at roll call were: Carson, Ross, Hoisington, Boston, Campbell and President Treece. Councilman Robb was absent. City Manager Brownson, City Attorney Hinman, and City Clerk Tomlinson were present.

The minutes of the regular meeting held September 16th and the regular adjourned meeting held September 21st were read and approved.

Eddie Drapela operator of the Airport was present and spoke to the Council about the prospects for an enlarged C.P.T. program, and the necessity for increased hangar facilities at the field. After considerable discussion it was moved by Councilman Carson and seconded by Councilman Ross that the matter be referred to the City Manager to work out a satisfactory program, and report back to the City Council at a later meeting. Motion carried.

The following entitled proposed ordinance was introduced and read: "An Ordinance Approving the Whole Cost of the Improvements Made in and for Paving District No. 47, in the City of Grand Junction, Colorado, Pursuant to Ordinance No. 178, Adopted and Approved June 11, 1910, as amended; Approving the Apportionment of Said Cost to Each Lot or Tract of Land or Other Real Estate in Said District: Assessing the Share of said Cost Against each Lot or Tract of Land or Other Real Estate in Said District; and Approving the Apportionment of Said Cost: and Prescribing the Manner for the Collection and Payment of Said Assessments", It was moved by Councilman Carson and seconded by Councilman Hoisington that the proposed ordinance be passed for publication. Motion carried.

The 57 Cab Service requested permission to move their telephone from 11th and Grand to 10th and Grand. It was moved by Councilman Carson and seconded by Councilman Ross that a revocable permit be granted to the 57 Cab Service for the use of a telephone on Tenth and Grand Avenue instead of the one they now are using at the corner of 11th and Grand. Motion carried.

Lieut. Klandrud, Commander of the Motor Training School has asked about fees for service men using the Lincoln Park Golf Course. It was moved by Councilman Campbell and seconded by Councilman Carson that service men be granted the privilege of using the Lincoln Park Golf Course for the balance of the year 1942, without charge. Motion carried.

Mr. Ross expressed the thanks of Mrs. Ross and himself for the flowers sent to them by the Council at the time of the death of their son.

Councilman Campbell, on behalf of the Finance Committee, stated that they had met with City Treasurer Stringer. Mr. Stringer would like to work part time and have his wife work the balance of the time. The Finance Committee recommended that if this could be worked out legally, that it be tried temporarily.

It was moved by Councilman Carson and seconded by Councilman Ross that the report of the Finance Committee in regard to Francis Stringer be accepted. Motion carried.

It was moved by Councilman Carson and seconded by Councilman Hoisington that the meeting adjourn until Wednesday, October 14th, 1942, at 7:30 o'clock P.M. Motion carried.
