

Grand Junction, Colorado
November 18, 1942

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Carson, Ross, Hoisington, Boston, Robb, Campbell and President Treece. City Manager Brownson and City Clerk Tomlinson were present.

The minutes of the regular meeting held November 4th were read and approved.

It was moved by Councilman Ross and seconded by Councilman Carson that the City Manager and City Clerk be instructed to prepare a suitable resolution conveying the City Council's regrets at the death of City Attorney Hinman, and that same be sent to Mrs. Hinman and son at this time.

A letter from Mr. Keith, Chief of Police, was read, in which he stated that the Police Department had no objection to the granting of the renewal of the above licenses.

It was moved by Councilman Carson and seconded by Councilman Boston that the applications be approved and licenses granted as soon as they have received their State licenses.

An application for a restaurant liquor license was presented by Robert J. Groom, Jr. and J. E. Dixon for the Campbell's Cafe at 333 Main Street. It was moved by Councilman Ross and seconded by Councilman Boston that the application be rejected for the reason that the locality is adequately served. Roll was called on the motion with the following result: Councilmen voting AYE - Carson, Ross, Hoisington, Boston and Robb. Councilmen voting NO - Campbell and Treece. A majority of the Councilmen voting AYE, the President declared the motion carried.

An application for a restaurant liquor license was presented for the Avalon Cafe by Josephine Ware. However sufficient time had not been allowed the Police Department for a report on this applicant, so it was deferred until a later date.

The committee representing MINUTE WOMEN AT WAR, with Mrs. Herman C. Graves as County Chairman, requested that the Council grant them permission to sell war stamps on the street on Saturday, November 28th, and that day be proclaimed as "War Stamp Day". The following proclamation was read:

PROCLAMATION

WHEREAS the women of America are celebrating the week of November 22 to 29, 1942, as MINUTE WOMEN AT WAR WEEK, and

WHEREAS the Grand Junction Women's Bond Sale Committee has arranged to make special efforts to sell war stamps on Saturday of this week,

THEREFORE, by authority of the City Council, I. T. J. Treece, President of the City Council of the City of Grand Junction, hereby proclaim Saturday, November 28, 1942,

WAR STAMP DAY

and call upon all loyal citizens to co-operate in the dedication of this day to the achievement of the high goals set by those in charge of selling stamps and thus assist in the solemn purpose of helping to finance the war effort.

It was moved by Councilman Campbell and seconded by Councilman Carson that the Proclamation be passed and adopted, and the MINUTE WOMEN AT WAR be granted permission to sell stamps on the street on November 28th. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

Drs. Munro and Paige were present and the milk situation was discusses at length. There is a very definite shortage of fluid milk supply in this vicinity, and this naturally leads to a condition hard to control. Dr. Paige stated that he would like to see the Milk Ordinance changed so that he would have authority to inspect the dairies supplying milk for all purposes, and also that all milk sold in the City be pasteurized. Mr. Clymer was also present and stated that he was the only dairy now selling raw milk, and that he would be glad to pasteurize his entire supply.

It was moved by Councilman Carson and seconded by Councilman Campbell that the City Manager be instructed to draw up an amendment to the Milk Ordinance conforming to Dr. Paige's and Dr. Munro's ideas, and present same at the next regular meeting of the Council. Motion carried.

It was moved by Councilman Carson and seconded by Councilman Hoisington that the meeting adjourn until Wednesday November 25th at 8:00 o'clock P. M. Motion carried.
