## Grand Junction, Colorado

## April 21st, 1943

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Carson, Ross, Hoisington, Boston, Campbell and President Treece. Councilman Robb was absent. Also present were City Manager Brownson, City Attorney Banks, and City Clerk Tomlinson.

The minutes of the regular meeting held April 7th were read and approved.

Mrs. Josephine Ware, proprietor of the Avalon Cafe requested that her liquor license be transferred to 335 Main Street. A petition of protest was filed by the property owners in the 300 block on Main Street, stating that they felt there were sufficient liquor stores and restaurants in that vicinity. It was moved by Councilman Ross and seconded by Councilman Hoisington that the request of Mrs. Ware be denied. Motion carried.

City Manager Brownson reported on recent developments in connection with the Airport and the C.A.A. Navy Pilot Training program. It had recently been announced that this school would be discontinued, and every effort has been made by all concerned in trying to get the school continued. Four Navy officials had been in conference with Mesa College, Chamber of Commerce, and City delegations during the day, and it is hoped that the matter will be re-considered.

It was reported that Thos. McCall and Son have completed their contract at the airport, and have certified that all material and labor bills have been paid. It was moved by Councilman Carson and seconded by Councilman Boston that the 10% balance, with held from McCall and Son for a period of thirty days, be paid to them. Roll was called on the motion with all members of the Council voting AYE on the motion. The President declared the motion carried.

City Manager Brownson reported that he had recently rented a small garage building on South 6th St. to the Specification Motor Oil System for the sum of \$10.00 per month. It was moved by Councilman Campbell and seconded by Councilman Carson that the action of the City Manager in renting this building be ratified by the Council. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

Mrs. Smith appeared before the Council and asked further reconsideration of her application to transfer her beer license from the Tavern Inn to the Depot Grill at 120 Pitkin Ave. Chief of Police Joe Keith also appeared before the Council and stated his views in the matter. It was moved by Councilman Carson and seconded by Councilman Campbell that the request of Mrs. Smith be

granted, and that her license be transferred to the Depot Grill. Roll was called on the motion with the following result: Councilmen voting AYE - Carson, Hoisington, Boston, Campbell, and Treece. Councilmen voting NO - Ross. A majority of the Councilmen present voting AYE, the President declared the motion carried.

It was moved by Councilman Carson and seconded by Councilman Ross that the meeting adjourn until Monday morning, May 3rd, at 10 o'clock A.M. Motion carried.
