

Grand Junction, Colorado

September 15, 1943

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P.M. Councilmen present and answering at roll call were: Carson, Ross, Hoisington, Boston, Treece, Campbell and President Robb. Also present were City Manager Brownson, City Attorney Banks and City Clerk Tomlinson.

The minutes of the regular meeting held September 1st were read and approved.

L. D. Harper and D. L. Leach, who have recently purchased the Money Saver Market presented an application for a 3.2 beer license. It was moved by Councilman Carson and seconded by Councilman Campbell that the license be granted. Motion carried.

It was reported to the Council that through an oversight, the Barbour Brothers operating the Money Saver Grocery & Market had not paid meat and cigarette licenses for the past three years. It was moved by Councilman Ross and seconded by Councilman Carson that this matter be referred to the City Attorney for collection. Motion carried.

Laycock Garage at 224 N. 7th requested permission to widen their driveway to 16 feet. It is now 12 feet. It was moved by Councilman Carson and seconded by Councilman Hoisington that the request be granted. Motion carried.

A letter to the Mesa County Commissioners from the Eagle Co. Commissioners asking the support of all Counties and Cities in getting the D. & R. G. R. R. Co. to reinstate Trains No. 15 and 16. It was moved by Councilman Campbell and seconded by Councilman Treece that the City Manager confer with the Railroad Officials on this matter. Motion carried.

The matter of maintaining roads and streets which divide the City limits from the County was discussed again. The Commissioners have requested that the City take over North 12th Street from North Avenue to Elm Avenue and that they would look after the maintenance of North 7th Street and Orchard Avenue. It was moved by Councilman Carson and seconded by Councilman Treece that the tentative agreement between the City Manager and the County Commissioners be ratified. Motion carried.

Mr. Brownson reported that the budget for seal-coating and repairing pavement has been expended for the year, but that there are sufficient funds in the rest of the Highway Department to continue to do considerable work yet this year. The Council instructed the City Manager to go ahead and do all possible repair work.

Mr. Brownson reported that the apron in front of the hangar

at the airport should be graveled and that the hangar should be painted, but that there is very little money left in the Airport Fund. It was moved by Councilman Carson and seconded by Councilman Ross that the City Manager be instructed to go ahead and gravel the apron in front of the hangar and also have the hangar painted, money to be used from the Airport Fund and the balance from the Special Contingent Fund. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

Other matters pertaining to the Airport were discussed and a committee - Councilmen Carson, Hoisington, and Campbell was appointed to be available to assist the City Manager in working out the problems in connection with the Airport, if it were found to be necessary.

It was moved by Councilman Carson and seconded by Councilman Boston that the meeting adjourn. Motion carried.
