

Grand Junction, Colorado

November 29, 1944

The City Council of the City of Grand Junction met in special session at 4:00 o'clock P. M., after due notice of call of meeting. Councilmen present and answering at roll call were: Carson, Harris, Robb, Treece, Campbell and President Hoisington. Councilman Boston was absent. Also present were City Manager Brownson, City Attorney Banks, and City Clerk Tomlinson.

It was moved by Councilman Carson and seconded by Councilman Harris that the Council waive formal notice of call. Motion carried.

The following applications for renewal of liquor licenses were presented:

Restaurant Beer and Wine - Carl R. Swenson dba Manhattan Cafe, 345 Main.

It was moved by Councilman Carson and seconded by Councilman Harris that the foregoing licenses be renewed when the State licenses have been received. Motion carried.

Ted. T. Hayashi presented an application for a Restaurant liquor license for the Royal Grill at 209 Colorado. He had formerly had a Beer and Wine license at this location. It was moved by Councilman Robb and seconded by Councilman Treece that the license be approved. Roll was called on the motion with the following result: Councilmen voting AYE - Harris, Robb, Treece and Campbell. Councilmen voting NO - Carson and Hoisington. A majority of the Councilmen present voting AYE, the President declared the motion carried, and the licenses duly granted.

A. Wayne Luellen presented an application for a liquor store license at 120 North Fourth Street and Antonio Stranges an application for a liquor store at 645 Rood Avenue. It was moved by Councilman Harris and seconded by Councilman Campbell that the licenses be approved. Roll was called on the motion with the

following result: Councilmen voting AYE - Carson, Harris, Robb, Treece, Campbell. Councilmen voting NO - Hoisington. A majority of the Councilmen present voting AYE, the President declared the motion carried, and the licenses duly granted.

The balance of the meeting was devoted to the consideration of plans for the improvement of Walker Field. Mr. Tom Wolfe, Vice-President of Western Air Lines outlining to the Council their plans for the future development in Grand Junction.

It was moved by Councilman Carson and seconded by Councilman Treece that the meeting adjourn. Motion carried.
