

Grand Junction Colorado

March 21, 1945

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Carson, Harris, Robb, Boston, Treece, Campbell and President Hoisington. Also present were City Manager Brownson, City Attorney Banks and City Clerk Tomlinson.

The minutes of the regular meeting held March 7th and the special meeting held March 15th were read and approved.

The matter of the Western Cafe liquor license being changed from 418 Main Street to 321 Main Street was brought up. Petitions signed by many of the business men in the 300 block on Main Street were filed, such petitions protesting the establishment of any more liquor stores or bars in that locality. It was moved by Councilman Carson and seconded by Councilman Treece that the request of the Western Cafe for a change of location be denied. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

The following election notice was presented and read:

PUBLIC NOTICE IS HEREBY GIVEN THAT A GENERAL MUNICIPAL ELECTION WILL BE HELD ON TUESDAY, THE 3RD DAY OF APRIL, A. D. 1945, AT THE POLLING PLACES HEREINAFTER DESIGNATED IN THE CITY OF GRAND JUNCTION, COLORADO.

That said General Municipal Election will be held at the several polling places in the several districts and voting precincts of the City of Grand Junction, in the State aforesaid, as follows:

District "A" - Polling Place - City Hall.

District "B" - Polling Place - U.S.O. Building

District "C" - Polling Place - Laycock Garage, 224 N. 7th St.

District "D" - Polling Place - R. Warren Garage - 8th & Main

District "E" - Polling Place - High School Gym.

Upon the date and at the places designated aforesaid, the polls will be open from the hour of 7 o'clock A.M. to and

including and will be closed at the hour of 7 o'clock P.M. The ballots to be used in voting will be prepared and furnished by the City Clerk to the Judges of the election, to be by them furnished to the voters. The election will be held and conducted as nearly as may be, in the case of elections for municipal officers. Registration for the said election will take place in the manner now provided by law.

That at said election there shall be and there is hereby submitted to a vote of such qualified electors of the City as shall in the year next preceding have paid a property tax therein, the following questions:

Question Submitted:

"Shall the City Council of the City of Grand Junction contract an indebtedness on behalf of the City and upon the credit thereof, by issuing negotiable coupon bonds of the City in an amount not exceeding \$35,000 for the purpose of paving and improving street intersections within the City of Grand Junction?"

Question Submitted:

"Shall the City Council of the City of Grand Junction contract an indebtedness on behalf of the City and upon the credit thereof, by issuing negotiable coupon bonds of the City in an amount not exceeding \$65,000, for the purpose of constructing improvements and betterments on the Municipal Airport, known as Walker Field?"

That at said election the following proposed ordinance will be submitted to the qualified electors of the City of Grand Junction for their adoption or rejection:

"An Ordinance Relating to the Development of the Municipal Airport Facilities in and for the City of Grand Junction, Colorado".

That at said election a member of the City Council will be elected from each of three election districts (i.e. Districts "A", "D", and "E") and one member from the City at Large for regular four-year terms.

It was moved by Councilman Harris and seconded by Councilman Campbell that the foregoing list of judges and clerks be appointed to serve on Tuesday, April 3rd. Motion carried.

There has been a request to make a public alley on a small strip of ground located south of 124 South First Street. The City of Grand Junction holds tax sale certificates Nos. 48977, 48985, 50757 and 50793 and Mesa County holds certificate No. 34139. Mr. Gormley has agreed to deed this property without cost to the City of Grand Junction for street and alley purposes. It is necessary as a public health measure so that garbage and ash trucks may serve the properties in this vicinity.

It was moved by Councilman Carson and seconded by Councilman Harris that the City Treasurer be authorized to cancel tax certificates No. 48977, 48985, 50757, and 50793, and that the County Commissioners be requested to cancel County Tax certificate No. 34139. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

It was reported that the sidewalk at 1421 North Seventh Street needs to be repaired. It was moved by Councilman Carson and seconded by Councilman Campbell that a notice be served on the owner of 1421 N. 7th requiring that the sidewalk be repaired in front of that property. Motion carried.

The Western Slope Auxiliary and Post #3981 V.F.W. gave a benefit card party for the Red Cross on Monday, March 19, 1945 at the Lincoln Park Auditorium and request that the auditorium be donated to them without cost for that night. It was moved by Councilman Carson and seconded by Councilman Harris that the request be granted and no charge be made for the auditorium for March 19. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

The Rettig Grocery known as Lincoln Park Food Mart applied for their 3.2 beer license to be renewed. It was moved by Councilman Campbell and seconded by Councilman Treece that the application be granted. Motion carried.

Applications for the use of Lincoln Park Auditorium for Saturday night dances were filed by Keith Buckley and by Kathryn Davis. Each application was to rent the hall for three months or more. It was moved by Councilman Carson and seconded by Councilman Treece that the request be denied. Motion carried.

City Manager Brownson, Councilmen Carson, Treece and President Hoisington made reports on their recent trip to Las Vegas, Boulder, City, Santa Fe and Albuquerque to visit the airports in these various cities.

It was moved by Councilman Campbell and seconded by Councilman Carson that the meeting adjourn. Motion carried.
