Grand Junction, Colorado

July 23, 1947

The City Council of the City of Grand Junction, Colorado, met in special session at 7:30 P.M. Councilmen present and answering at roll call were Harper, Hoisington, Martin and President Carson. Councilmen Bagby and Harris were absent. City Manager Fritz, City Clerk Tomlinson and Chief of the Department of Public Works and Planning Bennett were present, and City Attorney Banks was absent.

It was moved by Councilman Martin and seconded by Councilman Harper that the 24-hour notice of meeting be waived. Motion carried.

The Labor Mediation Committee reported that they had met in connection with the case of A. E. Dunlap who was removed from the employ of the City on July 11, 1947. They recommended, after hearing both sides of the case, that Mr. Dunlap be allowed to go back to work for the City on July 24, with seniority rights not impaired but with a two weeks suspension without pay. It was moved by Councilman Hoisington and seconded by Councilman Harper that the report of the Labor Mediation Committee be accepted and concurred in. Motion carried.

Mr. Bennett presented maps showing proposed changes of zoning throughout the City. A new spot zoning for small businesses now in existence or in places where a neighborhood grocery or something similar would be desired was suggested as Business "AR." These places are:
