Grand Junction, Colorado

January 21, 1948

On January 21st, the City Council of the City of Grand Junction, Colorado met in regular adjourned session at 11:00 o'clock A. M. Councilmen present and answering at roll call were Harper, Hoisington, Bagby, Colescott, Martin, Harris and President Carson. Also present were City Manager Fritz, City Attorney Banks and City Clerk Tomlinson.

An emergency ordinance entitled "AN ORDINANCE PROVIDING FOR THE ISSUANCE OF GRAND JUNCTION, COLORADO, WATER REVENUE BONDS IN THE PRINCIPAL AMOUNT OF \$395,000.00, FOR THE PAYMENT OF SAID BONDS AND THE INTEREST THEREON AND DECLARING AN EMERGENCY," was introduced and read. It was then moved by Councilman Hoisington and seconded by Councilman Harris that all rules of the Council which might prevent, unless suspended, the final passage and adoption of this ordinance at this meeting, be and the same are hereby suspended for the purpose of permitting the final passage and adoption of this ordinance at this meeting.

The question being upon the adoption of said motion and the suspension of the rules, the roll was called with the following results:

Those voting NAY: None

All members of the City Council having voted in favor of said motion, the presiding officer declared said motion carried and the rules suspended.

Councilman Bagby then moved that said ordinance be passed and adopted as read. Councilman Harper seconded the motion.

The question being upon the passage and adoption of said Ordinance, the roll was called with the following results:

Those voting AYE:

Councilmen: Porter Carson, John C. Harper, Frank A. Hoisington, M. M. Bagby, Harry O. Colescott, Al. G. Martin, Frank A. Harris

Those voting NAY: None.

The presiding officer thereupon declared that all members of the Council having voted in favor thereof, the said motion was carried and the said Ordinance dully passed and adopted.

On motion duly adopted, it was ordered that said Ordinance be numbered 763, and after approval by the President of the City Council, be published and recorded as required by the City Charter.

An application for a permit to construct a pre-cut garage on lots 10, 11, and 12, Block 5, which are the Hugh Pinger lots on 7th and North, and had been rejected by the Building Inspector because of the fact that no sanitary facilities were provided. This building is to be mounted on skids instead of a permanent foundation and used as an advertising display and a temporary part-time office. Sanitary facilities are available at the service station across the street. It was explained to the Council that these young men were selling these garages which were built entirely in accordance with the building code and are being cut at a local lumber yard. This office building at 7th and North would be removed at any time the City Council thought it necessary and advisable. It was moved by Councilman Bagby and seconded by Councilman Harper that permission be granted to James Brunton to establish a temporary building on 7th and North, to be used as part-time office headquarters for a period of six months or to be removed at any time the Council deems it advisable. Motion carried. It was moved by Councilman Bagby and seconded by Councilman Harper that the meeting adjourn. Motion carried.
