Grand Junction, Colorado

March 23, 1949

The City Council of the City of Grand Junction, Colorado, met in regular adjourned session at 7:30 o'clock P. M. Councilmen present and answering at roll call were Councilmen Carson, Hoisington, Bagby, Colescott, Martin, Harris and President Harper. Also present were City Manager Moore, City Attorney Banks and City Clerk Tomlinson.

The matter of the busses running on 16th Street was again brought up. There were a number of calls from residents of the neighborhood on 16th and Chipeta requesting that the busses continue operating on 16th St. The City had a survey made which showed that there were six property owners on 16th between Ouray and Chipeta who were very much opposed to having the busses and there were eleven in favor of the bus running on 16th. A survey of the whole neighborhood made by the Bus Company on March 21st shows the same six against the route, 27 in favor of it and 10 who did not care to express an opinion. In this survey it showed that there were approximately 470 riders per week. A delegation of property owners who were in favor of having the busses on 16th appeared before the council. Mr. Crosby, owner of the Grand Junction Rapid Transit Company, was also present and he stated that he was having a rough time trying to build up the Bus business in Grand Junction and that if he had to take the busses off 16th St., it would practically mean that he would have to move away from Grand Junction. The Council finally expressed themselves as being of the opinion that the streets of the city belong to all the people and that the busses should be allowed to operate wherever the manager deems it profitable. The City Manager was requested to help with the dust problem as soon as possible.

At a special meeting of the Zoning Board on March 9th the following changes were recommended to the City Council:

Lots in 1000 Block of Pitkin on north side of Street designated as Lots 27 and 28, Block 134, be changed from Residence C to Business B.

The South Side of North Avenue from 4th to 5th being the north one-half of Block 8 be changed from Residence B to Business A; Lot 3, Block 18 be changed from Residence A to Business AR. This lot is immediately adjacent to the property occupied by the Black and White Grocery and belong to the same owner. He desires to remodel and enlarge his store.

It was moved by Councilman Harris and seconded by Councilman Hoisington that the City Clerk be instructed to advertise these zoning changes and set April 6th as the date for the hearing. Motion carried.

C. D. Smith & Co. have made an offer for city-owned property adjacent to their warehouse property on South 7th St. It was moved by Councilman Carson and

seconded by Councilman Bagby that the City Clerk advertise that sealed bids will be accepted on this property to be opened at the April 6th meeting with the right to reject any and all bids. Motion carried.

Mr. Bart Evans appeared before the council in behalf of residents of the North Side of North Avenue between 8th and Cannell. Many years ago a sewer had been constructed on North Avenue and those houses hooked up. Then two years ago a sewer line was constructed in an alley which was dedicated by these same property owners to serve newly plotted ground to the north but the property facing North Avenue was again assessed. Mr. Bennet had gone into this matter verbally but the entire facts were not clear. These people feel that there is an injustice for them to be assessed for the sewer especially after donating ground for streets and alleys in the new addition. It was moved by Councilman Hoisington and seconded by Councilman Bagby that the matter be referred to the City Manager for a satisfactory solution. Motion carried.

It was moved by Councilman Harris and seconded by Councilman Hoisington that the following-named people be appointed as judges and clerks for the general election to be held April 5th.

Motion carried.

The City Manager was instructed to allow the schools to use their lawn taps this year as they are and that all new construction be required to be metered.

Mr. H. H. Hughs, dba Hughs Grocery, 964 North Avenue, made application to sell 3.2 Beer in his grocery store. It was moved by Councilman Harris and seconded by Councilman Bagby that this license be advertised for hearing April 20th. The City Market, East Side, H. L. Senter, and Rettigs applied for renewal of their 3.2 beer license. It was moved by Councilman Bagby and seconded by Councilman Colescott that the licenses be renewed. Motion carried.

It was moved by Councilman Colescott and seconded by Councilman Bagby that the following election notices be advertised in accordance with law:

to the City of Grand Junction for airport purposes;

AND WHEREAS, the said Bureau of Land Management has decided to make the said conveyance, subject to certain reservations, if the City will file an unconditional relinquishment of Airport Lease Denver 051958 and will pay such rentals as may be due under the said lease;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO: That the City does hereby unconditionally release and relinquish the Airport Lease Denver 051958, and it does hereby authorize and instruct its City Manager to pay to the District Land Office such rentals as may be due under the said lease and to further execute and deliver on behalf of the City, any

instrument necessary to unconditionally release all rights of the City under the above-mentioned lease.

It was moved by Councilman Carson and seconded by Councilman Martin that the meeting adjourn.
