Grand Junction, Colorado January 18, 1956

The City Council of the City of Grand Junction met in regular session at 7:30 P. M. Councilmen present and answering roll call were Orr, Harper, Colescott and Emerson. Councilmen absent, Shults, Lowe and Pres. Wright. Also present were City Manager Toyne, City Attorney Groves and City Clerk Tomlinson.

It was moved by Councilman Orr and seconded by Councilman Colescott that Councilman Harper act as President Pro Tem in the absence of President Wright. Motion carried and Councilman Harper took the chair and presided during the meeting.

It was moved by Councilman Emerson and seconded by Councilman Orr that the minutes of the regular meeting held January 4th be approved as written. Motion carried.

ORD. 945 - ZONING. The Proof of Publication to the proposed ordinance entitled AN ORDINANCE AMENDING CHAPTER 83 OF THE 1953 COMPILED ORDINANCES OF THE CITY OF GRAND JUNCTION, COLORADO, AND THE ZONING MAP INCORPORATED THEREIN was presented and read. It was moved by Councilman Colescott and seconded by Councilman Orr that the Proof of Publication be accepted and filed. Motion carried.

It was moved by Councilman Orr and seconded by Councilman Emerson that the proposed ordinance be called up for final passage. Motion carried. The Ordinance was then read and upon motion of Councilman Colescott and seconded by Councilman Emerson was passed, adopted, numbered 945 and ordered published. Roll was called on the motion with all members of the Council present voting "AYE." The President Pro Tem declared the motion carried.

ORD. 946 - VACATING STREETS ETC. The Proof of Publication to the proposed ordinance entitled AN ORDINANCE VACATING STREETS, ALLEYS AND EASEMENTS IN HOULTON'S SUBDIVISION AND HOULTON'S RE-SUB-DIVISION was introduced and read. It was moved by Councilman Orr and seconded by Councilman Colescott that the Proof of Publication be accepted and filed. Motion carried.

It was then moved by Councilman Colescott and seconded by Councilman Emerson that the ordinance be called up for final passage. Motion carried. The Ordinance was then read and upon motion of Councilman Emerson and seconded by Councilman Orr was passed, adopted, numbered 946 and ordered published. Roll was called on the motion with all members of the Council present voting "AYE." The President Pro Tem declared the motion carried.

REAPPOINT RECREATION COMMISSION MEMBERS. It was moved by Councilman Colescott and seconded by Councilman Orr that Richard Wells, H. B.

Manuel, T. S. Campbell, Dr. R. F. Gilmore and Mrs. Ila McCarrie be re-appointed to serve on the Recreation Commission for another two year term. Motion carried.

It was suggested that a letter be written to these Recreation Commission members expressing the appreciation of the Council in serving on the Recreation Commission and their willingness to be re-appointed to this board.

<u>CARNATION DAY MAY 12, 1956.</u> It was moved by Councilman Orr and seconded by Councilman Colescott that the American War Mothers be granted permission to sell carnations on the streets on May 12, 1956. Motion carried.

<u>WATER BILL ADJUSTMENTS.</u> The following requests for water bill adjustments due to service line breaks were requested. All were immediately repaired upon discovery.

COUNCILMAN LOWE ARRIVED AT THE MEETING AT THIS TIME.

REFER DR. HALL REQUEST TO CM. A letter from Dr. Robert F. Hall, 1645 West Sherwood Drive, was read in which he stated that on November 30, 1955 his basement was flooded due to the backing up of the sewer. He asked that the City pay the charges of the Clifton Electric and Supply Co. for cleaning this sewer. It was moved

by Councilman Orr and seconded by Councilman Lowe that this matter be referred to the City Manager for investigation and report back to the Council. Motion carried.

\$50 TO BOYS & GIRLS CITY COUNTY. It was moved by Councilman Colescott and seconded by Councilman Lowe that the City donate \$50 towards the Boys and Girls City and County day expenses for lunches. This has been done in the past. Roll was called on the motion with all members of the Council present voting "AYE." The President Pro Tem declared the motion carried.

TO GET BIDS FOR DITCH. City Manager Toyne reported that in the purchase of Hallenbeck Reservoir, it was understood and agreed that a by-pass ditch would be constructed to carry irrigation water from Juniata Reservoir around Hallenbeck Reservoir. This project should be completed before the spring run-off and it was moved by Councilman Orr and seconded by Councilman Emerson that the City Council authorize the City Engineer to advertise for bids on this project. Motion carried.

<u>PLANS FOR POLICE & JAIL BLDG.</u> City Manager Toyne presented proposed plans which he had drawn up for a police administration and jail building. This building was planned to be built at 6th and Colo. Ave.

It was moved by Councilman Orr and seconded by Councilman Lowe that the City Manager be authorized to proceed to secure estimates on the cost of the building as contemplated and to secure more complete plans. Motion carried.

DRUNKOMETER DEMONSTRATION. The City Attorney and Chief of Police reported that in trying to secure some means of determining the degree of intoxication of persons, the Chief of Police had investigated the possibilities of a Drunkometer. This machine will be demonstrated at 2 P. M. on February 7th and all Councilmen are invited to be present at this demonstration. There will also be a demonstration to the Medical Association on Tuesday evening on February 7th. The cost of the machine with all the charts and repair kit is approximately \$300 and it costs about thirty-five cents to make each test.

It was moved by Councilman Colescott and seconded by Councilman Lowe that the meeting adjourn. Motion carried.
