It was moved by Councilman Harper and seconded by Councilman Orr that the minutes of the regular meeting held December 19th be approved as written. Motion carried.

ORD. 990 APPROP. TO RECREATION. The Proof of Publication to the proposed ordinance entitled AN ORDINANCE APPROPRIATING UNBUDGETED RECEIPTS OF THE RECREATION DEPARTMENT OF THE CITY OF GRAND JUNCTION was introduced and read. It was moved by Councilman Colescott and seconded by Councilman Emerson that the Proof of Publication be accepted and filed. Motion carried.

It was then moved by Councilman Orr and seconded by Councilman Harper that the ordinance be called up for final passage. Motion carried. The Ordinance was then read and upon motion of Councilman Colescott and seconded by Councilman Orr was passed, adopted, numbered 990 and ordered published. Roll was called on the motion with all members of the Council present voting "AYE." The President Pro Tem declared the motion carried.

ORD. 991 ANNEX BLOCK 3 LINDA LANE. The Proof of Publication to the following proposed ordinance was presented and read: AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF GRAND JUNCTION. Roll was called on the motion with all members of the Council present voting "AYE." The President Pro Tem declared the motion carried.

COUNCILMAN LOWE ARRIVED AT THE MEETING.

FILE PETITION NO. 7TH ST. RESIDENTS. A petition signed by most of the property owners on North Seventh Street between Grand Ave. and Hill Ave. protesting the removing of the center parkings was presented. There was some discussion concerning the removal of the center parkings on 7th Street. Mr. Alstatt, City Engineer, and Mr. Johnson, Chief of Police, reported that at the present time a survey was being made to determine where the primary and secondary streets in the City would be located and when this is completed, it would be known whether or not 7th Street would be one of the major arteries and if it is, consideration would then be given as to removal of the center parkings. It was moved by Councilman Lowe and seconded by Councilman Orr that the petition be filed and reconsidered when all other data concerning removal of the center parkings on No. 7th was considered. Motion carried.

AT THIS TIME PRESIDENT LOWE assumed the duties of the President of the City Council and presided during the balance of the meeting.

<u>DISCUSS TEENAGE DELINQUENCY.</u> Mr. Rounds was present and asked the Council whether they intended to have any discussion or action concerning the teenage delinquency problem in the City. Considerable discussion was had by the Council concerning the advisability of appointing a committee to work on this problem. Some of the Councilmen being in favor of such a committee and others believing that it was not the Council's responsibility to take the lead in this problem. It was suggested that state legislation be proposed making parents equally responsible with the teenagers in any delinquency problem.

It was moved by Councilman Wright and seconded by Councilman Orr that President Lowe, at his discretion and at his earliest convenience, give serious thought to appointing a committee composed of Councilmen and service club members to work with school officials, police officials and others to see what can be done to work out this juvenile delinquency problem. Motion carried.

<u>SIDEWALK ON NORTH AVE.</u> Councilman Wright suggested that some sort of a sidewalk, possibly black top, be provided along North Ave. from 12th Street to the Indian Wash so that children do not have to walk along North Avenue. This matter was referred to the City Manager for study.

KREX TO TAPE RECORD COUNCIL MEETINGS. Councilman Orr stated that Station KREX would like to tape record meetings of the Council which would be edited and would provide a half hour program at the station.

It was moved by Councilman Shults and seconded by Councilman Orr that the meeting adjourn. Motion carried.
