## Grand Junction, Colorado September 4, 1957

**DREAM CAFE LIQUOR APPLICATION.** Mrs. Lucile Buchanan made application for a restaurant liquor license for the Dream Cafe at 118 Main Street. It was moved by Councilman Strnad and seconded by Councilman Harper that this application be advertised for hearing on October 2nd. Motion carried.

**FRUITVALE WATER & SANITATION DIST.** City Manager Cheever announced that the meeting set up by the Fruitvale Water and Sanitation District for the purpose of giving all the facts concerning annexation to the Fruitvale area residents would be at 7:30 P. M. on Tuesday, September 10th.
