Grand Junction, Colorado August 20, 1958

ROLL CALL.

The City Council of the City of Grand Junction met in regular session on August 20, 1958. Councilmen present and answering roll call were Emerson, Orr, Strnad, Wright and President Shults. Councilmen Harper and Colescott were absent. Also present were City Attorney Ashby and City Clerk Tomlinson. City Manager Cheever was absent.

MINUTES.

It was moved by Councilman Orr and seconded by Councilman Strnad that the minutes of the regular meeting held August 6th be approved as written. Motion carried.

IMPR. DIST. #55 Hearing - Bids for construction authorized.

This was the date set for hearing on Improvement District No. 55. In accordance with a new Supreme Court decision, notices had been sent to all property owners upon which assessments for improvements would be levied in connection with this district. There were no written remonstrances or protests filed against the district, but a number of people were in the audience protesting the improvement of certain streets and alleys.

Dr. and Mrs. Doerr, Mrs. Carl Potratz, Laura and Irma Weston, Pat Cochran, and others, were present and protested the paving of the alley between 6th and 7th and Walnut and Orchard. Several of these people had signed the petition asking for the improvement to be made but had changed their minds and now asked that their names be withdrawn from the petition; however, according to the ordinance which sets up the procedure to be followed in creating an improvement district, names cannot be withdrawn from the petition after the petition has been filed with the Council.

Mr. Chas. Schneider, who circulated the petition requesting the paving of the alley, stated that he had originally had 58.14% of the property owners fronting on the alley signed in favor of the paving.

The Council felt that as long as there was a difference of opinion and that possibly a majority of the people in the area did not wish to have the alley paved, a little further time should be given them in which to determine whether a majority would want the alley paved or not.

Mr. and Mrs. Barnes, 430 No. First Street, protested the widening of First Street between Ouray and Grand Avenues, stating that they had worked hard to get their parking and trees growing and hoped to keep this place as a home and were opposed to the widening of the street. It was explained to them that North First Street was a through traffic artery, and that it was very necessary that it be widened in order to take

care of the traffic, and that better than 64% of the property owners on the street had signed petitions for the widening and paving of the street.

Mr. L. L. French opposed the paving of the alley between Houston and College Place, back of the Campus Drug Store and the Episcopal Church. His assessment would be very small as his property is more than 100 feet from the edge of the alley.

Mr. V. R. Keplinger protested the paving of Glenwood Avenue between 15th and 16th. It was moved by Councilman Wright and seconded by Councilman Orr that the City Engineer be authorized to advertise for bids for Improvement District No. 55 as originally set up by resolution and to ask for an alternate bid eliminating the alley between Walnut and Orchard and 6th and 7th; these bids to be tabulated and presented to the Council at the next regular meeting. Roll was called on the motion with all members of the Council present voting "AYE." The President declared the motion carried.
