PEOPLE'S ORD. NO. 31 Publication of Receipts & Expenditures

It was moved by Councilman Orr and seconded by Councilman Wright that the following Resolution be passed and adopted as read:

R E S O L U T I O N

WHEREAS, from the returns of the general municipal election held in the City of Grand Junction, April 7th, 1959, as shown by the report of the canvassing board just filed, it appears that there were 1690 votes cast in favor of and 1521 votes cast against the ordinance entitled, "AN ORDINANCE REQUIRING PUBLICATION OF RECEIPTS AND EXPENDITURES OF THE CITY OF GRAND JUNCTION; REQUIRING THE PUBLICATION OF A SEMI-ANNUAL FINANCIAL STATEMENT OF SAID CITY; AND PROVIDING A PENALTY FOR VIOLATION THEREOF," making a majority in favor of the adoption of said ordinance of 169 votes.

THEREFORE BE IT RESOLVED, That the said Ordinance was passed and adopted at said election; and

BE IT FURTHER RESOLVED, That the said ordinance be passed and adopted as People's Ordinance No. 31, and that the Clerk be and is hereby ordered to publish said Ordinance in The Morning Sun, as passed and adopted.

Roll was called on the motion with all members of the Council voting "AYE." The President declared the motion carried.

City Clerk, City Treas & City Atty to determine exact amount to pub. It was moved by Councilman Emerson and seconded by Councilman Wright that in the absence of the City Manager that the City Clerk, City Treasurer and City Attorney make a study of People's Ordinance No. 31 and determine what is required and the exact expenditures which will be necessary as they interpret it and report back to the Council. Motion carried.

Councilman Emerson also moved that Councilmen Wright, Strnad, Colescott and Orr make a study of the City budget to determine where they will be able to find the necessary finances to pay the expenses for the publications required by the ordinance.

Councilman Strnad stated that he did not feel that they should make such a study until it is decided whether or not a ruling of the Court would be made as to the legality of the ordinance and just what is required.

Councilman Emerson then withdrew his motion. Councilman Wright suggested that the City Attorney be instructed to get a court ruling on the ordinance, and that all reports be made to the Council at the next meeting.

CONCESSIONS AT LINCOLN PARK

Dr. Otto, representing the Athletic Committee of the Chamber of Commerce, stated that the Pepsi Cola Company was buying trophies for the National Junior College Baseball Tournament to be held in Grand Junction in May and they would like to have permission to sell Pepsi Cola either through Mr. Fulton or have the concession themselves.

Councilman Wright suggested that the City Manager be requested to see if Mr. Fulton will cooperate with the Pepsi Cola Company in this matter. Councilman Strnad brought up the matter that no agreement has been signed, at the present time, with Mr. Fulton to give him an exclusive contract for the concessions at the park. It was then suggested that if Mr. Cheever was unable to take care of this matter that Councilman Wright talk to Mr. Fulton about it so that it could be settled and the trophies ordered.

Councilman Harper again suggested that the Recreation Department operate all of the concessions at Lincoln Park.

Councilman Emerson again suggested that the matter of the determination as to where the finances are coming from to publish the expenditures and receipts required by People's Ordinance No. 31 be made.

BOYS' & GIRLS' CITY COUNTY DAY City Mgr to prepare agenda for Apr. 15

The Council was reminded that April 14th and 15th would be Boys' and Girls' City County Day. Councilman Emerson asked to be relieved of the responsibility of preparing an agenda for that day and asked that the City Manager's office take over this responsibility.

It was moved by Councilman Orr and seconded by Councilman Strnad that the meeting adjourn. Motion carried.
