ROLL CALL

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 p.m., January 15, 1964. Councilmen present and answering roll call were R. B. Evans, Chas. H. Love, Harry O. Colescott, Warren D. Lowe, Herbert M. Wright and President C. E. McCormick. Councilman Ray A. Meacham was absent. Also present were City Manager J. M. Lacy, City Attorney Gerald J. Ashby and City Clerk Helen C. Tomlinson.

INVOCATION

The invocation was given by Bishop Floyd Larson, Church of Jesus Christ of Latter Day Saints.

MINUTES

It was moved by Councilman Lowe and seconded by Councilman Colescott that the minutes of the regular meeting held January 2, 1964 be approved as written. Motion carried. (6 AYES)

LEGAL ADVERTISING

Renew contract with Daily Sentinel for 1964

15¢ & 11¢ & 10¢ for monthly Receipts & Disbsmts (Instr 3992)

A contract was presented by Mr. Preston Walker, Publisher of the Daily Sentinel, for legal advertising for the year 1964. The contract calls for fifteen cents per line for the first insertion and eleven cents per line for subsequent insertions and ten cents per line for publishing the monthly report of Receipts and Disbursements. It was moved by Councilman Colescott and seconded by Councilman Love that the City Manager be instructed to sign this contract. Motion carried. (6 AYES)

L.P. AUDITORIUM

Deny req March of Dimes Auction for free use 1-24/25

A letter from Mr. Roger Head, Auction Chairman for the March of Dimes Auction, to be held at Lincoln Park Auditorium on January 24th and 25th was read. In this letter he requested that they be given the use of the auditorium without any cost. It was moved by Councilman Colescott and seconded by Councilman Lowe that the request be denied. Motion carried. (6 AYES)

The City Council has not for many years given any free use of the

auditorium. A cost basis is set up for organizations such as the one holding the auction for the benefit of the March of Dimes.

HEARING

3.2 Beer Violations

Suspend License Wieker Cigar Store to 3-23-64

This date was set for the hearing on violations of the 32 beer code by Wieker's Cigar Store. Messrs. Robert and George Wieker had been notified to appear before the Council regarding three violations. One had occurred on November 3rd when a 17-year old boy had purchased a case of beer from the bartender at Wieker's. Mr. Veatch, the bartender, was arrested and someone from the Wieker Cigar Store posted bond for him to appear in Judge Bakker's Court, but Mr. Veatch skipped out before his trial and forfeited the bond. Another violation took place on Dec. 23rd, when a keg of beer was sold to a 17-year old boy, and another occurred on Dec. 24th, when beer was sold to two other 17-year old boys.

Mr. Ashby, City Attorney, swore in the four boys (Larry Keith Evans, Clifton, Johnny Ross, Dale Hunt and Michael Knight) and Policemen Bob Daniels and Deon Harris and Police Sergeant J. T. Logue. The Policemen testified as to the violations and the boys substantiated the testimony by stating that they had purchased beer at Wieker's and had paid for the beer themselves. Mr. Robert Wieker appeared before the Council and also questioned the boys. The boys stated that they had used their drivers' licenses for identification with the correct birth dates showing that they were not 18 years old.

A memorandum was read from Chief of Police Karl Johnson to City Manager Lacy in which he set forth the details of the violations. A letter from Mr. Wieker to the City Council was read in which he explained his attempts at checking ages for teenagers who wish to purchase beer.

Councilman Wright stated that as it is a recognized fact when the license comes up for renewal, the Council has the power to deny it or set it ahead or treat it in any manner they should so choose, and because of the fact that a revocation would completely eliminate any possibility of the Wiekers' getting another license, and the Council might not wish to be this drastic, he would move that the license of Robert and George Wieker dba Wieker's Cigar Store be suspended for the duration of the current portion of their license (until March 23, 1964). The motion was seconded by Councilman Love. Motion carried. (6 AYES)

ADJOURNMENT

It was moved by Councilman Colescott and seconded by Councilman Lowe

that the meeting adjourn. Motion carried. (6 AYES)
