ROLL CALL

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 p.m., May 20, 1964. Councilmen present and answering roll call were Ray A. Meacham, R. B. Evans, Harry O. Colescott, Warren D. Lowe, Herbert M. Wright and Pres. McCormick. Councilman Chas. H. Love was absent. Also present were City Manager Joe Lacy, City Attorney Gerald J. Ashby and City Clerk Helen C. Tomlinson.

INVOCATION

The invocation was given by Rev. Richard W. Foster, Pastor, St. Matthew's Episcopal Church.

MINUTES

It was moved by Councilman Lowe and seconded by Councilman Evans that the minutes of the regular meeting held May 6, 1964 be approved as written. Motion carried. (6 AYES)

HEARING

Annexation McCary Tract (S of Bookcliff Ave & E of Med Arts)

This was the date set for hearing on the annexation of the following tract of land known as the McCary tract:

All of that part of the North Quarter of the Southwest Quarter of the Northeast Quarter of Section 11, Township 1 South, Range 1 West of the Ute Meridian, lying East of the center line of North Seventh Street, City of Grand Junction; except the West 450 feet of said tract, Mesa County, Colorado.

There were no written protests and no one in the audience who was opposed to the annexation of this property. The hearing was closed.

In accordance with the recommendation of City Engineer Hickman, it was moved by Councilman Lowe and seconded by Councilman Meacham that the contract for the re-construction of College Place from North Avenue to Elm Avenue be awarded to Elam Construction Company for the sum of \$22,476.79, and that the City Manager and City Clerk be authorized to sign the contracts.
