Grand Junction, Colorado

November 18, 1964

ROLL CALL

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 p.m., November 18, 1964. Councilmen present and answering roll call were Ray A. Meacham, R. B. Evans, Chas. H. Love, Harry O. Colescott, Warren D. Lowe, Herbert M. Wright and President Chas. E. McCormick. Also present were City Attorney Gerald J. Ashby and City Clerk Tomlinson. City Manager J. M. Lacy arrived at the meeting during the discussion on cable television.

INVOCATION

The invocation was given by Rev. Francis N. White, Pastor, First United Presbyterian Church.

MINUTES

It was moved by Councilman Lowe and seconded by Councilman Evans that the minutes of the regular meeting held November 4, 1964 be approved as written. Motion carried. (7 AYES)

AUDITOR FOR 1964

John McNulty apptd for 1 more year

Councilman Meacham reported that the committee appointed to select an auditor for auditing accounts of the City for 1964 would recommend that Mr. John McNulty be given the job for one more year. He moved that the report of the committee be accepted and that Mr. John McNulty be appointed to make the audit for 1964. Councilman Wright seconded the motion. Motion carried. (7 AYES)

LIBRARY

Regional Committee apptd

Councilman Love reported that his committee for the selection of a Regional Library Planning Committee wished to present the following names: Mrs. Robt. McKelvey, Collbran, Mrs. Marjorie Stout, Fruita, Miles Kara, Chas. Lumley and Max Krey of Grand Junction. President McCormick congratulated the committee on having secured this committee to serve as a Regional Library Planning Committee.

CABLE TV

Appl Wentronics Inc for franchise

Cable TV Company of Colorado presented a letter to the Council stating that they were ready to make a service rate structure into a form of contract as a condition to receiving a franchise to build and operate a cable television system. Many people had asked the question of "how do we know whether the price of the service would not be raised to an unreasonable amount?"

Mr. Wm. H. Nelson, Attorney, presented a proposed franchise ordinance granting a franchise to Wentronics, Inc. for cable television and requesting that the Council set a date for an election on this matter. A check in the amount of \$2,000 accompanied the application.

Mr. Andrew Williams, Attorney for a partner in the Western Slope Electronics System, Inc., suggested that all of the applicants for cable television franchises be required to post a performance bond or put up a cash deposit guaranteeing

to the people that if a franchise was voted upon favorably, the firm would proceed immediately with the construction of a cable television system.

Mr. Nelson stated unequivocally that so far as had been determined at this time, there was no connection between Western Slope Electronics System, Inc. and Wentronics, Inc.

City Attorney Ashby reported that according to the City Charter each application for a franchise or revocable permit must be voted on.

Prop. Ord. passed for publication

The following entitled proposed ordinance was presented and read: AN ORDINANCE GRANTING A FRANCHISE BY THE CITY OF GRAND JUNCTION TO WENTRONICS, INC., ITS SUCCESSORS AND ASSIGNS, AUTHORIZING SAID COMPANY TO LOCATE, BUILD, CONSTRUCT, ACQUIRE, PURCHASE, EXTEND, MAINTAIN AND OPERATE INTO, WITHIN AND THROUGH SAID CITY A PLANT OR PLANTS, SUBSTATIONS AND WORKS FOR THE GENERATION, TRANSPORTATION AND DISTRIBUTION OF ELECTRONIC SIGNALS AND TO DISTRIBUTE AND FURNISH SAID ELECTRONIC SIGNALS TO THE INHABITANTS OF THE CITY OF GRAND JUNCTION BY MEANS OF CONDUITS, CABLES AND WIRES STRUNG ON POLES OR OTHERWISE OVER, UNDER, ALONG, ACROSS AND THROUGH CERTAIN STREETS, ALLEYS AND OTHER PUBLIC WAYS AND PLACES IN THE CITY OF GRAND JUNCTION AND FIXING THE TERMS AND CONDITIONS THEREOF.

Election date Feb. 2, 1965

It was moved by Councilman Wright and seconded by Councilman Meacham that the proposed ordinance be passed for publication and that the City Council set Tuesday, February 2, 1965, as the date for a special election to be held for the purpose of voting on granting a franchise for cable television to Wentronics, Inc. Motion carried. (7 AYES)

CABLE TV

Appl Home Owned Cable TV, Inc. for Rev. Permit

Home Owned Cable TV, Inc. presented an application for a revocable permit for the purpose of installing a cable television system and requesting that an election be called to submit the permit for approval of the populace. The only difference in the terms of the revocable permit and the franchises was the subscription rate of 5.90 per month and the amount of the fee that would be paid to the City which would be 2.1/2% of the monthly subscription revenue, and the fact they would issue up to 50% of the stock to be sold to the people of Mesa County.

City Attorney Ashby stated that the difference in the elections would be that on the question of granting franchises, only qualified taxpaying electors are allowed to vote and on a revocable permit election all qualified electors are privileged to vote. Mr. Frank Hockensmith, Attorney, represented Home Owned Cable TV, Inc.

Mr. Bruce Dixon, who operates the Dixon, Inc., an electronic firm in Grand Junction, explained to the Council how Home Owned Cable TV, Inc. proposed to operate stating that they would get qualified engineers and builders to put in the system. He stated that he himself was an engineer and has worked in electronics for many years. Other members of the corporation of Home Owned Cable TV, Inc. are all Grand Junction professional men.

It was moved by Councilman Love that an election be set on February 3, 1965 for Home Owned Cable TV, Inc. revocable permit to be voted on. Councilman Evans seconded the motion. The Council assured Mr. Hockensmith that if a favorable vote was cast on the revocable permit, the Council would issue the permit. Roll was called on the motion with the following result: Councilmen voting AYE: R. B. Evans, Chas. Love, and President McCormick; Councilmen voting NAY: Ray Meacham, Harry Colescott, Warren Lowe and Herbert M. Wright. A majority of Councilmen voting NAY, the motion was declared lost.

It was moved by Councilman Wright and seconded by Councilman Meacham that the election for granting a revocable permit for Home Owned Cable TV,Inc. be set for Feb. 9, 1965. Motion carried with Councilmen Evans and Love voting NAY.

It was moved by Councilman Wright and seconded by Councilman Meacham that if there are any more applications for cable television, elections will not be scheduled until after the General Municipal Election on April 6, 1965. Motion carried. (7 AYES)

LIQUOR HEARINGS

12-16-64 State Liquor Store & Mark's

Hearings have been scheduled for December 16, 1964 for two existing liquor licensees which are to be issued under corporate structure. They are for Mark's "Finer Dining," Mark M. & Antonia V. Wagner, 105 N. 2nd St. and for State Liquor Store, Richard L. Stranger, 659 Rood Ave.

RENEWAL OF 1965 LIQUOR LICENSES

Consideration was then given to the renewal of 1965 liquor licenses:

The following report from Chief of Police Karl Johnson and a report from the Mesa County Health Department on the condition of premises and operation of the establishments holding liquor licenses were presented:

Dear Sir:

Below is a summary of incidents which have come to the attention of the Police Department during the past year concerning the operations of hotels and restaurants which are licensed to sell liquor for consumption on the premises. This information is furnished as an aid to the City Council in its consideration for renewal of licenses for 1965.

Bamboo Restaurant

215 No. 5th

On July 22, 1964 a fight was reported by the bartender. When the officers arrived, the fighters had left; the bartender declined to sign a complaint or to reveal the names of those who had been fighting.

JENSEN'S FLAMINGO

201 Colo. Ave.

February 9, 1964 a Police Office observed an unknown person entering the lounge at approximately 3:30 AM. He suspected a burglary might be in progress and stopped to investigate. He found the door locked; and after experiencing considerable delay in gaining entry, he found approximately eight men and women congregated inside. Richard Jensen, a son of the licensee, advised the officer that these people were members of the band and that they were practicing. The licensee was warned of this matter by Mr. Niven of the State Liquor Department on February 13, and on the same date a

letter was mailed by me to the licensee advising that the situation could not be tolerated. I subsequently received assurance from the licensee that it would not be repeated.

On February 22, 1964, Mrs. Hazel Jensen reported a disturbance. When the officers arrived, the responsible parties had left.

On March 11, 1964, Mrs. Hazel Jensen reported a disturbance. Again, when officers arrived, the disturbance was over; no complaints were signed.

On March 28, 1964, a disturbance was reported by Mrs. Hazel Jensen. When officers arrived, offending parties had departed.

On June 12, 1964, a fight outside the premises was reported by the Merchant Police; two subjects were taken into custody on a charge of disturbance and were found guilty.

On July 13, 1964, Mrs. Jensen reported that a man was beating his wife. When the officers arrived, they requested both the wife and Mrs. Jensen to sign complaints. Both declined; no further action was taken.

La Court Tavern

2nd & Main

Oct. 2, 1964, the bartender reported a fight. Officers arrived, but the bartender declined to sign any complaint. The offending party was warned of the consequences of such action.

Beacon Lounge

609 Main St.

January 15, 1964, a cab driver reported that he had been challenged by a drunk in the bar. The bartender was warned about not reporting such incidents and against serving intoxicated persons.

On June 9, 1964, a fight was reported by the bartender. When officers arrived, the offending parties were gone, but were subsequently located. The bartender declined to file any complaint.

RoVey's Cafe

122 S 5th

January 16, 1964, an officer observed two subjects fighting in the street in front of this address. The subjects were arrested and convicted of disturbance.

January 22, 1964, a disturbance was reported by Mr. Ritter; he signed a complaint with one arrest and one conviction.

May 16, 1964, a disturbance was reported by Mr. Ritter who signed a complaint with one arrest.

June 10, 1964, disturbance was reported by Mr. Ritter. He signed a complaint; one arrest and a conviction.

August 24, 1964, a fight was reported in an alley adjacent to this address. Two persons arrested and convicted.

August 28, 1964, it was reported that a man and women were seen committing an immoral act in the alley. No action was taken inasmuch as this report was made the day after the alleged act was supposed to have been committed.

St. Regis Lounge

359 Colorado

June 23, 1964, complaint of loud music; management advised and the amplifier was turned down.

June 24, 1964, a second complaint of loud music; again, the management was advised and the amplifier was turned down.

On October 16, 1964, Detective Robert Johnson accompanied State Liquor Inspector Robert Pond on an inspection tour to determine if requirements of food service and light standards were being met. Except for improvement of lighting standards, all were found to be in compliance with the exception of the St. Regis which on that date had no supply of food or material with which to prepare a meal or serve other food as required under the Liquor Code.

A complaint was filed and the licensee was brought into Justice of the Peace Court; and after hearing testimony from several witnesses that food was normally kept on hand, the Court rendered a verdict of "Not Guilty."

During the first week of November, Captain Abbey accompanied an inspector from the Health Department in making an inspection of all hotel and restaurant licensees. Conditions were generally found to be satisfactory, except at RoVey's Cafe and Lounge where several sub-standard conditions were noted, and the management was given until November 18th to make the necessary corrections.

Generally speaking, it is my opinion that the bars in Grand Junction are being operated in a satisfactory manner and in full compliance with the laws and regulations. Whenever laxness is observed, management is immediately advised, and in almost all instances corrections have been made. With very few exceptions, the Police Department has enjoyed excellent cooperation with all of the licensees and their employees.

The fact that quite a number of incidents are reported from specific locations, in most instances is an indication that the proprietors and licensees are cooperating in reporting these in accordance with the regulation.

NOTE:

I am aware of the increasing objections being raised concerning the operation of RoVey's Cafe, 122 South Fifth Street. The following comments are offered as my personal opinion concerning the conditions which have led to these objections.

The most frequent complaints that have come to my attention have related to profanity and indecent acts being committed by patrons of RoVey's in the alley between Fifth and Sixth Street, South of Main. From long observation it has been my opinion that these conditions are largely, if not wholly, the result of completely inadequate facilities; particularly rest room facilities in the cafe. The present rest rooms are so small, that they will accommodate only one person at a time. This has caused patrons of the bar to go into the alley, instead of the rest room.

Secondly, patrons are permitted to exit into the alley by going through the kitchen. I have raised the question to previous inspectors of the Health Department as to the desirability of allowing this, and have been advised there is nothing that they can do to overcome it.

Finally, many objectors stated that they feel that the greatest problem is that this business is improperly located. And, if it were located in some other area of the City, it would probably not be objectionable.

Dear Mr. Lacy:

A reinspection of Ro-Vey's Cafe and Lounge located at 122 South 5th was made November 18, 1964 to determine compliance of sanitation violations noted on the inspection of November 2, 1964.

Items noted have been corrected with the following exceptions:

The walls of the establishment have been cleaned and painted, except for the east wall in the front dining room, which had not been completed at the time of inspection.

Bar floors are still noted to be dirty.

Areas where the linoleum is worn as yet have not been repaired.

General housekeeping items noted during the reinspection requiring correction are as follows:

- 1. The light fixtures need cleaning in the front dining area and in the kitchen.
- 2. Shelves in the storage room need to be cleaned as do the ones in the front dining room.
- 3. The meat block needs cleaning.

We approve the establishment with reservation provided the items noted on the reinspection are corrected. A time limit of two weeks is being allowed to correct the above mentioned items.

It was moved by Councilman Lowe and seconded by Councilman Colescott that the application of La Court Hotel Co., Inc., dba LaCourt Hotel & Motor Lodge, 103 S. 2nd Street, be approved and license granted when state license has been received. Motion carried. (7 AYES)

It was moved by Councilman Colescott and seconded by Councilman Wright that the application of Katherine Blackshear dba St. Regis Lounge, 4th & Colo., be approved and license granted when state license has been received. Motion carried. (7 AYES)

ROVEY'S

There was a large delegation of people who work in the downtown area present to protest the granting of renewal of a liquor license to Rovey's Cafe & Lounge, 122 So. 5th. Attorney Jas. Golden was present representing the Ritter Brothers who hold a hotel and restaurant liquor license for Rovey's Cafe & Lounge. Signed petitions were presented protesting the granting of a renewal of the license and in favor of granting the renewal. Messrs. Leland Schmidt, Don Vogel, Mgr. of Montgomery Ward, & Harold Richardson told of the immoral and disorderly conduct which took place and the unsanitary conditions of the alley at the back of Rovey's.

Mr. Schmidt stated that he did not think it is the kind of establishment that should be allowed to be operated in the

downtown shopping park. The merchants in this area have spent a lot of money to make the area attractive and to bring to Grand Junction the All American City status and they were objecting to the "Larimer Street operation." The clerks in the Montgomery Ward store protested against conditions existing in the alley between the store and the warehouse and stated that they were actually afraid to cross the alley at night. There are to be 22 night openings for the stores from now until Christmas. Many women shoppers will be parking in the two parking lots on either side of Rovey's. The parking lots have been purchased at great expense by the Downtown Parking Corporation for the downtown shoppers' convenience.

It was moved by Councilman Wright and seconded by Councilman Meacham that consideration of the application for renewal of restaurant liquor license for Jess J. Ritter and Jack D. Ritter dba Rovey's Cafe & Lounge, 122 So. 5th Street, be tabled until the next meeting of the Council in order that all angles of the matter can be given full investigation. Motion carried. (7 AYES)

To consider further Dec. 18, 1964

Attorney Golden stated that he had a jury trial on Dec. 2nd and it would be very inconvenient to appear before the Council that evening. It was moved by Councilman Wright and seconded by Councilman Meacham that the motion be amended to bring up the matter of renewal of the application for liquor license for Rovey's Cafe & Lounge on Dec. 16th. Motion carried. (7 AYES)

It was moved by Councilman Colescott and seconded by Councilman Lowe that the following applications for renewal of liquor licenses for the year 1965 be approved and licenses granted when state licenses have been received. Motion carried. (7 AYES)

1965 BUDGET APPROVED

This was the date set for hearing on the proposed 1965 Budget. All of the audience had left excepting the reporters. No one was present to make any objections or ask any questions concerning the Budget.

City Manager Lacy stated that the Budget reflects a \$500,000 increase over the 1964 budget. Personal Services shows a 5.4% increase which includes the regular increment increase for most employees of 4%; material and supplies represents a 2.3% decrease; the balance is for capital improvements and under the present method of budgeting, capital account accruals must be budgeted in order to put a lid on the mill levy until 1970. President McCormick closed the hearing.
