### **ROLL CALL**

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 p.m., December 16, 1964. Councilmen present and answering roll call were Ray A. Meacham, R. B. Evans, Chas. Love, Harry Colescott, Herbert M. Wright and President C. E. McCormick. Councilman Lowe arrived at the meeting during the discussion on Rovey's liquor license. Also present were City Manager Lacy, City Attorney Ashby and City Clerk Tomlinson.

# **INVOCATION**

The invocation was given by Mr. Jerald F. Chadwick, Counselor to the Bishopric, First Ward, LDS Church.

### **MINUTES**

It was moved by Councilman Evans and seconded by Councilman Meacham that the minutes of the regular meeting held December 2, 1964 be approved as written. Motion carried. (6 AYES)

#### HEARING

Liquor licenses

"Mark's Finer Dining, Inc. & State Liquors Inc.

Hearings had been scheduled and advertised on the application of Mark M. Wagner, Antonia V. Wagner and L. C. Kopanos dba Mark's "Finer Dining" Inc. at 105 No. 2nd Street and for State Liquors, Inc. Richard Stranger, Manager, at 659 Rood Ave. No protests were filed against either of these applicants. President McCormick closed the hearing. It was moved by Councilman Colescott and seconded by Councilman Evans that the applications for liquor licenses for Mark's Finer Dining, Inc. and State Liquors, Inc. be approved and licenses granted when State licenses are received. Motion carried. (6 AYES)

## **HEARING**

3.2 Beer License for Ted Kubena dba Shakey's Pizza Parlor, 827 North Ave.

### Granted

Hearing had been scheduled and advertised for this date on the application of Ted Kubena dba Shakey's Pizza Parlor, 827 North Ave. No protests had been filed and there was no one present protesting the granting of this license. President McCormick closed the hearing. It was moved by Councilman Meacham and seconded by Councilman Wright that the application be approved and license granted when State license is received. Motion carried. (6 AYES)

### **HEARING**

Zoning changes-E/W 8th N Belford

W si 1st bet Mesa/Independent

Hearing were held as schedule and advertised for the following changes in zoning:

- 1. East and West of 8th Street, North of Belford, from R-2 (2 family) to C-1 (light commercial). No one present protested the change of this zoning so President McCormick closed the hearing.
- 2. SW corner Lorey Drive and 1st Street, from R-1-C (single family) to P (Parking) and B-2 (neighborhood business).
- 3. West side 1st Street between Mesa and Independent Ave. from R-1-C (single family) to R-3 (multi-family). Mr. Warren Reams, Attorney, was present requesting the change of zoning in this area. There being no opposition to either of these changes in zoning, President McCormick closed the hearing.

### LIQUOR LICENSE

Roveys Cafe & Lounge, 122 S 5th

Granted - renewal

The matter of issuing a renewal of hotel & restaurant liquor license to Jess J. Ritter and Jack D. Ritter dba Rovey's Cafe & Lounge, 122 So. 5th St., had been tabled until this meeting. A report from the Mesa County Health Department was read which stated that the management of Rovey's Cafe & Lounge had complied with all matters insofar as sanitation was concerned. City Attorney Ashby reported to the Council that the petitions which had been filed by a group of downtown people were not sufficient for the Council to refuse to re-issue a liquor license for this premises. Possibly this matter could be approached from a private or public nuisance standpoint wherein the public nuisance would be abated by the City or the private nuisance could be abated by the citizens if they want to take it to Court. The City Council cannot refuse to renew a license if there has been no violation of the liquor code. He stated that Mr. Golden, Attorney, for the Ritters, and he would be glad to work on the nuisance angle if it was felt wise to approach it in this way. He also stated that it was difficult to determine whether the nuisance was caused by the operation of Rovey's Cafe or whether it was caused from a problem of people circulating around, and the question would come up as to what responsibility an operator has after a patron leaves his premises. He stated he would be glad to look further into the nuisance angle and report back at the next meeting of the Council if they so desired.

It was moved by Councilman Love and seconded by Councilman Meacham that the application for a hotel & restaurant liquor license for Jess J. Ritter and Jack D. Ritter dba Rovey's Cafe & Lounge, 122 So. 5th Street, be approved and license be issued when State license has been received. Motion carried. (7 AYES)

Councilman Colescott stated that it might be well for the Police Department to keep a close observation on this establishment and the operators should report any difficulties to the Police Dept. immediately.

# MUN. JUDGE

Accept Resignation Wm. E. Foster

Apptd Ed Ruland 12-17-64

A letter of resignation from Wm. E. Foster as Judge of the Municipal Court effective December 31, 1964 was read, and the resignation accepted. Councilman Meacham reported for the Committee appointed to select a Judge and stated that they had interviewed several applicants and would like to present the name of Ed Ruland, a member of the firm of Groves, Dufford and Nelson.

It was moved by Councilman Colescott and seconded by Councilman Evans that Mr. Ed Ruland be appointed as Judge of the Municipal Court effective December 17, 1964. Motion carried. (7 AYES) Mr. Foster is now on vacation.

Councilman Meacham stated that the Committee would still like to function for a period of time to try to establish a liaison between the Council and the Judge's office in working out a smooth operation. Councilman Colescott suggested that possibly the Judge should be sworn in to make it more formal.

# LIBRARY BOARD

Fred C. Hottes apptd mbr of Board for 5 yrs

President McCormick reported that Fred C. Hottes had consented to remain on the Library Board, and he was very happy to re-appoint him with concurrence of the Council for a term of five years.

### PROP. ORD.

Licensing of Peddlers, Solicitors & Transient Merchants

### Discussed

Discussion was then had on a proposed ordinance entitled: AN ORDINANCE RELATING TO THE LICENSING OF PEDDLERS, SOLICITORS AND TRANSIENT MERCHANTS AND PROVIDING PENALTIES FOR VIOLATION THEREOF. There was a large crowd present and many were opposed to the passage of the ordinance. A large number of them were life insurance salesmen or door to door salespeople who had never abided by the so-called "Green River" ordinance.

City Attorney Ashby stated that a good many people thought that the "Green River" ordinance applied only to non-residents of the City. Apparently from the number of people who have called in about the proposed ordinance there have been many violations of the "Green River" ordinance and the City treasury could be far richer if the ordinance had been enforced.

Recently a Supreme Court ruling has declared any "Green River" ordinance illegal unless enforced without discrimination so everyone who sells door to door whether living in Grand Junction or not would be affected by the "Green River" ordinance. The proposed ordinance had been drawn up to license door to door salespeople so that they could carry on in an effective manner. It was the Council's intention to repeal the "Green River" ordinance and that this proposed ordinance would take its place.

Many people spoke against the passage of the proposed ordinance. President McCormick and City Attorney Ashby finally came up with proposal that the proposed ordinance should not be passed and the "Green River" ordinance should be repealed and a simple ordinance providing that it would be illegal for any salesman to enter a premises where a "No Peddlers" or "No Solicitors" sign was exhibited. It was suggested that a committee work with Mr. Ashby for the purpose of drawing up either an ordinance regulating and licensing door to door salespeople and a "no soliciting" ordinance such as the one suggested above.

# PROP. ORD.

Mobile Homes & Trailer Courts

To study

A proposed ordinance regulating mobile homes and trailer courts was given to the Council for their study. City Manager Lacy stated that we are now operating under an ordinance passed back in Sept. 5, 1951 which was designed to take care of the original concept of trailer homes rather than the mobile homes of today. The license fee is \$5.00 per trailer with a minimum of \$50. The new ordinance calls for a license fee of \$5.00 or \$10.00 depending on the number of spaces. Other details are much more in keeping with modern practices. The Planning Commission has pretty well approved this proposed ordinance and it will be considered at the next meeting of the Council.

# **WATER**

Report of Engrs on improvement of Filter Plant & Reservoir covers-Cost \$1,845,900

City Manager Lacy reported that Henningson, Durham and Richardson, Engineers, had prepared the proposed plans for development of the long-range water improvement for filter plants and reservoirs. They proposed to remodel the existing plant and to construct a new plant which will treat eight million gallons of water per day and which can be expanded in the future to treat twenty-four million gallons of water per day and also to cover the present reservoirs which the Mesa County Health Department would like to have done as soon as possible. This proposal is based on the impact that the Ute Water System will have when it is put into full operation. The entire construction cost for the project is as follows:

Construction of 8 m.g.d. new plant	\$1,122,000.
Remodel old plant	162,900.
Concrete covers for present reservoirs	<u>561,000.</u>
Total Cost	\$1,845,900.

The time schedule for the proposed project would be up to the Council but the recommendation was for it to be done prior to 1970. The time schedule also would depend on financing. If done soon, it would be necessary to pass a bond issue and if it is carefully staged, it would not take as many bonds. Some money could be saved each year to apply on the improvement. This report was given to the Council for study.

# UNITED PALSY OF COLO

Granted permission to conduct fund-raising campaign

A letter from the United Cerebral Palsy Association of Colorado was read which requested permission to conduct fund raising events in Grand Junction during the month of January, 1965, and to especially conduct a house to house campaign on Jan. 18, 1965.
