Colescott, Warren Lowe, Herbert M. Wright and President McCormick. Councilman Ray A. Meacham, Charles H. Love and R. B. Evans were absent. Also present were City Manager J. M. Lacy, City Attorney Ashby and City Clerk Tomlinson.

INVOCATION

The invocation was given by Rev. J. Frederick Speer, Assistant Pastor, First United Presbyterian Church.

MINUTES

It was moved by Councilman Lowe and seconded by Councilmen Colescott that the minutes of the regular meeting held January 6, 1965 be approved as written. Motion carried. (4 AYES)

3.2 BEER HEARING - LAWRENCE J. LOGUE DBA PIZZA HUT, 1230 N. 12TH STREET - GRANTED

City Manager Lacy stated that at the last meeting of the P.I.A.B., the revised charter was approved, but since the minutes of the meeting had not been received by members of the

Council, it might be better to hold this matter over until the next meeting of the Council.

PROPOSED ORDINANCE REGULATING PEDDLERS & SOLICITORS - REPEALING GREENRIVER ORDINANCE - PASSED FOR PUBLICATION

The Proof of Publication to the following entitled proposed ordinance was presented and read: AN ORDINANCE REPEALING CHAPTER 69 or THE 1953 COMPILED ORDINANCES OF THE CITY OF GRAND JUNCTION, THE PEDDLERS, SOLICITORS AND ITINERANT MERCHANTS CHAPTER OF SAID ORDINANCES. It was moved by Councilman Wright and seconded by Councilman Lowe that the Proof of Publication be accepted and filed. Motion carried. (4 AYES)

Councilman Colescott suggested that it might be well to wait awhile before calling this ordinance up for final passage as if it was passed the people would have no protection and it might be possible they might want some other ordinance.

President McCormick stated that he had received two letters; one from the G.J. Board of Realtors and one from the Western Colorado Association of Life Underwriters. After holding meetings with all of their members, it had been agreed that some ordinance governing sales people in Grand Junction would be desirable. The Western Colorado Association of Life Underwriters also suggested that a Better Business Bureau be developed with a central source of information. The Downtown Retail Trade Committee of the Chamber of Commerce asked the Council to delay final passage of the-so-called peddlers' ordinance so they could make more of a study of it and they offered-to work with the Council and City Attorney in devising an ordinance that would be acceptable to the greatest number of peoples.

There were several housewives in the audience who asked the Council to pass an ordinance against unlimited soliciting from door to door.

It was moved by Councilman Wright and seconded by Councilman Lowe that the proposed ordinance be called up for final passage. Call for the vote on the motion showed no Councilmen voting AYE and four Councilman voting NAY. All of the Councilmen present having voted NAY, the motion was declared lost.

City Attorney Ashby then read the following entitled proposed ordinance AN ORDINANCE REGULATING PEDDLERS AND SOLICITORS, AND PROVIDING PENALTIES FOR VIOLATION THEREOF. It was moved by Councilman Lowe and seconded by Councilman Colescott that the proposed ordinance be passed for publication Motion carried. (4 AYES)

EAGLES BASEBALL CANCEL \$2,497.67 OWED CITY

City Manager Lacy reported that the Eagles Semi-Professional Baseball Team has owed the City a balance of \$2,497.67 since 1960 and it has been accruing interest since that time at the rate of 6% in accordance with action taken by the City Council at that time. Mr. Lacy reviewed the history of the Eagle's baseball program up to 1960 stating that the Council would be asked every year to waive the fees as the Baseball Committee did not make enough money to pay all of the expenses. In

February, 1960, the slate was once again wiped clean. In September, 1960, when the Committee Chairman appeared before the Council, it was agreed that the Council would place a \$1,000 credit in the 1961 budget to help the Eagles get on a paying basis. Interest was to be charged at 6%. A plan of a ten cent per admission field fee was established in 1961 and

since that time, this portion of the fees has been taken care of promptly. No interest has been paid since 1961. At this time, there is owing in interest and fees the sum of \$593.15 plus the original balance of \$2,497.67.

Mr. Lacy suggested that the Eagles pay the sum of \$593.15 and the City would cancel the balance. In 1964, they paid the ten cent field fee plus an additional ten cents field fee for lights which took care of the 1964 costs.

It was moved by Councilman Wright that the City waive or credit the Eagles account with \$2,497.67 if they pay the balance due of \$593.15. The motion was seconded by Councilman Colescott. Roll was called on the motion with all Councilmen present voting AYE. The President declared the motion carried. (4 AYES)

SALES TAX ADM - REPORT ON 1964 COLLECTIONS

City Manager Lacy reported that the sales tax collected through November, 1964 was \$153,061.37. He gave the following break down by areas: 26.70% from Zone I, (Shopping Park); 33.55% from Zone II (Central Shopping Area); 10.66% from Zone III (Teller Arms District); 13.48% Zone IV (North Ave.) and 15.61% from Zone V (Other areas). He also gave the break-down of collections from the various types of retail stores. He stated they were very pleased to say this is right on our estimate of revenue as projected from the financial study. However from the actual administration of the new tax since August 1st has brought to light the need for some changes in the ordinance to clarify certain provisions and make collection more practical. The changes suggested are as follows:

- 1. Section 2-18 (1). Should be modified to exclude leases or contracts which are predominately service (such as towel and uniform rentals where laundry service is the principal portion of the charge.)
- 2. Section 11-6. Should be expanded to include mining, manufacturing, processing, and irrigation firms as well as railroad and construction firms which may pick up materials for outside City use, tax free. This expansion should include an identification method whereby the merchants can be assured that they are acting correctly when making tax-free sales, possibly an identification card system.
- 3. Section 20-1 (1) and 13-1 (1). The tax schedule should be changed from the present starting point of 19 cents to 44 cents as the point at which the one cent City tax should be added. This is the basic starting point used by all other Colorado cities which do not use the 19 cents point. We have found that the large majority of the businesses have selected the alternate of paying the City one-half of what they have collected for state tax.

Therefore, there would be no significant drop in revenue although the customer would feel the benefit of this change when making small purchases.

4. Section 21-3. Should be amended to provide authority to extend the time for filing use tax returns to a longer time, probably yearly in some cases. The amounts collected from this source are small and in many cases the requirement of filing of returns simply puts an additional burden on certain types of businesses.

Councilman Wright stated that he thought it would be in order to go ahead and draw up the suggested changes.

PEDDLERS ORDINANCE

Councilman Wright stated that he would like to go back to the matter of the so-called peddlers or solicitors ordinance. He felt it was incumbent upon the Council to pass the best ordinance that serves the best interest of the bulk or majority of the people. He felt that such an ordinance should not penalize local merchants or legitimate sales people in order to catch a small percentage of fly-by-night salesmen.

Councilman Colescott felt that there might not be a splurge of buying "no solicitor" signs for awhile and President McCormick said this might turn out to be a "stop gap" measure and it may be that a Better Business Bureau may be organized if this is not adequate as he felt that the Council has not heard from all of the people.

ADJOURNMENT

It was moved by Councilman Lowe and seconded by Councilman Wright that the meeting adjourn. Motion carried. (4 AYES)
