ROLL CALL

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P.M. May 18, 1966 in the Civic Auditorium at City Hall. Councilmen present and answering roll call were Chas. E. McCormick, R. B. Evans, Chas. H. Love, Harry O. Colescott, Dr. Hurst F. Otto, and President Ray A. Meacham. Councilman Wright arriving during the meeting. Also present were City Attorney Gerald J. Ashby and City Clerk Helen C. Tomlinson. City Manager J. M. Lacy was absent.

INVOCATION

The invocation was given by Rev. Morris L. Venden, Pastor, Seventh Day Adventist Church.

MINUTES

It was moved by Councilman McCormick and seconded by Councilman Love that the minutes of the regular meeting held May 4, 1966 be approved as written. Motion carried. (6 AYES)

HEARING

Annexation El Corona (S of Patterson & W of Mantey Hts)

This date had been scheduled and advertised for hearing on the proposed annexation of El Corona area which is south of Patterson Road and west of Mantey Heights. There were no protests from the audience and no written protests had been filed. The President declared the hearing closed.

DAYS

Forget-me-not June 23

A letter was read from the Disabled American Veterans requesting permission to sell forget-me-nots on the downtown streets on June 23rd. It was moved by Councilman Evans and seconded by Councilman Colescott that the request be granted. Motion carried. (6 AYES)

DAYS

Poppy Day May 28 VFW #1247 & #3981

The Veterans of Foreign Wars Post #1247 and Post #3981 requested permission to sell poppies on the downtown streets on May 28th. It was moved by Councilman Colescott and seconded by Councilman Otto that the requests be granted. Motion carried. (6 AYES)

3.2 BEER HEARING

Wayside Grocery Travis L. or Edith M. Park, 2851 North June 1, 1966

A hearing had been scheduled and advertised for hearing on June 1, 1966 on the application of Travis L. or Edith M. Park dba Wayside Grocery, 2851 North Ave., for a 3.2 beer grocery store license.

ANNEXATION

El Corona Resol Prop Ord

City Attorney Ashby stated that under the new Colorado annexation law of 1965, the procedures for annexation will have to be more formal. This is especially true if there is any opposition at all in the area to be annexed. It is required in the law that the Council find that one-sixth of the perimeter is contiguous; that a community interest exists between the territory and the City; that the territory is urban or will be urbanized in the near future and that the territory is integrated or capable of being integrated and that no election is required. It requires that a resolution be passed by the Council setting forth these findings and that a conclusion is reached. The following Resolution was presented and read:

RESOLUTION

WHEREAS, on May 18, 1966, a hearing was held before the City Council of the City of Grand Junction, Colorado, to determine the eligibility for annexation to said City of the following described territory, situate in Mesa County, Colorado, to-wit:

Beginning at the Southwest Corner of the Southeast Quarter of the Northeast Quarter of Section 12, Township 1 South, Range 1 West of the Ute Meridian, thence North to the Northwest Corner of the Northeast Quarter of the Northeast Quarter of said Section 12, thence East along the North line of said Northeast Quarter of the Northeast Quarter 495 feet, thence South to the North line of the Southeast Quarter of the Northeast Quarter of said Section 12, thence East along said North line 326 feet to a point of intersection with the West line of the KSL Subdivision as projected North, thence South to a point on the South line of said Southeast Quarter of the Northeast Quarter, thence West to the point of beginning,

and,

WHEREAS, the Council has found, and does hereby find, that one-sixth of the perimeter of the area proposed to be annexed is contiguous with the City; that a community of interest exists between said territory and the City; that the territory proposed to be annexed is urban or will be urbanized in the near future; that the said territory is integrated or is capable of being integrated with said City; and that no election is required under The Municipal Annexation Act of 1965.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That the said territory is eligible for annexation to the City of Grand Junction, Colorado, and should be so annexed by Ordinance.

PASSED AND ADOPTED this 18th day of May, 1966.

It was moved by Councilman McCormick and seconded by Councilman Evans that the Resolution be passed and adopted as read. Roll was called on the motion with all members of the Council present voting AYE. The President declared the motion carried. (6 AYES)

The following entitled proposed ordinance was presented and read: AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF GRAND JUNCTION. It was moved by Councilman Otto and seconded by Councilman Love that the proposed ordinance be passed for publication. Motion carried. (6)

ORD. 1229

Prohibit killing birds in cemeteries, parks, recreation areas

The Proof of Publication to the following entitled proposed ordinance was presented and read: AN ORDINANCE AMENDING CHAPTER 19 OF THE CODE OF ORDINANCES OF THE CITY OF GRAND JUNCTION, COLORADO, BY ADDING THERETO A SECTION 29, PROHIBITING THE KILLING OF BIRDS WITHIN THE CITY, ITS CEMETERIES AND CITY OWNED PARKS AND RECREATION AREAS. It was moved by Councilman Love and seconded by Councilman Evans that the Proof of Publication be accepted and filed. Motion carried. (6 AYES)

It was moved by Councilman Evans and seconded by Councilman Otto that the ordinance be called up for final passage. Motion carried. (6)

The ordinance was then read, and it was moved by Councilman McCormick and seconded by Councilman Otto that the Ordinance be passed and adopted as read, numbered 1229 and ordered published. Roll was called on the motion with all members of the Council present voting AYE. The President declared the motion carried. (6 AYES)

WARRANTS CANCELLED

Warrants #1233 and #1234 dated June 9, 1965 and issued to the Division of Government Documents, Washington, D. C. had not been presented for payment and the Finance Dept. requested that they be cancelled. It was moved by Councilman Love and seconded by Councilman Evans that Warrants #1233 in the amount of \$64.85 and #1234 in the amount of \$2.50 be cancelled. Motion carried. (6 AYES)

Councilman Wright arrived at the meeting.

PROCLAMATION

Realtors' Week

A proclamation from the Board of Realtors proclaiming May 22 through May 28th as Realtors' Week in the City of Grand Junction was presented. The President of the Council was authorized to sign same.

ADJOURNMENT

It was moved by Councilman Wright that the meeting adjourn. Motion carried. (7 AYES)
