#### Grand Junction, Colorado

November 2, 1966

#### **ROLL CALL**

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P.M. November 2, 1966 in the Civic Auditorium at City Hall. Councilmen present and answering roll call were Chas. E. McCormick, R. B. Evans, Chas. H. Love, Harry O. Colescott, Richard Youngerman, Herbert M. Wright and President Ray A. Meacham. Also present were City Attorney Gerald J. Ashby, City Manager Richard Gray, and City Clerk Helen C. Tomlinson.

#### **INVOCATION**

The invocation was given by Rev. Howard L. Manning, Retired Presbyterian Pastor.

#### **MINUTES**

It was moved by Councilman Love and seconded by Councilman McCormick that the minutes of the regular meeting held October 19, 1966, be approved as written. Motion carried.

# **HEARING**

Liquor License grtd Craig & Joyce Taylor, 401 North Ave.

This was the date set for hearing on the application of Craig and Joyce Taylor for a retail liquor store license at 401 North Avenue. They are purchasing the Lucky Liquors from Mark and Gladys Hamilton. No written petitions or objections had been filed. A letter from Chief of Police Karl Johnson was read stating that there was no reason why the application should not be approved. President Meacham closed the hearing.

It was moved by Councilman Evans and seconded by Councilman Wright that the application be approved and license granted when the State license has been received. Motion carried.

A report from Chief of Police Johnson stated that his Department had no objections to the renewal of any of the licenses. ### **HAMMER DRUG**

Liquor License

The application for the renewal of the Hammer Drug Store liquor license was presented. A letter from Karl Johnson, Chief of Police, stated that complaints against the Hammer Drug Co. had been filed charging that liquor had been sold on four occasions to persons under the age of 21 years of age. The cases have not been disposed of in County Court. Also, that it is rumored that they do not have a bona fide drug store with a qualified pharmacist on duty at all times to fill prescriptions. Mr. Johnson recommended that the license be denied until all the alleged violations have been satisfactorily adjudicated. City Attorney Ashby stated that he would like a little more time to check into these alleged violations, and, if it seems proper, to hold a hearing before the Council. It was moved by Councilman Wright and seconded by Councilman McCormick that the Hammer Drug application for renewal be tabled until the next meeting of the Council. Motion carried.

### 3.2 BEER VIOLATION

Food time Grocery 1117 N 1st St. Hearing 11-16-66

Chief of Police Johnson reported that on June 20, 1966, Mr. Donald Putnam, an employee of the Food Time Grocery, 1117 North First Street, was charged with the sale of 3.2 beer to two boys who were under the age of 18 years. Mr. Putnam was in County Court on Sept. 12, 1966 and found guilty and fined \$20 and placed on probation for one year. On April 20th, the licensee of this establishment was given a reprimand by the City Council for a similar violation in March, 1966. A hearing on this violation will be held Nov. 16th before the Council.

#### **UNITED FUND \$867**

payroll deductions permitted for 1st time

City Manager Gray reported that a total of \$867 had been donated to the United Fund by City employees. The quota set for them was \$550. Payroll deduction was permitted for the first time and apparently helped the total amount donated. President Meacham expressed gratification on the part of the Citizens of Grand Junction and the City Council for this nice response.

#### **CM REPORTS**

On Internatl CM's Conf in Phoenix 10-23/26

City Manager Gray reported that he had attended the 52nd annual conference of the International City Manager's Association in Phoenix, October 23rd to 26th. There were over 900 City Managers in attendance at the conference and all but two of the Colorado Managers were there. It was a very worthwhile conference. He also had the opportunity to meet and visit with former City Manager, Joe Lacy, and his wife.

Before returning to Grand Junction, he met Paul Walker, County and Regional Planning Director and went to Fort Worth where they visited the Regional Office of Department of Housing and Urban Development. This is the Federal Agency which administers Federal Aid programs to Municipal Governments. They met for two and one-half hours with four of the key persons in the community facilities section of the department and discussed overall programs of the comprehensive plan and master sewer study, which are now in progress in this community. They also discussed future programs and the procedures for initiating them.

### **SEWAGE DISPOSAL ODOR**

Councilman Wright suggested that City Manager Gray get in touch with Mr. Ray Sullivan in connection with a chemical that might aid in the treatment of sewer odors.

#### **HAMMER LIQUOR LICENSE**

Mrs. Amanda Hammer spoke briefly to the Council concerning her liquor license renewal, and was assured that the Council would consider everything at the proper time.

#### **ADJOURNMENT**

It was moved by Councilman McCormick and seconded by Councilman Evans that the meeting adjourn. Motion carried.
