A letter was read from Mr. and Mrs. A. W. Hammer withdrawing their application for a drug store liquor license. Councilman Colescott moved that the Council drop any hearings that may have been contemplated for alleged violations in operation of Hammer Drug. Councilman Love seconded the motion. City Attorney Ashby stated that the store will be liquidated before the first of the year, and that they do need the license for the balance of the year in order to accomplish this. He also stated that Chief Johnson was in accord with the Council's proposed procedure. Motion carried.

#### **3.2 BEER HEARING**

Violation Food Time Drive-In Grocery, Inc. 1117 N 1st

Selling to Minor

The hearing on Food Time Drive-in Grocery, Inc., 1117 No. 1st Street, for selling 3.2 beer to two minor boys was brought up. Mr. Tom Elder, Attorney, and Mr. Donald Putnam were present. City Attorney Ashby had requested that Rodney Sowers be present but he failed to appear. The other boy, James Hutton, had been excused from being present because of other commitments. Mr. Elder stated that apparently there was some difference of opinion as to how the beer had actually been purchased. However, Mr. Putnam had been found guilty, charged \$20 court costs and placed on probation. This had been a jury trial, so they would have to state that Mr. Putnam was guilty. City Attorney Ashby stated that one of the boys was over six feet tall, and very mature looking boy. Inasmuch as the boys were not present, the hearing was continued until the next Council meeting, and Mr. Ashby will have the boys brought in.

It was moved by Councilman Love and seconded by Councilman Evans that the boys be brought in by the Police Department for the next Council meeting. Motion carried.

### NATL LEAGUE OF CITIES

Clmn McCormick apptd on Transp & Communctns Comm

President Meacham read a letter from the National League of Cities to Mr. McCormick, appointing him to the Transportation and Communications Committee for the League. Mr. McCormick was complimented on this appointment.

#### **CLIFTON SANITATION DIST #2**

Meeting 11-30-66 re formation of dist

A letter was read from Mr. Wm. Anderies, Mesa County Budget Director, telling of a hearing to be held in the Court House on November 30, 1966 at 9:00 A.M. concerning the organization of Clifton Sanitation District No. 2. The Council requested that the City Manager and City Attorney look into this matter to see if the City has any interest in this district. Councilman Colescott brought out that too many outside districts would hem the City in and prohibit the expansion of its facilities. If it seems there is a reason for the Council to be interested in this matter, the City Manager will call the members together for a meeting.
