## ROLL CALL

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 p.m. July 5, 1967 in the Civic Auditorium at City Hall. Councilmen present and answering roll call were Chas. E. McCormick, R. B. Evans, Stanley Anderson, Harry O. Colescott, R. G. Youngerman, Herbert M. Wright and President Ray A. Meacham. Also present were City Attorney Gerald J. Ashby, City Manager R. N. Gray and City Clerk Helen C. Tomlinson.

## INVOCATION

The invocation was given by Rev. H. L. Manning, Retired Presbyterian Minister serving as Minister at Olathe.

## MINUTES

It was moved by Councilman McCormick and seconded by Councilman Evans that the minutes of the regular meeting held June 21, 1967 be approved as written. Motion carried.

## AUDIT-1966 - REPORT BY DALBY, WENDLAND & JENSEN

Mr. Curtis Robinson, a partner in the firm of Dalby, Wendland & Jensen, Certified Public Accountants, was present and stated that his firm had completed the 1966 audit for the City of Grand Junction and had delivered copies to each member of the Council. He stated that the City of Grand Junction maintains its accounting system on a single entry basis and since the state law was recently passed requiring double entry system the financial statements do not meet the requirements of the Colorado local government law.

City Manager Gray told the Council that the City is aware of this recent law but it gives Cities three years for compliance. The City is well along in the inventory of property which is required and hopes that within a very short time it will be in compliance with the Colorado law.

Mr. Robinson stated that they would have a letter of recommendations ready at a later date. In the meantime, the Council will study the audit report.

### C.M.L. COMPLIMENTS COUNCILMAN MCCORMICK

A letter was read from Mr. John Hamlin of the Colo. Municipal League complimenting Councilman McCormick on the manner in which he presided at one of the sessions at the annual conference and thanking him for his cooperation and contribution on the Resolutions Committee.

# ORDINANCE NO. 1265 PASSED - LIBRARY - TRANSFER FUNDS, BOOKS, PROPERTY TO MESA COUNTY PUBLIC LIBRARY

The following entitled proposed emergency ordinance was presented and read: AN ORDINANCE REPEALING CHAPTER 16 OF THE CODE OF ORDINANCES OF THE CITY OF GRAND JUNCTION, THE LIBRARY SECTION THEREOF, DISSOLVING THE BOARD OF DIRECTORS OF THE CITY LIBRARY, TRANSFERRING THE BOOKS AND PERIODICALS, THE CITY LIBRARY PERSONALTY AND THE FUNDS HELD BY THE CITY FOR THE LIBRARY OPERATION TO THE MESA COUNTY PUBLIC LIBRARY AND THE MESA COUNTY TREASURER FOR THE PUBLIC LIBRARY FUND, AND DECLARING AN EMERGENCY. # WATER/SEWER BONDS - CHARTER AMENDMENT - SPECIAL ELECTION 8-29-67

City Manager Gray stated that after considerable study and with the advice of the engineers and the fiscal agent, it has been decided that the best way to fund the water and sewer improvements, which are necessary to bring the plants up to date, would be a combined water and sewer revenue issue. The term of the bonds would be in the neighborhood of thirty years. In order to get the best price for a combined revenue bond, it will be necessary to co-pledge water and sewer revenues. It is recommended that a special election be held on August 29, 1967 so that the electorate can vote on a charter amendment that would permit co-pledging both water and sewer revenues toward re-payment of bonds of this nature.

It appears that the City is not eligible for anything from the Federal Government to supplement water funds but possibly would be eligible for some help toward a sewage disposal plant. At the next meeting of the Council an emergency ordinance will be proposed setting an election for a charter amendment on August 29, 1967.

#### ADJOURNMENT

It was moved by Councilman McCormick and regularly seconded and carried that the meeting adjourn.
