#### ROLL CALL

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P.M. January 15, 1969 in the Civic Auditorium at City Hall. Councilmen present and answering roll call were C. A. Walt, R. B. Evans, Stanley Anderson, Harry O. Colescott and President R. G. Youngerman. Councilmen Ray Meacham and Herbert M. Wright were absent. Also present were City Manager Gray, City Attorney Ashby and City Clerk Helen C. Tomlinson.

### **INVOCATION**

The invocation was given by Captain Jarvies, Salvation Army.

## **MINUTES**

It was moved by Councilman Anderson and seconded by Councilman Evans that the minutes of the regular meeting held January 2, 1969 be approved as written. Motion carried.

### LEGAL ADVERTISING

Renew Contract with Daily Sentinel for 1969 Instr No.

12¢ per line per insertion

Mr. Kenneth Johnson, General Manager of The Daily Sentinel, came to the Council and presented the 1969 agreement for the printing of legals for the City. This contract calls for The Daily Sentinel to be designated as the official newspaper for the City and sets the rate of payment at \$.12 per agate line per insertion. It was moved by Councilman Walt and seconded by Councilman Evans that the President of the Council and City Clerk be authorized to sign the agreement. Motion carried.

### **HOUSING CODE**

Plan Comm to proceed with study committee

Statement of Council

Mr. Blake Chambliss, member of the Grand Junction Planning Commission, came before the Council and stated that at the special meeting of the Planning Commission held on January 8th, it was the determination of the Commission that the City should go ahead and select a committee to study the Housing Code. The suggestion was made that a City voter registration list be secured and that twelve names be selected from each district to serve as a committee. Mr. Chambliss suggested that this be done in an orderly manner with members of the Planning Commission and any citizens who were interested be present at a Council meeting when the names are drawn. Each name on the lists would be given a number and at a Council meeting the names would be selected at random from a table of random numbers. There would be no way then to "load" the committee. The lists would be posted at the City Hall and anyone could look at the list, and if his name was not on it, he could register in the proper manner and have his name added to the list.

Meetings would be held, with the press present, so that proper publicity could be given to the study as it was going on. Mr. Chambliss suggested that this procedure be followed through and the meetings held and study made as expeditiously as possible.

The City Council presented and read a Statement of Policy in connection with a Housing Code, as follows:

"In consideration of City Council appointing a Citizens' Committee to study the desirability and feasibility of Grand Junction adopting a housing code, we believe the following position of the Council should be made perfectly clear.

"At this time, the City Council in no way has prejudged or predetermined the desirability or need for a housing code in Grand Junction. The Council has neither taken a position favorable nor unfavorable to a housing code.

"We believe that in order for the Council to perform its function as the elected representatives of the Grand Junction citizens, that we must always be willing to explore possible needed improvements in laws and ordinances for the City. We charge the Citizens' Study Committee to make an objective study of a housing code and its feasibility for Grand Junction. Throughout this process, they should be informing the general citizens, as well as their own committees.

"When the Citizens' Committee is prepared to make recommendations to this Council of their findings, we will then decide on the best way to proceed if further action is necessary."

It was moved by Councilman Walt that the City Council authorize the Planning Commission to appoint the committee to study the Housing Code on the basis outlined, to be approved by the City Council. Councilman Anderson seconded the motion. Motion carried.

# **CITY-COUNTY ATTORNEY**

Provide budget for 1969

The following Resolution was presented and read:

### **RESOLUTION**

A RESOLUTION AMENDING THE BUDGET ADOPTED FOR THE FISCAL YEAR ENDING DECEMBER 31, 1969, TO PROVIDE A BUDGET FOR THE DEPARTMENT OF CITY-COUNTY ATTORNEY.

WHEREAS, the Board of County Commissioners of Mesa County and the City Council of the City of Grand Junction have determined to establish the joint offices of City-County Attorney, the expenses for which are to be shared equally by the two agencies; and,

WHEREAS, it has been determined that the City shall be the paying agency for said operation, and it is necessary to establish a budget for all departments;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

The Proof of Publication to the following entitled proposed ordinance was presented and read: AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF GRAND JUNCTION, COLORADO. It was moved by Councilman Colescott and seconded by Councilman Evans that the Proof of Publication be accepted and filed. Motion carried.

It was moved by Councilman Anderson and seconded by Councilman Evans that the ordinance be called up for final passage. Motion carried.

The Ordinance was then read, and it was moved by Councilman Colescott and seconded by Councilman Anderson that the ordinance be passed and adopted as read, numbered 1303 and ordered published. Roll was called on the motion with

all members of the Council present voting AYE. The President declared the motion carried.

### W. FRANKLIN AVE R/W

\$2000 to Matilda Derosiers for 25 ft x 226 ft

City Manager Gray stated that Mrs. Matilda Desrosiers at 1st and West Franklin owns a tract of land 25 feet wide and 226 feet long which she will sell to the city for right of way for W. Franklin Avenue for the sum of \$2,000. As a condition for the sale of this property, Mrs. Desrosiers asks that the City will not open up W. Franklin Ave. unless a petition for paving is signed by the other property owners along this street. She does not want to have a dusty, graveled road in front of her property. Along the south side of W. Franklin, there is a 36 foot easement, but no right of way dedicated for a street. The City has been trying for some time to work out the problems in this area so that a fifty-foot street can be put in and improved. Some of the street on the north side is paved and has curb and gutter which were put in under City specifications. Several property owners from this area attended the Council meeting, including Mrs. Desrosiers, Tom La Duke, Charles Hamilton and Mr. and Mrs. Orvis.

It was moved by Councilman Walt that action on this matter be delayed until the next meeting of the Council. He has not been up there to inspect the property. There was no second to this motion.

It was moved by Councilman Colescott that the City see if they can get the signatures of all the interested property owners for a right of way along the present easement on the south side of Franklin and when this has been done to enter into an agreement with Mrs. Desrosiers to purchase the north twenty-five feet for right of way for the sum of \$2,000. Councilman Anderson seconded the motion. All members of the Council present voted Aye with the exception of Councilman Walt. The motion was declared carried.

### **ADJOURNMENT**

The President declared the meeting adjourned.
