ROLL CALL

Councilman Harry O. Colescott, re-elected Councilman from District "A" was sworn into office by City Clerk Helen C. Tomlinson. The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock p.m. May 7, 1969 in the Civil Auditorium at City Hall. Councilmen present and answering roll call were Raymond R. Paruch, Harry O. Colescott, Ray A. Meacham, Stanley R. Anderson, Theodore N. Naff, R. B. Evans and President Richard G. Youngerman. Also present were City Manager Gray, City Attorney Ashby and City Clerk Helen C. Tomlinson.

INVOCATION

The invocation was given by Rev. Mabel Donaldson, Unity of Grand Junction.

MINUTES

It was moved by Councilman Anderson and seconded by Councilman Evans that the minutes of the regular meetings of April 16th and May 5th be approved as written. Motion carried.

HEARING

San Sr Dist No. 24-69

(Melrose Estates) No. of Orchard & 28 Rd - Jim Gale

This date had been scheduled and advertised for hearing on the creation of a sanitary sewer district in Melrose Estates Subdivision. The petition was presented and signed by the developer of the subdivision. No written protests had been received, and there were no protests from anyone in the audience. President Youngerman closed the hearing.

City Manager Gray concurred with this recommendation stating that even though the low bid was \$255 over the amount budgeted, this amount could be absorbed. It was moved by Councilman Evans and seconded by Councilman Meacham that the low bid of Fred Cunningham in the amount of \$6,255 for repairing curbs, gutters and sidewalks for 1969 be accepted and contract awarded to him. Concrete lining balance of North Fork Ditch on Kannah Creek

Elam Constr \$7360 low

Bids had been received and opened at 2:30 p.m. May 6th for lining the balance of the North Fork ditch on Kannah Creek. The following bids were received:

Elam Construction, Inc. \$7,360. Bluewater Builders, Inc. 6,000. Engineer's estimate 8,000.

A memo from City Engineer Hickman advised that Mr. McGuffey, owner of Bluewater Builders, Inc., the apparent low bidder, had advised him by telephone May 7th that Bluewater Builders, Inc. would be unable to make the required bond and guarantee (100%). Mr. Hickman therefore recommended that the contract be awarded to Elam Construction, Inc. City Manager Gray concurred with this recommendation. Councilman Colescott stated he thought it would be advisable to get written confirmation from Bluewater Builders, Inc. that they could not produce the required bond. It was stated that a check had been made with the bonding company and the Company confirmed that the necessary bond could not be presented. It was moved by Councilman Colescott and seconded by Councilman Anderson that the bid of Elam Construction, Inc. in the amount of \$7,360 for concrete lining on the North Fork Ditch at Kannah Creek be accepted and contract awarded to them. Bleachers - GJ Stock car racing Assn req to use

Denied

Mr. Wayne Jones, Sec'y, Grand Junction Stock Car Racing Association, was present and addressed the Council. He stated the Association was organized a year and a half ago and interest in the program had mushroomed beyond their expectations. They now have a location on Whitewater hill and are in the process of building a stock-car racing track and expect to have many entertaining shows. Their immediate need is help for this year, and they would like to use the portable bleachers at Lincoln Park.

Mr. Stocker and Mr. Jim Wysocki of the Parks and Recreation Department were present. Mr. Stocker told the Council he would like to make it clear that they were not against stock-car racing but they had to consider all of the programs they have in the park - the NJCAA, the Shrine Circus, Rodeo, baseball and tennis which have overflowing crowds. These bleachers are constantly being moved around to accommodate the crowds and if they were loaned out, they would be gone when he needed them.

Mr. Wysocki stated that when other organizations have asked for the bleachers, they have been told "No" and it might be best to keep this policy. The Council went along with Mr. Stocker and Mr. Wysocki and advised Mr. Jones that the bleachers could not be loaned out of Lincoln Park. Mr. Jones thanked the Council for consideration.

Waive green fees for Rocky Mtn Open, L.P. Firestone 3rd Annual Invitational \$ 1 ladies guest day

Letters were read from Mr. Roy L. Reynolds, Golf Pro at Lincoln Park Golf Club, and W. A. Russell, President of the Lincoln Park Men's Golf Club, asking for green fees to be waived on May 17 and 18 for the Annual Western Slope Firestone Golf Tournament. Mr. Reynolds also asked that the green fees be waived for Inter-Club matches with Bookcliff Country Club on May 11th; Pro-Am with the professional and four members of surrounding clubs on the Western Slope and in Eastern Utah; June 24th and July 22nd for Ladies Guest Days; and Aug. 13 to 17th for the Rocky Mountain open. It was moved by Councilman Anderson and seconded by Councilman Meacham that the City grant permission for green fees to be waived for the Rocky Mountain Open on Aug. 13 thru 17th; the Lincoln Park Firestone Third Annual Invitational and one ladies guest day. Laurence Flanagan dba Westside Grocery, 505 W Colo - apprvd

Clmn Paruch statement impossible to vote for any beer licenses

An application for renewal of 3.2 beer license was presented for Laurence Flanagan dba Westside Grocery, 505 West Colorado Ave. A letter from Karl Johnson, Chief of Police, was read stating that there was nothing in the operation of this license in the past year that would prohibit the renewing of same. Councilman Paruch stated that because of the basic thinking of some of his constituents, it would be impossible for him to vote in the affirmative on any question relating to beer. It was moved by Councilman Evans and seconded by Councilman Meacham that the application be approved and that license be issued when state license has been received. Motion carried with Councilman Paruch voting NAY. Motion carried.

Councilman Naff suggested that Bookcliff Avenue be widened as far to the east as possible as it narrows down along where this annexation will be located.

Ski-Lu, Inc. dba Ivanhoe Inn

Approve req to expand - add bar in basement

Ski-Lu, Inc. dba Ivanhoe Inn, 233 North Avenue, presented an application to expand and enlarge the premises at 233 North Avenue and add a basement bar facility. This had been approved by the liquor inspection department. It was moved by Councilman Meacham and seconded by Councilman Evans that the request be approved and that the City Manager be authorized to sign the application. Motion carried with Councilman Paruch voting NAY.

ANNEXATION

Grand Ave East of School Adm Bldg & South to Freeway

To use enclave law

Instr No. 4233

The Planning Commission recommended that an area east of the school district buildings and south of Grand Avenue to the freeway be annexed. One large property owner has not wanted annexation and has blocked it for years, but the homes along Grand Avenue need sewer service. The Planning Commission recommended to the Council that this area be annexed in accordance with the enclave annexation law, as it has been surrounded for three years by city boundaries.

It was moved by Councilman Anderson and seconded by Councilman Naff that the Council grant the Planning Commission authority to use the enclave annexation procedure and to proceed as soon as possible. Motion carried.

PANCAKE DAY

Kiwanis Club req 6-20-69 granted

to use tables & chairs from Lincoln Park

A letter from Kiwanis Club asked that for their second annual pancake day in the downtown shopping park, on June 20th, in connection with the Stampede, that they be given permission to block off a half a block of the shopping park east of Fifth Street and to use the tables and chairs from Lincoln Park Auditorium. It was moved by Councilman Anderson and seconded by Councilman Paruch that the requested be granted. Motion carried.

Amend Chapt 14-\$25 license fee for contract refuse haulers

to charge for use of tanks

The following entitled proposed ordinance was presented and read: AN ORDINANCE AMENDING CHAPTER 14 OF THE CODE OF ORDINANCES OF THE CITY OF GRAND JUNCTION TO PROVIDE A LICENSE FEE AND PROCEDURES FOR ISSUING LICENSES TO CONTRACT HAULERS OF REFUSE AND GARBAGE, AND PROVIDING CHARGES FOR TWO YARD SANITATION TANKS. City Manager Gray explained that the fee for licensed trash haulers would be \$25 per year or portion thereof. This need exists. Haulers cannot solicit business, but there are times when customers have a large amount of trash to be hauled, and the City cannot take it when the customer wants it hauled. This would not relieve the city resident of any responsibility in paying the regular fee for hauling trash and garbage. There is also a growing trend to use the larger steel tanks, especially for businesses where there is a lot of refuse to be taken care of. The tanks cost in the neighborhood of \$300 each. The City would purchase the tanks and rent them at a fee of \$5.00 per month, or the customer could purchase a tank of his own. A deal can be made whereby the tanks could be furnished by a local company.

It was moved by Councilman Anderson and seconded by Councilman Evans that the proposed ordinance be passed for publication. Motion carried.

Police Dept-Resol To increase salaries

Members of the City Council had discussed on numerous occasions the fact that it has been impossible to hire qualified police officers and to keep the men in the department, and had resolved that the police sworn officers should have a raise in salary at this time. This had been explained to the Employees' Committee members at an earlier meeting. The raise for the policemen would cover patrolmen through captains and would average 9%. Officers starting wages would be \$486.00 - a 4 1/2% increase and sergeants would receive approximately 14% raise in salary. The following Resolution was presented and read:

Councilman Anderson stated that the reason that raises were being given to the police employees was the fact that it was impossible to get well qualified men to serve as officers. He felt that there had been no intention of raising the chief at this time, and that a raise for him should be given at the time other department head salaries are considered. Councilman Meacham stated that he felt that Mr. Johnson, was very well qualified and should have more money, but that this was not the time for singling him out for a raise and that study of this position should be given to see how his position ranks with positions of other Chiefs of Police.
