#### Grand Junction, Colorado

October 3, 1973

#### ROLL CALL

The City Council of the City of Grand Junction, Colorado met in regular session at 7:30 p.m. October 3, 1973, in the Civic Auditorium at City Hall. Present for roll call were President of the Council Stanley Anderson, and Council members Harry Colescott, Silas Grantham, Lawrence Kozisek, Jane Quimby, Elvin Tufly, and Robert Van houten. Also present were City Attorney Gerald Ashby, City Manager Harvey Rose, and City Clerk Neva Lockhart.

#### MINUTES

There being no corrections or additions to the Minutes of the Regular Council meeting held on September 19, 1973, Councilman Kozisek moved they be approved as written which motion was seconded by Councilwoman Quimby and said motion carried unanimously.

### <u>HEARING - TRAILERS & MOBILE HOMES - PROPOSED ORDINANCE - REFERRED</u> BACK TO PLANNING <u>COMMISSION</u>

This was the date advertised for hearing on the proposed ordinance entitled AN ORDINANCE REPEALING AND REENACTING CHAPTER 29 OF THE CODE OF ORDINANCES OF THE CITY OF GRAND JUNCTION, ITS TRAILERS AND MOBILE HOMES ORDINANCE AND PROVIDING FOR THE PUBLICATION OF SAID ORDINANCE IN PAMPHLET FORM. Mr. Gary Cowan, Attorney, was present representing Mobile Park owners as well as many Mobile home Approximately 200 interested Mobile Home owners were owners. present for the hearing. Mr. Cowan stated that they would like a compromise, a variance on a nonconforming use as compliance with the proposed ordinance would present a hardship for the park owners as well as the mobile home owners. Mr. Virgil Sherry, 2837 North Avenue, and owner of the A&W Trailer Court; Mr. Willard L. Richmond, 519 Court Road and owner of the Metro Mobile Home Park; Mr. Lloyd Moler, 830 Independent Avenue and owner of the Westlake Mobile Home Park; Mr. Mark Zelmer, 1040 Independent Avenue and representing the Westward Ho Mobile Park; and Mr. Bob Mather, 1550 South U.S. Highway 50 and owner of the Grand View Mobile Home Park, presented estimates they would have to absorb if the ordinance is adopted in its present form. All owners said they would have to raise the space rental to pay for the improvements, and all owners noted that they have 50 to 75 percent tenants who are on fixed incomes.

Battalion Chief R. T. Mantlo was present and discussed the average burn time for trailers, which is 14 minutes, versus homes with one-half inch sheet rock insulation, which is 30 minutes. Mr. Steve Miller, 549 Willow Road, a mobile home owner, stated that mobile homes provide low-income housing which is not provided in any other way in Grand Junction. He opposed passage of the ordinance in its present form. The President closed the hearing.

#### RECESS

It was moved by Councilman Van Houten and seconded by Councilman Grantham that the proposed ordinance be referred back to the Planning Commission subject to review with the Mobile Homes Park Association. Motion carried unanimously.

Mr. Cowan indicated he would work with this group.

After a short recess, the President called the meeting to order.

## <u>HEARING - REZONING 16.63 ACRES FROM R-1-B TO PD-8 LANDING PROPERTY</u> IN MANTEY HEIGHTS - PROPOSED ORDINANCE

Approved by the Planning Commission and advertised for hearing on this date was the request by Ralph and Lilamarie Landing to rezone 16.63 acres from R-1-B (Single-Family Residence) to PD-8 (Planned Unit Development). This property is located South of Patterson Road, West of Mantey Heights Water Tank and East of Mantey Heights Subdivision, and North of the Grand Valley Canal. No letters were filed regarding this request, and there was no one in the audience who indicated a desire to speak on this matter. The President closed the hearing.

The following entitled proposed ordinance was presented and read: AN ORDINANCE AMENDING THE ZONING MAP, A PART OF CHAPTER 32 OF THE CODE OF ORDINANCES OF THE CITY OF GRAND JUNCTION BY CHANGING THE ZONING OF CERTAIN LANDS WITHIN THE CITY. It was moved by Councilwoman Quimby and seconded by Councilman Grantham that the proposed ordinance be passed for publication and said motion carried unanimously.

## PROPOSED ORDINANCE - VACATE 3 FOOT UTILITY EASEMENT ON NORTH PROPERTY LINE OF LOT 5, WALKER HEIGHTS SUBDIVISION

Recommended from the City Planning Commission was the request for vacation of a three-foot utility easement on the north property line of Lot 5 in Walker Heights Subdivision. The following entitled proposed ordinance was presented and read: AN ORDINANCE VACATING A PORTION OF EASEMENT IN THE CITY OF GRAND JUNCTION, It was moved by Councilman Colescott and seconded by Councilman Tufly that the proposed ordinance be passed for publication. Motion carried unanimously.

## REVOCABLE PERMIT FOR STREET LIGHT AT 812 ROOD AVENUE FOR SQUIRRELL'S ANSWERING SERVICE - RESOLUTION

Approved and recommended by the City Planning Commission was the petition of D. W. Squirrell, dba Squirrell's Telephone Answering

Service, for a revocable permit to install a light pole in the City right of way at 812 Rood Avenue. The following Resolution was read:

#### RESOLUTION

WHEREAS, D. W. SQUIRRELL, dba SQUIRRELL'S TELEPHONE ANSWERING SERVICE, has petitioned the City Council of the City of Grand Junction for a revocable permit and proposes to install a light pole in the City right of way near the southwest corner of the east one-half of Lot 30 in Block 92, City of Grand Junction, between the end of the chain link fence and the City sidewalk near the edge of the black top presently on said lot; and

WHEREAS, such action has been heretofore approved by the City Planning Commission and would not be detrimental to the use of the right of way or to the interest of the inhabitants of the City;

<u>DAYS - DISCUSS RECENT ART FESTIVAL - DOWNTOWN RETAIL TRADE</u>
COMMITTEE

Mr. Howard Butterfield, Mr. Guy Stephens, and other members of the Downtown Retail Trade Committee presented slides and a letter protesting the manner in which the recent Arts and Crafts Fair was handled. They listed: (1) The closing of Main Street on Friday and Saturday, September 7 and 8 was not sanctioned by the Trade Committee; (2) Spaces sold directly in front of shops for \$20 each, and the fact that they were doing business in many locations when only one Sales Tax Permit had been purchased; (3) Slides were shown of the Downtown Shopping Park. The pictures were taken on Sunday morning after the event; and (4) The Downtown Retail Trade Association requested the right to endorse or to reject any promotion or event planned for or involving any portion of the Downtown Shopping Park. The Committee stated it holds no malice towards the Arts and Crafts, and in fact has discussed the possibility of sponsoring a Fair on Main Street. The Committee felt that a properly managed Fair, and inviting Art and Craft people from the Grand Valley only, would be an asset to the City. Mr.

Butterfield said this matter was brought to the attention of the Council as the Committee wants to see that something like this does not happen again and some control can be placed on the activities on Main Street. He noted that certain stores lost thirty percent of business on these two days which were the last two shopping days before school started.

Councilman Van Houten stated that he did not see this Fair nor the conditions noted; he said he did not feel that paragraph 4 of the letter was applicable. Councilwoman Quimby noted that she did attend the Fair on Friday and thought it was delightful; she did not, however, get to attend on Saturday nor did she see the She said that there were two spoken of on Sunday. conditions. Council meetings prior to the Fair at which time the Downtown Retail Trade Committee could have made their feelings known. Since they did not do so, Council acted on information available. Mr. Butterfield said that he was contacted by the coordinator of the Fair prior to the Council meetings but that he had not met with the Committee and so had been unable to come to Council and give the Committee's opinion. Councilman Tufly stated that in future when something comes up that the Committee or any member personally, does not approve, Council would like to have that information.

Mrs. Althea Williams said that the Fair brought some exhibits to Grand Junction which were impressive, and many people would not have had the opportunity to see them otherwise. She felt that more cooperation between the Committee and the Fair would have been productive. President Anderson questioned the thirty percent loss of sales. Mr. Butterfield said this was obtained by comparing this year's sales against those of last year. President Anderson said he would like very much to see the Fair done again and asked the Committee to work on it.

#### 3.2 BEER RENEWAL - SKAGGS DRUG, 1834 N. 12TH STREET - APPROVED

Presented for consideration was the application by Skaggs Companies, Inc., doing business as Skaggs Drug Center, 1834 North 12th Street, for a 3.2 beer license renewal. A letter from Chief of Police Karl Johnson advised that there have been no complaints or violations concerning the sale of 3.2 beer at this establishment.

It was moved by Councilman Colescott and seconded by Councilman Kozisek that the application be approved and the license issued when the State license has been received. The motion carried unanimously.

#### <u>LIQUOR LICENSE - CHANGE OF OFFICERS, BARBOUR'S FORESIGHT LIQUOR -</u> APPROVED
