Thereupon, the following Ordinance was introduced and read by title only, each member present having been furnished a copy thereof:

AN ORDINANCE AUTHORIZING THE SALE AND ISSUANCE OF SEWER REFUNDING BONDS, SERIES 1978A, PRINCIPAL AMOUNT REVENUE IN THE \$1,080,000, GENERAL OBLIGATION WATER REFUNDING BONDS, SERIES 1978B, IN THE PRINCIPAL AMOUNT OF \$2,145,000, DATED MAY 1, 1978, FOR THE PURPOSE OF REFUNDING JOINT SEWER AND WATER REFUNDING REVENUE BONDS, SERIES 1976, DATED SEPTEMBER 1, 1976, OF THE CITY GRAND JUNCTION, OUTSTANDING IN THE PRINCIPAL AMOUNT \$3,240,000; PROVIDING FOR AN ESCROW TO PAY SAID BONDS AND THE INTEREST THEREON; PRESCRIBING THE FORM OF SAID BONDS; PROVIDING FOR THE ISSUANCE OF GENERAL OBLIGATION WATER BONDS SERIES 1978C, IN THE PRINCIPAL AMOUNT OF \$3,205,000, DATED MAY 1, 1978, FOR THE PURPOSES OF EXTENSIONS, CONSTRUCTION AND BETTERMENTS TO WATERWORKS FACILITIES; PROVIDING FOR THE APPLICATION OF CERTAIN REVENUES OF THE SEWER AND WATER SYSTEM OF THE CITY AND AN INVESTED SINKING FUND TO PAY THE SERIES 1978A, SERIES 1978B AND SERIES 1978C BONDS AND THE INTEREST THEREON; PROVIDING FOR THE LEVY OF TAXES TO PAY THE SERIES 1978B REFUNDING BONDS AND THE SERIES 1978C WATER BONDS AND THE INTEREST THEREON; FINDING AND DECLARING AN

EMERGENCY, AND PRESCRIBING OTHER DETAILS IN CONNECTION THEREWITH.

It was thereupon moved by Council member Brown and seconded by Council member O'Dwyer, that the foregoing Ordinance No. 1737, read by title only, at this meeting as aforesaid, be finally passed on first reading, as read, as an Emergency Ordinance and that all rules of this Council which might prevent, unless suspended, the final passage and adoption of said Ordinance at this meeting, be and the same are hereby suspended, and that said Ordinance No. 1737 be published in full in The Daily Sentinel, within three days of its passage.
