

Grand Junction, Colorado

November 13, 1978

The City Council of the City of Grand Junction, Colorado, reconvened in regular adjourned session the 13th day of November, 1978, at 1:30 p.m. in Council Chambers at City Hall. Those present were Council members Larry Brown, Frank Dunn, Robert Holmes, Jane Quimby, Bill O'Dwyer, and Karl Johnson, a quorum. Councilman Kozisek was absent. Also present were City Manager Jim Wysocki, City Attorney Gerald Ashby and City Clerk Neva Lockhart.

RESOLUTION SETTING MILL LEVY FOR 1979 AT EIGHT (8) MILLS (6.35 MILLS FOR GENERAL FUND, 1.65 MILLS FOR UNFUNDED LIABILITY OF POLICE AND FIRE PENSION FUNDS)

The following Resolution was read:

RESOLUTION

CITY OF GRAND JUNCTION 1979 BUDGET

IMPLEMENTING DOCUMENTS

LEVYING TAXES FOR THE YEAR 1978 IN THE CITY OF GRAND JUNCTION, COLORADO.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

That there shall be and hereby is levied upon all taxable property within the limits of the City of Grand Junction, Colorado, for the year 1978 according to the assessed valuation of said property, a tax of eight (8) mills on the dollar (1.00) upon the total assessment of taxable property within the City of Grand Junction, Colorado, 1.65 mills for the purpose of funding a portion of the unfunded liability of the police and fire pension funds and 6.35 mills for the purpose of paying the expenses of the municipal government of said City, and certain indebtedness, including interest upon indebtedness of the City, for the fiscal year ending December 31, 1979.

ADOPTED and APPROVED this 13 day of November, 1978.

RESOLUTION SETTING FIVE (5) MILLS LEVY FOR DOWNTOWN DEVELOPMENT AUTHORITY

The following Resolution was read:

RESOLUTION

LEVYING TAXES FOR THE YEAR 1978 IN THE GRAND JUNCTION, COLORADO, DOWNTOWN DEVELOPMENT AUTHORITY.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

That in accordance with the provisions of 31-25-817 of Colorado Revised Statutes, 1973, there shall be and hereby is levied upon all taxable property within the Grand Junction, Colorado, Downtown Development Authority limits, for the year 1978 according to the assessed valuation of said property, a tax of five (5) mills on the dollar (\$1.00) upon the total assessment of taxable property within the Grand Junction, Colorado, Downtown Development Authority, for the purpose of paying the expenses of said Authority for the fiscal year ending December 31, 1979.
