OF DECISION ON APPLICATION FOR A FERMENTED MALT BEVERAGE LICENSE BY FEATHER PETROLEUM COMPANY AT 213 NORTH FIRST STREET, GRAND JUNCTION.

A public hearing having been held on March 21, 1979, on the application by Feather Petroleum Company for a fermented malt beverage license for sales in sealed containers for consumption off the premises for Stop 'N Save at 213 North First Street, Grand Junction, and the City Council having considered the evidence adduced at said hearing, FINDS:

- 1. That the hearing was held on March 21, 1979, on the application after proper notice thereof under the Beer Code.
- 2. That the survey conducted by the City indicated that the needs of the neighborhood were not being met by other outlets within the neighborhood and there was a need for this outlet in that 219 persons so stated while 37 felt the needs were being met by other outlets. In addition, the applicant submitted petitions bearing the signatures of 73 persons supporting the issuance of the license.
- 3. That no one appeared at the hearing in opposition to the granting of the license and no petitions or letters of disapproval were received by the City Council.
- 4. That the character of the applicant, as determined through a

check by the Police Department of the corporate officers and through letters attesting to their good character, is good.

5. The evidence supports the position that the needs of the neighborhood are not being met by other outlets of the same type and the position that the desires of the inhabitants of the neighborhood are that the license issue.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That a fermented malt beverage license for sales in sealed containers for consumption off the premises issue to Feather Petroleum Company doing business as Stop 'N Save at 213 North First Street, Grand Junction.

Filed and accepted on March 1, 1979, was the application by John W., Jr. and Eleanor Maloney to move retail liquor store license from 716 Horizon Drive to 715 Horizon Drive. The sign giving notice of hearing was posted on the property March 23, 1979, and the display ad giving notice of hearing was published in The Daily Sentinel on Friday, March 23, 1979. A survey was conducted of the area bounded by G Road on the south, 28-1/4 Road on the east, H

Road on the north, and 27 Road (12th Street) on the west. The survey commenced March 10, and was completed March 23. Results are:

The Health Department and Fire Department will make their inspections upon the completion of the building prior to issuance of license.

Sam Haupt was present representing the developers of the Shopping Center where this restaurant is to be located. Mr. Steve Zook and Mr. Abshagen were present. No opponents, no letters, no counterpetitions.

HEARING - APPLICATIONS BY MESA COLLEGE FOR 3.2% BEER SPECIAL EVENTS PERMITS FOR FRIDAY, APRIL 27 FROM 8:00 P.M. TO MID-NIGHT ON LAWN S OF STUDENT CENTER, AND SATURDAY, APRIL 28, FROM 12:00 NOON TO 4:00 P.M. ON LAWN W OF SAUNDERS FIELD HOUSE (4TH AND 5TH PERMITS) GRANTED

A hearing was held after proper posting of property. The report from the Police Department was read.

As in past functions of this nature, the college will check identification to insure only those 18 or older will be allowed to consume beer. They will serve beer only on the lawn south of the Student Center on the 27th and the lawn west of Saunders Field House on the 28th.

WHEREAS, the Council has found, and does hereby find, that one-sixth the perimeter of the area proposed to be annexed is contiguous with the City; that a community of interest exists between the territory and the City; that territory proposed to be annexed is urban or will be urbanized in the near future; that the territory is integrated or is capable of being integrated with said City; that no land in single ownership has been divided by the proposed annexation; no land held in identical ownership comprising more than twenty acres which, together with the building and improvements thereon has an assessed valuation in excess of two hundred thousand dollars is included without the landowner's consent; nor is any of the land now subject to other annexation proceedings; and that no election is required under the Municipal Annexation Act of 1965.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That said territory is eligible for annexation to the City of Grand Junction, Colorado, and should be so annexed by Ordinance.

RESOLUTION OF OPPOSITION TO HOUSE BILL NO. 1201 - APPROVED

The following Resolution was read:

RESOLUTION

OPPOSING HOUSE BILL 1201 CONCERNING CONDEMNATION FOR DOMESTIC WATER.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That there be communicated to the members of the Legislature from Mesa County the opposition of the City to House Bill 1201 with the urging of a negative vote by them as the Bill needlessly restricts municipalities in their acquisition of water and too narrowly defines "domestic water" requiring a complete change in the practice of water use in municipalities to their detriment without corresponding benefit to others.

TWO RIVERS PLAZA

City Manager Wysocki reported that sampling of the roof at Two Rivers Plaza indicates that probably the entire roof will not have to be replaced although additional sampling is necessary prior to final decision.

Regarding the figures for any addition or storage, Mr. Wysocki indicated he will have those by the date of Council's study session.

Councilman Brown requested a legal opinion as to whether the City has any recourse whatsoever, with respect to the roof, against any party, whether it's the person who designed it, or the person who put it down, or any party who came in between.

LETTER FROM MAYOR TO COUNCIL CANDIDATES

Councilman Holmes suggested the Mayor send a letter to the nine Council candidates and he offered his congratulations to the four successful.

MISCELLANEOUS

Councilman Brown asked where the City stands on its big advertising campaign regarding easements. Mr. Wysocki responded that it has not been developed yet.

He, too, congratulated all the Council winners.

Councilman O'Dwyer stated that four or five months ago it was requested that Staff look to the future and see what kind of space they are going to need. Since Council has not received a report, he hopes they are still thinking about it.

Councilman Brown mentioned the use of the lands around the Airport for related facilities. He noted that land that may not be desirable for other development could be used for Road Department Buildings, the desirability of a golf course, etc. From the standpoint of taking lands that may some day be a problem from the noise and what not, and using them for City installations if they are appropriate.

Councilman Dunn said that although he has not always agreed with them, he is going to miss Councilman Kozisek and Councilman Brown and suggested they not forget the problems facing the City. Councilman Brown responded that their conspiracy is still in the embryonic stage, but they will be back. President Johnson pointed out that ex Council people are always subject to appointment to

special task forces.
