The City Council of the City of Grand Junction, Colorado, convened in regular session the 20th day of October, 1982, at 7:30 p.m. in the City Council Chambers at City Hall. Those present were Council members Betsy Clark, Frank Dunn, Robert Holmes, Karl Johnson, Christine Kreissler, and President of the Council Louis Brach. Councilman Gary Lucero was absent. Also present were City Manager Jim Wysocki, City Attorney Gerald Ashby, and City Clerk Neva Lockhart.

President of the Council Louis Brach called the meeting to order and led in the Pledge of Allegiance.

INVOCATION

Reverend James Schaedler, Clifton Assembly of God Church.

MINUTES

Upon motion by Councilman Johnson, seconded by Councilwoman Clark and carried, consideration of the minutes of October 6, 1982, was deferred to November 3, 1982.

HOUSING AUTHORITY - THOMAS L. SWENSON APPOINTED TO 5-YEAR TERM

By secret ballot, Thomas L. Swenson was appointed to the Grand Junction, Colorado, Housing Authority for a term of five years.

FORESTRY BOARD - SUSAN MARTINEAU APPOINTED TO FILL VACANCY - TERM EXPIRES SEPTEMBER, 1984

Upon motion by Councilwoman Clark, seconded by Councilman Holmes and carried, Susan Martineau was appointed to serve on the City of Grand Junction Forestry Board, term to expire September, 1984.

CITIZENS REQUEST IMPROVEMENTS TO TIARA RADO GOLF COURSE

Stewart Thomas, 503 Rado Drive, and Tom Wayland, 505 Rado Drive, appeared before Council to petition for a fence to separate the townhouse development from the Tiara Rado Golf Course parking lots. A request to move the trash containers for the golf course has already been acted upon. According to Mr. Thomas and Mr. Wayland the fence would provide a barrier and help eliminate illegal trespass, dust, and debris, and prohibit the use of private parking lots by Tiara Rado patrons. The gentlemen indicated their respective Associations are willing to provide the materials for the fence if the City will furnish the labor to install the fence as indicated by the Parks and Recreation Director during conversations earlier this year.

The City Manager indicated that the suggestion by the outgoing

Parks and Recreation Director to provide the labor for the fence still stands. He indicated, however, that the Condo and Homeowner's Associations have not responded as to whether they wish to participate by purchasing the materials. Regarding the parking lot, Mr. Wysocki stated this is an item that would need to be budgeted, but that it may not be requested in this budget process because there may be another means of moving the maintenance shed, and he feels it would be foolish to pave, move the shed and then have to go back and patch later.

Consensus of Council was to have the gentlemen meet with the City Manager to follow up on the offer by the City to provide the labor regarding the fence, so long as the gentlemen are willing to commit the materials on behalf of their respective Associations.

Dee Connell, President of the Railway Historical Society, appeared before Council to request a proclamation declaring November 22, 1982, as Rio Grande Railway Centennial Day in Grand Junction.

REQUEST TO USE STOCKER STADIUM FOR NICKY CRUZ CRUSADE ON SUNDAY, OCTOBER 31, 1982, 3:00 - APPROVED

James Schaedler, 258 Fifth Street, Clifton, Colorado, appeared before Council to petition the use of Stocker Stadium on Sunday, October 31, 1982, at 3:00 p.m. for the Nicky Cruz Crusade should the weather permit, and provided the numbers of people appear that preliminary estimates indicate may come to Grand Junction for this Schaedler proposed that volunteers from his event. Mr. organization work under the Parks and Recreation supervision after the football game on Saturday night and the Crusade Sunday evening to clean up the Stadium. According to Mr. Schaedler, the Nicky Cruz Crusade is a joint effort among thirty-two evangelical churches in the Grand Junction area.

The City Manager advised Council that he has had many requests for the use of stocker Stadium and that in order to be fair to them all, he has had to say "no" until Council can develop its guidelines and policies for the use of the Stadium.

Upon motion by Councilman Holmes, seconded by Councilman Dunn and carried by roll call vote with Council members CLARK and BRACH voting NO, Stocker Stadium was made available for the Nicky Cruz Crusade on Sunday, October 31, 1982, at 3:00 p.m. should it be necessary to move the Crusade to that location, in keeping with the remarks by Mr. Schaedler regarding maintenance, security and cooperation with the authorities that are affected. Mr. Schaedler was to work out arrangements with the City Manager and Staff.

There were no opponents, letters, or counterpetitions. The applicant presented a petition bearing the signatures of 950 persons in favor of the issuance of the license.
- 3. No one appeared at the hearing in opposition to the granting of the license and no petitions or letters of disapproval were received by the City Council.
- 4. The characters of the applicants are good as determined by checking done by the Police Department and by letters attesting to their good characters, the applicants being the officers of the corporation making application.
- 5. The evidence supports the position that the license should be granted.

A public hearing having been held on October 6, 1982, on the application by Paul W. Grindle, Bruce E. Troy and Dale A. Troy for a beer-wine license for The Eggschange at 2829 North Avenue, evidence adduced at said hearing, FINDS:

- 1. That the hearing was held on October 6, 1982, on the application after proper notice thereof under the Liquor Code.
- 2. The evidence concerning the needs of the neighborhood was presented through the survey of the City conducted in the area bounded by 28 Road on the west, Elm Avenue on the north, 28-1/2 Road on the east and Gunnison Avenue on the south, and by the applicants through petitions bearing the signatures of about 331 persons, most living outside the neighborhood, requesting the approval of the license.
- 3. The City survey, in total, found 120 favoring the issuance of the license with 92 being opposed. A further breakdown of the survey results indicate that of the inhabitants responding, 38 opposed the issuance while 28 favored it. Of the owners of property in the neighborhood, 49 opposed the issuance of the license, while 37 favored it.
- 4. The Council is mindful of the requirement that it determine the issuance of licenses on the basis of the evidence as to the desires of the inhabitants and the needs of the neighborhood, is aware that where, as here, there is no other similar outlet within a neighborhood and there is support for the issuance of a license the license must issue, and that Hotel and Restaurant licenses may be considered as similar licenses when a Beer-Wine license is being considered.
- 5. While recognizing that the evidence is somewhat equivocal, as it often is, the Council believes that the license should issue; the desires of the limited number of the inhabitants responding to the survey being close in division, the same being true of owners of property in the area, with a rather large expression of need for the outlet apparent in the total survey result when combined with the expression of the petitions offered by the applicants. Added to this is the type of outlet proposed, an outlet of

probable limited impact on the neighborhood because of location and clientele.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

- 4. The character of the applicant is good as determined by checking done by the Police Department and by letters attesting to his good character.

BIDS - AWARD OF CONTRACT - WATERLINE EXTENSIONS, 1982, PIONEER CONSTRUCTION, INC. \$67,121.46 WITH AUTHORIZATION FOR CHANGE ORDERS DELETING TWO EXTENSIONS ON I-70 B RESULTING IN CONTRACT PRICE OF \$51,613.46

Bids were opened at 2 p.m. October 19, 1982, for Waterline Extensions, 1982. Bidders were:

R. L. Atkins Construction, Inc. \$77,852.78 Parkerson Construction, Inc. \$72,838.00 Pioneer Construction, Inc. \$67,121.46 Engineer's Estimate \$53,319.00

Funds budgeted for this work amount to \$53,951.66. Administration recommended award of the contract to Pioneer Construction, Inc. for its bid of \$67,121.46 with change orders deleting two extensions on I-70 B resulting in a contract price of \$51,613.46. The change orders have been discussed with Pioneer Construction,

and they have raised no objections to the deletions.

Upon motion by Councilman Johnson, seconded by Councilman Holmes and carried, the bids were accepted and the contract for Water Line Extensions, 1982, was awarded to Pioneer Construction, Inc. in the amount of \$67,121.46 and authorized the Staff to effect the change orders deleting the two extensions on I-70 B resulting in a contract price of \$51,613.46.

HEARING - SINGH SUBDIVISION OUTLINE DEVELOPMENT PLAN FOR PROPERTY NE OF 27-3/4 LINE AND G ROAD LINE

A hearing was held after proper notice on the petition by Laimani Singh for approval of his outline development plan of 48 lots on approximately 13.4 acres in a residential single family zone at 4 units per acre located northeast of 27-3/4 line and G Road Line. Karl Metzner, City Planner, reviewed the plan. He indicated the Planning Commission recommended denial on the basis of inadequate accesses to the project. The unimproved status of G Road at this time; traffic problems; non-existent irrigation water; noise and air pollution; safety factor due to the nearness of Runway 422; and the fact that it is not a good use of the property overall. Mr. Metzner pointed out, however, that the zone is appropriate for the use of the land.

Katie McIntire, Paragon Engineering, was present for the petitioner. She proposed an improvement district where the Singh property would take over on a per unit basis some of the liability for the street. Rich Livingston, attorney for Mr. Singh, was present. He reviewed previous petitions by Mr. Singh for development of this property. During the last two years there has been some negotiation by the City, the County, the Airport Authority, and Mr. Singh but that nothing concrete has developed. He requested Council's favorable consideration of Mr. Singh's petition.

There were no opponents, letters, or counterpetitions.

Upon motion by Councilman Holmes, seconded by Councilman Johnson and carried, the outline development plan for Singh Subdivision was approved with the stipulations with regard to Planning Commission's recommendations on street improvements, etc., being kept in mind before any future consideration being given to the final development of this property.

Mr. Livingston clarified that as they understand the stipulation, the main point of access is going to be G Road. When they get to the preliminary and final stages, they will propose something along the lines of what the Planning Department has outlined in the orange: improving G Road into the property but stopping down by the parcel owned by the third party on the south end. The development of that access on to the south would occur at some point on in the future when that property reaches a point of development.

That the boundaries of the election districts within the City of Grand Junction be changed so that:

DISTRICT A: shall contain and include all that portion of the City of Grand Junction described as follows:

Beginning at the center of the intersection of North Twelfth Street and Grand Avenue; thence south to the City limit line north of the Colorado River; thence west along City limit line to intersection with North/South City limits line; thence south to the south bank of the Colorado River; thence easterly along the south bank of Colorado River to the northeast corner of Reservation Subdivision, thence south to Unaweep Avenue; thence following the City limits line to a point on the west City limits which point is the intersection of said City limits line and centerline Grand Avenue projected westerly; thence east along said projected centerline Grand Avenue to the center of the intersection of Grand Avenue and North Twelfth Street.

DISTRICT B: shall contain and include all that portion of the City of Grand Junction lying north of Grand Avenue and west of the following described line:

Beginning at the center of the intersection of North Seventh Street and Grand Avenue; thence north to the center of the intersection of North Seventh Street and Gunnison Avenue; thence east to the center of the intersection of North Eighth Street and North Avenue; thence west to the intersection of North Avenue and North Seventh Street; thence north along centerline of North Seventh Street to the north City limits line.

DISTRICT C: shall contain and include all that portion of the City of Grand Junction lying east and south of the following described line:

Beginning at the center of the intersection of Elm Avenue and Cannell; thence north to the center of the intersection of Cannell and Orchard Avenue; thence east to the center of the intersection of Orchard Avenue and Twenty-Eight and One-Quarter Road; thence north along centerline Twenty-Eight and One-Quarter Road to centerline Patterson Road; thence easterly along the City limit line to Twenty-Nine Road; and shall contain and include all that portion of the City of Grand Junction lying north of the following described line:

Beginning at the center of the intersection of Cannell and Elm Avenue; thence east to the center of the intersection of Elm Avenue and North Twelfth Street; thence south to the center of the intersection of North Twelfth Street and North Avenue; thence east to the center of the intersection of North Avenue; thence east to the center of the intersection of North Avenue and Twenty-Eight and One-Quarter Road; thence north to the center of the intersection of Twenty-Eight and One-Quarter Road and Elm Avenue; thence east to the center of the intersection of Elm Avenue and Twenty-Eight and Three-Quarter Road thence south to the center of the intersection of Twenty-Eight and Three-Quarter Road and North Avenue; thence east to the east City limit line.

Beginning at the center of the intersection of North Seventh Street and Kennedy Avenue; thence north along the centerline of North Seventh Street to the intersection of North Seventh Street and Horizon Drive; thence east and north to the north City limit line and north and west of the following described line:

Beginning at the center of the intersection of North Seventh Street and Kennedy Avenue; thence east to the center of the intersection of Kennedy Avenue and Cannell; thence north to the center of the intersection of Cannell and Orchard Avenue; thence east to the intersection of Orchard Avenue and Twenty-Eight and One-Quarter Road; thence north to the center of the intersection of Twenty-Eight and One-Quarter Road and Patterson Road; thence west and north along the City limit line to the north City limits.

DISTRICT E: shall contain and include all that portion of the City

of Grand Junction lying south and east of the following described lines:

Beginning at the center of the intersection of North Seventh Street and Kennedy Avenue; thence east to the center of the intersection of Kennedy Avenue and Cannell; thence north to the center of the intersection of Cannell and Elm Avenue; thence east to the center of the intersection of Elm Avenue and North Twelfth Street; thence south to the center of the intersection of North Twelfth Street and North Avenue; thence east to the center of the intersection of North Avenue and Twenty-Eight and One-Quarter Road; thence north to the center of the intersection of Twenty-Eight and One-Quarter Road and Elm Avenue; thence east to the center of the intersection of Twenty-Eight and Three-Quarter Road; thence south to the center of the intersection of Twenty-Eight and Three-Quarter Road and North Avenue; thence east to the City limit line; and

PROTESTING OIL AND GAS SEVERANCE TAX PAYMENT REPORTING DATA.

WHEREAS, the State Department of Revenue has certified report data utilized for the distribution to cities and counties for Oil and Gas Severance Tax payments; and

WHEREAS, C.R.S. 39-29-110(1)(d) requires that employees of oil and gas companies to be counted for such reports must be employed full-time in the extraction of oil and gas at the point of first sale; and

WHEREAS, reports from several companies appear to have been inconsistent with this requirement; and

WHEREAS, the inconsistent reporting data may have significantly reduced payments to this jurisdiction and to other cities and counties in this region;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That the reporting data utilized by the Department of Revenue to determine Oil and Gas Severance Tax Payments is hereby protested; and

BE IT FURTHER RESOLVED that the City Council hereby requests that reporting companies be requested to amend their reports to include only those full-time employees involved with extraction of oil and gas at the point of first sale.
