- 4. The characters of those involved in the application are good as determined by checking done by the Police Department and by letters attesting to their good characters.
- 5. The evidence supports the position that the license should issue both under the Liquor Code and the previous practice of the City Council.

HEARING - URBAN DEVELOPMENT ACTION GRANT PROGRAM APPLICATION - APPROVED AND MAYOR AUTHORIZED TO SIGN APPLICATION - DDA PROGRAM

Skip Grkovic, Director of the Downtown Development Authority, reviewed the Urban Development Action Grant Program and the proposed application by DDA for a grant under the program. There were no opponents, letters or counterpetitions. Upon motion by Councilman Johnson, seconded by Councilwoman Kreissler and carried, the application was approved for Urban Development Action Grant and the Mayor was authorized to sign the application.

HEARING - REZONE FROM PR-8 TO PR-13.1 AND HOUSTON HEIGHTS SUBDIVISION FINAL PLAT AND PLAN FOR THE NE CORNER OF 15TH STREET AND WELLINGTON AVENUE - RESOLUTION OF FINDINGS AND DECISION SCHEDULED DECEMBER 1, 1982

A hearing was held after proper notice on the petition by Ken Shrum, Colex, ltd., for rezone from PR-8 to PR-13.1 and Houston Heights Subdivision final plat and plan for the northeast corner of 15th Street and Wellington Avenue. The request is to change from planned residential uses at 8 units per acre to planned residential uses at 13.1 units per acre and a final plat and plan of 40 units on approximately 3 acres. The Planning Commission recommended denial because of neighborhood concerns and the 15th Street and Wellington Avenue improvements.

Bob Goldin, Planner, reviewed the proposal. Mr. Goldin advised that the Planning Commission recommended approval of the rezone,

but recommended denial of the final plat and plan pending the outcome of 15th Street improvements.

Sam Haupt was present representing Colex, Ltd. He explained that the Planning Commission's concern was the bridge across the Grand Valley Canal. He submitted letters from adjacent property owners who have greed to petition to go into an improvement district for 15th Street.

Comments were had from: Claudia McKinley, 1308 Wellington, Dave McKinley, 1308 Wellington, Maybelle Kanavel, 1313 Wellington, and Leona Kochivar, 1238 Wellington. Mr. McKinley indicated that Council should overturn the Planning Commission's recommendation for the rezone, but uphold its recommendation regarding the plat and plan.

A Resolution of Decision is scheduled on the December 1, 1982, City Council agenda.

RESOLUTION NO.89-82 CONCERNING ANTI-TRUST LIABILITY - APPROVED

The following Resolution was read:

RESOLUTION NO. 89-82

CONCERNING ANTI-TRUST LEGISLATION

WHEREAS, the exposure of municipalities in Colorado and throughout the country to Federal antitrust lawsuits has been greatly expanded as a result of recent decisions of the United States Supreme Court; and

WHEREAS, the potential for treble damage awards and the substantial expense of defending antitrust litigation, even if successful in the defense, may inhibit municipalities from enacting or enforcing regulations which are intended to protect the public health, safety and welfare, but which also may serve to restrict competition; and

WHEREAS, at least four Colorado municipalities already have been sued under the Federal antitrust laws for various regulatory activities, with claimed damages, when trebled, exceeding \$235,000,000; and

WHEREAS, the cost to the taxpayers of one Colorado municipality in defending one of these lawsuits, which was settled prior to trial, exceeded \$250,000; and

WHEREAS, municipalities differ from private enterprise in that private enterprise is not charged with protecting the public health, safety and welfare; and

WHEREAS, numerous protections from municipal regulations, other than treble damages under the Federal antitrust laws, are available, such as public notice, public hearing, public meeting and public record requirements, court review of actions, periodic elections and the rights of initiative, referendum and recall, and the continuing authority of the state General Assembly or the people of Colorado to modify the statutory and constitutional authority of Colorado's municipalities; and

WHEREAS, state legislation does not provide any certain solution to the problem and years of litigation will be necessary to decide whether any state legislation meets the test established by the United States Supreme Court for local government antitrust immunity; and

WHEREAS, Federal legislation can address the problem directly by seeking a specific exemption from the Federal antitrust laws for local governments and all or some of their activities; and

WHEREAS, Federal legislation could eliminate damages from the antitrust remedies available against local governments and their taxpayers; and

WHEREAS, local governments should not be imperiled when engaging in traditional local-government regulatory activities such as zoning, enacting and enforcing building and fire codes, regulating the sue of public rights-of-way, licensing, franchising and the myriad of other regulatory activities traditionally engaged in by local governments;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That the Congress of the United States be urged to act as quickly as possible to provide appropriate exemptions for municipalities from Federal antitrust liability.

AIM

Councilwoman Kreissler attending a meeting of AIM. The Committee discussed the update on the request for the Energy Impact Funds for the pedestrian walkways. The information should be available Thursday or Friday as to whether they will receive the funds.

They discussed a coordination effort on park land acquisition and development with various municipal representatives from Mesa County.

A decision was made to pursue a grant from the Attorney General of Colorado Public Health Fund for \$10,000. The funds are designated for a drug and alcohol abuse education program, and these funds are designated to go to the Police Department Liaison School with the schools.

Councilwoman Kreissler reported that the Recreation Board received an update on the Orchard Mesa Pool. Discussed the possible addition of a solar assist package and a possible solarium. The Board favors both items.

Discussed the status of the proposed Recreation Center.

Discussed the various recreation programs currently in progress.
