LIQUOR-BEER APPLICATIONS APPROVED FOR RENEWAL OF LICENSES

A hearing was held after proper notice on the petition by Gerald Greenberg for George Harper for a conditional use to permit a hotel-restaurant liquor license at Casa di Italia, 1048 Independent Avenue, Suite A-101. There were no opponents, letters, or counterpetitions. Upon motion by Councilman Dunn, seconded by Councilwoman Clark and carried with Councilman HOLMES voting NO, the petition for conditional use was approved.

A public hearing having been held on December 15, 1982, on the

application by George R. Harper for a hotel-restaurant liquor license for Casa di Italia at 1048 Independent Avenue, Suite A-101, Grand Junction, and the City Council have considered the evidence adduced at said hearing, FINDS:

- 1. The hearing was held on December 15, 1982, on the application after proper notice thereof under the Liquor Code.
- 2. The survey conducted by the City indicated that the needs of the neighborhood were not being met by other outlets within the neighborhood and there was a need for this outlet in that 268 persons so stated while 58 felt the needs were being met by the other outlets. In addition, a petition favoring the issuance of the license and bearing 336 signatures was entered by the applicant.
- 3. No one appeared at the hearing in opposition to the granting of the license and no petitions or letters of disapproval were received by the City Council.
- 4. The character of the applicant is good as determined by checking done by the Police Department and by letters attesting to his good character.
- 5. That the evidence supports the position that the license should issue both under the Liquor Code and the previous practice of the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That a Hotel-Restaurant Liquor License issue to George R. Harper for Casa di Italia located at 1048 Independent Avenue, Suite A-101, Grand Junction, Colorado.

HEARING - APPLICATION BY THE MANHATTAN DELICATESSEN, INC., FOR A 3.2% BEER LICENSE (PACKAGE CARRYOUT) AT 2889 NORTH AVE. UNIT NO. 3 - RESOLUTION OF FINDINGS AND DECISION SCHEDULED JANUARY 19

A hearing was held after proper notice on the application by The Manhattan Delicatessen, Inc., for a 3.2% beer license which permits the sales in sealed containers for consumption off the premises of the licensee at 2889 North Avenue, Unit No. 3. The following report was read:

"On December 1, 1982, the application by The Manhattan Delicatessen, Inc., for a 3.2% beer license at 2889 North Avenue, Unit #3, was accepted. Corporate officers are:

The display ad giving notice of hearings was published in The Daily Sentinel December 24, 1982, and the sign giving notice of hearing was posted on the property December 24, 1982.

A survey of the area from 28-3/4 Road on the west, Bunting Avenue on the north, through 2909 North Avenue on the east, to Hill Avenue, if extended, on the south has been completed. Results:

- a. An owner of property in the neighborhood. 12
- b. An employee or business lessee of property in the neighborhood.
- c. An inhabitant of the neighborhood. 6

A letter was filed by Mrs. George Fults opposing the granting of a license. There have been no petitions, letters, or counterpetitions filed.

The Mesa County Health Department and the Fire Department have seen the construction plans, and they have no problems so long as all aspects of the construction plans are followed. The Police Department advises that the background investigations of Walter R. and Walter C. Thoms (father and son respectively) revealed nothing of a derogatory nature.

Similar-type outlets within one mile: 3."

The map showing similar-type outlets was reviewed.

Mr. Walter R. Thoms was present for the hearing. There were no opponents, letters, or counterpetitions.

RESOLUTION NO. 2-83 CORRECTING RESOLUTION NO. 96-82 - BOISE CASCADE ANNEXATION - ORDINANCE NO. 2099

The following Resolution was read:

WHEREAS, on the 15th day of December, 1982, a petition was submitted to the City Council of the City of Grand Junction, Colorado, for annexation to said City of the following property situate in Mesa County, Colorado, and described as:

Beginning S 89 deg. 33 min. W 722.5 ft from the SE Cor of the NE 4 of the NW4 of Section 9, T1S, R1W, Ute Meridian, thence along the arc of a curve left radius 5660 ft distance of 134.8 ft chord bears N 66 min. 41 sec. W 134.8 ft, thence N 67 deg. 32 min. 30 sec. W 501.8 ft, thence along the arc of a curve right radius 5800 ft for a distance of 545.6 ft chord bears N 64 min. 41 sec. W 545.4 ft, thence S 14.9 ft to the N right-of-way of denver & Rio Grande Western Railroad, thence S 56 min. 34 sec. E along the railroad right-of-way 848.8 ft, thence N 89 deg. 33 min. E 371.7 ft more or less to beginning.

ALSO Beginning at a point on the S right-of-way line of Highway 6 & 50 which point lies S 00 deg. 05 min. W 341.96 ft and W 25 ft from the NE Cor of the SE 4 of th NE Cor of the SE4 of the NW4 of Section 9, T1S, R1W, Ute Meridian, thence S 00 deg. 05 min. W 344.33 ft, thence N. 56 deg. 34 min. WHEREAS, the Council has found and determined and does hereby find and determine that said petition is in substantial compliance with statutory requirements therefor; that one-sixth of the perimeter of the area proposed to be annexed is contiguous with the City; that a community of interest exists between the territory and the City; that the territory proposed to be annexed is urban or will be urbanized in the near future; that the said territory is integrated or is capable of being integrated with said City, and that no election is required under the Municipal Annexation Act of

1965 as the owner of one hundred percent of the property has petitioned for annexation;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

- 1. That the said territory is eligible for annexation to the City of Grand Junction, Colorado, and should be so annexed by Ordinance.
- 2. That this Resolution is made to correct Resolution No. 96-82 passed and adopted December 15, 1982, which did not include the complete description.

LIQUOR - TAVERN LIQUOR LICENSE SUSPENDED 1 DAY - LA BARRA FAMOSA DEL CHARRO, 227 ROOD AVENUE

The recommendation by Liquor/Beer Hearing Officer Dave Palmer on the matter of Michelle Garcia and her tavern liquor license at La Barra Famosa del Charro, 227 Rood Avenue, for a violation of Section 24-5-101 C.R.S. 1973, was to suspend the license for a period of five days with four days of the five days' suspension being suspended because of the licensee's long history as a productive and law-abiding citizen of the community. Mrs. Garcia and her attorney, Robert Traylor, were present.

It was moved by Councilman Johnson, seconded by Councilwoman Kreissler, that the findings of the Hearing Officer be accepted

and that the license held by Michelle Garcia at La Barra Famosa del Charro be suspended for five days with four days of that suspension being suspended through the renewal of the license and that the one-day suspension commence Thursday morning, January 6, 1983.

Councilman Dunn felt that suspending four days of the five-day suspension was being a little lenient. He moved to amend the motion to impose a three-day suspension with two days being withheld. Councilman Holmes seconded the motion. Council members voting AYE: DUNN, HOLMES. Council members voting NO: JOHNSON, CLARK, LUCERO, KREISSLER, BRACH. The President declared the amendment lost.

Council members voting AYE on the main motion: CLARK, JOHNSON, LUCERO, KREISSLER, BRACH. Council members voting NO: DUNN, HOLMES. The President declared the motion carried.

## CML

The City Manager announced a program by the CML for the Legislative Conference on February 3 at 9 a.m. in downtown Denver. He encouraged Council members to make arrangements with him to attend the conference.

#### DDA

Councilman Johnson reported that the DDA Board met the morning of January 5, 1983, at which time it was announced that Gloria Ferns will be leaving her position. He indicated that the staff is now advertising and recruiting to fill the position. The Board considered the proposed action taken by a Committee and by the Planning Commission related to zoning and redevelopment regulations in the downtown planning area. Also, it authorized the Director to enter into a contract with the Colorado Department of Local Affairs for a \$25,000 impact assistance grant. The Board also authorized entering into a contract with Laventhol and Horwath to finish up the hotel feasibility study for the downtown area.

## MESA COUNTY ENERGY IMPACT ASSISTANCE PROGRAM

Councilwoman Kreissler attended the meeting of the Mesa County Energy Impact Assistance Program hearing request for funds. The Youth Detention facility was prioritized number one. The requested amount was \$120,000.
