Grand Junction, Colorado

March 16, 1983

The City Council of the City of Grand Junction, Colorado, convened in regular session the 16th day of March, 1983, at 7:30 p.m. in the Council Chambers at City Hall. Those present were Council members Betsy Clark, Frank Dunn, Robert Holmes, Karl Johnson, Christine Kreissler, and Gary Lucero. President of the Council Louis Brach was absent. Also present were City Attorney/Acting City Manager Gerald Ashby and City Clerk Neva Lockhart.

The President of the Council Pro Tem Frank Dunn called the meeting to order and led in the Pledge of Allegiance.

INVOCATION

Reverend Robert McClung, Manager of the IBC Book Store.

MINUTES

Upon motion by Councilman Johnson, seconded by Councilman Lucero and carried with Councilman HOLMES voting NO, the applications by the following businesses to renew liquor and beer licenses were approved:

HEARING - APPLICATION BY WESTERN COUNTRY SPRING, INC., DBA SWISS COLONY, MESA MALL, UNIT #090, 2424 HIGHWAY 6 AND 50, FOR 3.2% BEER LICENSE, PACKAGE CARRYOUT

A hearing was held after proper notice on the application by Western Country Spring, Inc., doing business as Swiss Colony at Mesa Mall Unit #090, 2424 Highway 6 & 50, for a 3.2% beer license which permits sales in sealed containers for consumption off the premises of the licensee. The following report was read:

On March 15, 1983, the applicant filed a petition with 157 signatures favoring the granting of the license.

The background investigation of the corporate officers by the Police Department revealed nothing of a derogatory nature.

The map showing similar-type outlets was reviewed. Eddie Davis, President of Western Country Spring, Inc., was present to speak for the granting of the license. HEARING #9-83 - NORTHSTAR SUBDIVISION PRELIMINARY PLAT FOR THE NE CORNER OF 28 ROAD AND WALNUT AVENUE APPROVED WITH STIPULATIONS BY PLANNING COMMISSION

A hearing was held after proper notice on the Northstar Subdivision Preliminary Plat of 20 units on 2.7 acres in a residential single-family zone at 8 units per acre for the northeast corner of 28 Road and Walnut Avenue. Mary Ann Carlson of the Planning Staff reviewed the proposal. Katie McIntyre, Paragon Engineering, was present representing the petitioners Valley Venture - Richard Schubert and Larry Mattison.

Comments were had from: Doug Sawtelle, 2806 Walnut Avenue; June

Hall, 575 Court Road; Janus Leonardi, 566 28 Road, and Mr. Aaeng, 565 28 Road.

Most of the concerns of the neighbors were addressed. Upon motion by Councilman Holmes, seconded by Councilwoman Kreissler and carried, the Northstar Subdivision Preliminary Plat was approved with the stipulations by the Planning Commission.

HEARING #8-83 - RIGHT-OF-WAY VACATION, 28 ROAD FROM GRAND VALLEY CANAL TO APPROXIMATELY 400 FEET S OF BOOKCLIFF AVENUE - PROPOSED ORDINANCE - (NORTHSTAR SUBDIVISION PRELIMINARY PLAT)

A hearing was held after proper notice on the petition by Valley Ventures: Robert Schubert and Larry Mattison and an adjacent property owner, Gary Ulibarri, to vacate a portion of 28 Road, sections east and west of 28 Road from the Grand Valley Canal to approximately 400 feet south of Bookcliff Avenue. There were no opponents, letters, or counterpetitions.

The following entitled proposed ordinance was read: AN ORDINANCE VACATING A RIGHT-OF-WAY IN THE CITY. Upon motion by Councilman Holmes, seconded by Councilwoman Clark and carried, the proposed ordinance was passed for publication.

HEARING #50-81 - (GRAND) HILTON HOTEL AND OFFICE COMPLEX, NW CORNER OF I-70 AND HORIZON DRIVE - SCHEDULE FOR OFFICE COMPLEX EXTENDED FOR ONE YEAR

Anthony Verhaart, representing the Hilton Hotel and office complex, appeared before Council to request a one-year extension of the schedule for the office complex, northwest corner of I-70 and Horizon Drive. Upon motion by Councilman Lucero, seconded by Councilwoman Kreissler and carried, the schedule for the office complex was extended for one year.

PROPOSED ORDINANCE - ZONE CHANGE FROM PR-12.4 TO RSF-8 THE NE CORNER OF 28-3/4 ROAD AND ELM AVENUE

Upon motion by Councilwoman Clark, seconded by Councilwoman Kreissler and carried, the proposed ordinance was passed for publication.

The President Pro-Tem declared a five-minute recess. Upon reconvening, six members of Council were present.

Upon motion by Councilman Lucero, seconded by Councilwoman Clark and carried, the proposed ordinance was called up for final passage and the title only was read: AN ORDINANCE RELATING TO THE REGULATION OF CONSTRUCTION, ALTERATION, MOVING, DEMOLITION, REPAIR AND USE OF ANY BUILDING OR STRUCTURE WITHIN THE CITY OF GRAND JUNCTION, COLORADO; ADOPTING BY REFERENCE THERETO THE UNIFORM BUILDING CODE OF THE INTERNATIONAL CONFERENCE OF BUILDING OFFICIALS, 1982 EDITION, TOGETHER WITH THE APPENDIX THERETO, WITH CERTAIN AMENDMENTS THERETO, AND TOGETHER WITH THE UNIFORM BUILDING CODE STANDARDS, 1982 EDITION, OF THE INTERNATIONAL CONFERENCE OF BUILDING OFFICIALS; PROVIDING FOR THE ISSUANCE OF PERMITS AND COLLECTION OF FEES THEREFOR; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH.

Battalion Chief Wes Painter stated that this Code does address the parking of tankers in residential or other neighborhoods where they would present a definite hazard. Councilwoman Kreissler attended a recent meeting of the Airport Area Business Association was excellent; a good discussion of what is happening on Horizon Drive and how it will affect the businesses and the general timing.

# LODGING TAX

Councilman Dunn reported that he has been visiting with the motel owners during the past week, and relations have never been more cordial. He read a letter from Mrs. Harrison, President of the Mesa County Motel Association. The Association would like an opportunity to submit an alternative proposal to the one presently under consideration.

Councilman Lucero reported for the Lodging Tax Committee: The makeup of the Committee will consist of seven people - one Council member; one Chamber of Commerce representative, a representative from the Motel Association with 100 rooms or more; a representative from the Motel Association with 99 rooms or less; a travel agency representative; representative from an add agency; and a public relations representative.

It was recommended that the Committee have control of the funds. At a future meeting of the Committee, they will discuss collection and distribution of the funds.
