Grand Junction, Colorado

July 20, 1983

The City Council of the City of Grand Junction, Colorado, convened in regular session the 20th day of July, 1983, at 7:30 p.m. in the City Council Chambers at City Hall. Those present were Frank Dunn, Robert Holmes, Mike Pacheco, Ray Phipps, and President of the Council Pro Tempore Betsy Clark. Councilwoman Christine Kreissler and Mayor Gary Lucero were absent. Also present were City Manager Jim Wysocki, City Attorney Gerald Ashby, and Deputy City Clerk Teddy Martinez.

President of the Council Pro Tempore Clark called the meeting to order and led in the Pledge of Allegiance.

INVOCATION

Councilman Robert Holmes.

MINUTES

Upon motion by Councilman Phipps, seconded by Councilman Pacheco and carried, the minutes of July 6, 1983, were approved as submitted.

ROOD AVENUE PARADE PERMIT FOR 6TH ANNUAL COLORADO WEST MARCHING BAND FESTIVAL

Mr. Dick Brickley, Music Supervisor for School District #51, appeared before Council to request rerouting from Main Street to Rood Avenue for the 6th Annual Colorado West Marching Band Festival Parade to be held this Fall. Mr. Brickley stated that during the marching competition some bands may march 10 abreast which is very difficult on narrow streets such as Main, from 1st to 7th Streets. It also makes it very difficult to judge the individual band members under such conditions. The following route was suggested: East on Rood Avenue, from 1st to 7th Street, south on 7th Street to Main Street, east on Main Street, from 7th Street to 12th Street. Council will consider the request and have an answer by the August 3 Council meeting.

LIQUOR LICENSE RENEWALS APPROVED

This is a change of ownership affecting Williams Market and Delicatessen presently owned by DOS, Inc.

HEARING - PROPOSED ORDINANCE - RIGHT-OF-WAY AND ALLEY VACATION, 11TH STREET RIGHT-OF-WAY AND ALLEY BETWEEN ORCHARD AVENUE AND WALNUT AVENUE AND COLLEGE PLACE AND 11TH STREET

A hearing was held after proper notice on the petition by Lincoln Park Osteopathic Hospital and Doctors Clinic Building, Inc., Roger C. Zumwalt, for right-of-way and alley vacation 11th Street right-of-way and alley between Orchard Avenue and Walnut Avenue and College Place and 11th Street. There were no opponents, letters, or counterpetitions. Upon motion by Councilman Dunn, seconded by Councilman Phipps and carried, the right-of-way and alley vacation was approved.

The following entitled proposed ordinance was read: AN ORDINANCE VACATING A RIGHT-OF-WAY AND AN ALLEY IN THE CITY OF GRAND JUNCTION. Upon motion by Councilman Dunn, seconded by Councilman Pacheco and carried, the proposed ordinance was passed for publication.

HEARING - PROPOSED ORDINANCE - UTILITY EASEMENT VACATION WITHIN BRIARGATE SUBDIVISION, SW CORNER OF ELM AVENUE AND 28-1/4 ROAD

A hearing was held after proper notice on the petition by Benchmark Communities, Ltd., Michael B. Cline, for a utility easement vacation within Briargate Subdivision, southwest corner of Elm Avenue and 28-1/4 Road. This is a request to vacate one 22.5 foot by 35.21 foot portion and one 22.5 foot by 35.20 foot portion of utility easement. There were no opponents, letters, or counterpetitions. Upon motion by Councilman Dunn, seconded by Councilman Phipps and carried, the utility easement vacation was approved.

HEARING - CONDITIONAL USE - ADDITION OF SANCTUARY TO FIRST CHRISTIAN CHURCH, 1326 N. 1ST STREET

A hearing was held after proper notice on the petition by First Christian Church of Grand Junction, Tracey Miller, for a conditional use to add a sanctuary to First Christian Church, 1326 N. 1st Street, northeast of 1st Street and West Sherwood Drive, on 1.81 acres in a residential single-family zone at 5 units per acre. There were no opponents, letters or counterpetitions. Upon motion by Councilman Dunn, seconded by Councilman Phipps and

carried, the conditional use for First Christian Church was approved.

HEARING - PROPOSED ORDINANCE - ZONING SIMPSON ANNEXATION RSF-4, W OF 25-1/2 ROAD, S OF PATTERSON ROAD

A hearing was held after proper notice to zone Simpson Annexation RSF-4, 25-1/2 Road, south of Patterson Road. There were no opponents, letters, or counterpetitions.

A hearing was held after proper notice to zone Southgate Annexation PR-15 and PR-18. There were no opponents, letters, or counterpetitions.

Upon motion by Councilman Pacheco, seconded by Councilman Dunn and carried with Councilman HOLMES voting NO, the proposed ordinance was passed for publication.

HEARING - PROPOSED ORDINANCE - ZONING BOISE CASCADE ANNEXATION AND D & RGW RR ANNEXATION C-1, S OF HIGHWAY 6 & 50, E OF 24-1/2 ROAD

A hearing was held after proper notice to zone Boise Cascade Annexation and D & RGW RR Annexation C-1. There were no opponents, letters, or counterpetitions.

The following entitled proposed ordinance was read: AN ORDINANCE AMENDING THE ZONING MAP, A PART OF CHAPTER 32 OF THE CODE OF ORDINANCES OF THE CITY OF GRAND JUNCTION, BY ADDING THE ZONING OF CERTAIN LANDS WITHIN THE CITY. Upon motion by Councilman Holmes, seconded by Councilman Pacheco and carried, the proposed ordinance was passed for publication.

HEARING - CONDITIONAL USE - KINDER HAUS CHILDREN'S CENTER, NE CORNER OF 27-3/8 ROAD AND C ROAD

A hearing was held after proper notice on the petition by Patricia Knight Felin for a conditional use for a child care center (Kinder Haus Children's Center) on .75 acre in a residential single-family zone at 8 units per acre, located on the northeast corner of 27-3/8 Road and C Road. Planner Janet Stephens reviewed the proposal. Petitioner Patricia Knight Felin, 502 River View, was present.

There were no opponents, letters or counterpetitions. Upon motion by Councilman Dunn, seconded by Councilman Holmes and carried, the conditional use for Kinder Haus Children's Center was approved.

HEARING - REZONE FROM RMF-64 TO PC, S OF WEST GUNNISON AVENUE AND SW OF HWY 6 & 50 - RESOLUTION OF DECISION SCHEDULED AUGUST 3, 1983

A hearing was held after proper notice on the petition by Gene O. Taylor to rezone from RMF-64 to PC, south of West Gunnison Avenue and southwest of Highway 6 & 50. This is a request to change from residential single-family uses at 8 units per acre to planned commercial use on .63 acre. Planner Janet Stephens reviewed the proposal. Petitioner Gene Taylor, 633 Fletcher Lane, was present and stated he plans to build an above-ground level lake for demonstrating water equipment and possible water-sport lessons. He is also planning a large storage area to the rear of the property. Mr. Marvin Maldonado, 527 W. Ouray, questioned the use of the alleyway. Mr. Taylor stated it will not be used as a major access, but it will be used for loading and unloading purposes. Virginia Trujillo, 323 W. Ouray, questioned whether the alley will be paved. If the alley is paved it will affect the drainage. The drainage will be addressed by the Planning Commission on July 26, 1983, and then come to the City Council on August 3, 1983, for a final decision.

AUDITOR'S REPORT AND ENGAGEMENT LETTER

Jeffrey Vogle, Audit Senior, of Fox and Company, reviewed the 1982 Audit Report for the City. Mr. Vogle indicated he was able to give the City a clean opinion with no exceptions. City Manager Wysocki stated that one exception should be put into the record as it relates to the joint sewer system. Mr. Vogle quoted: "Expenditures exceeded the budgeted amount which may be a violation of State Statutes." He referred to Page 10 of the Financial Statements which compares budget to actual. A general explanation of why expenditures are over budget is that many of the expenditures are for capital project items, and construction went along ahead of schedule and better than planned, which required more payments to the contractors over that period of time. The funds were in the City coffer, but the \$1.9 million was not appropriated by the City Council. A supplemental appropriation should have been made in November of '82' to include the additional capital outlays. Failure to make said appropriation was an oversight. City Attorney Ashby stated that the Budget Law says that expenditures cannot exceed appropriations.

Acceptance of the 1982 Audit and 1983 Engagement Letter for Fox & Company is scheduled for August 3, 1983.

WHEREAS, Paragraph 5d of FHPM 4-6-7 states the Federal Aid Urban

System shall consist of arterial routes and collector routes, exclusive of urban extensions of the Federal Aid Primary System, and

WHEREAS, Arterial and collector routes were designated in the 1990 Highway Functional Classification Study recently completed in cooperation with the Colorado Department of Highways and approved by the Federal Highway Administration; and

WHEREAS, Paragraph 6c(4) of FHPM 4-6-7 states the routes of the Federal Aid Urban System shall be designated by appropriate local officials with the concurrence of the Colorado Department of Highway;

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Grand Junction, and the Board of County Commissioners of Mesa County hereby approve the designation of the Federal Aid Urban System of Highways in said urban area, consisting of all arterial routes and collector routes exclusive of urban extensions of the Federal Aid Primary System.

City Manager Wysocki explained that the foregoing Resolution designates the Grand Junction Fire Department to act as the agency to deal with emergency hazardous waste situations or incidents

within the city limits.

CONTINUANCE OF PETITION BY LOUIE HYDE FOR REDUCED SPEED LIMIT ON 27-1/2 ROAD, N OF PATTERSON ROAD

Mr. Louie Hyde, 633 27-1/2 Road, appeared before Council on June 22, 1983, and again on July 20, 1983, requesting reduced speed of 25 miles per hour on 27-1/2 Road along with enforcement, street widening and/or walkway for pedestrians, bicyclists, and equestrians. A letter dated July 20, 1983, was submitted by Mr. Hyde requesting an answer as to what action has been taken regarding the petition. City Manager Wysocki stated he has asked the Traffic Engineer to look at the 35 mph speed; he has also had the Police Department do an accelerated, extensive enforcement in the area. Mr. Wysocki also stated the City is looking at the possibility of widening a portion of the shoulder of the road where it has been suggested that it might be more hazardous than other parts of the road.

It was suggested by Mr. Holmes that the area at least be noticeably posted 35 mph with strict enforcement by the Police Department. Apparently, 27-1/2 Road has no posted speed limit since it is a collector street with an automatic speed limit of 35 mph. Mr. Hyde was agreeable to this action. Mr. Wysocki was directed to have 27-1/2 Road posted at 35 mph.

PETITION TO MOVE UP DATE OF CONSTRUCTION OF ORCHARD AVENUE STORM DRAIN, CANNELL TO 12TH STREET

Rosemarie Townsend, 1381 E. 3rd Street, Delta, owner of a house at 940 Orchard Avenue in Grand Junction, requested that the construction date of a storm drain in her area be moved up sooner than November, 1983, with the concern that August or September rains would flood the properties in the area. Others speaking for the petition were: Mary and Lee Biesecker, 702 Ivy Place, Billie Lou George, 938 Orchard Avenue.

Mr. Wysocki was directed to check into moving up the time schedule for the project and reporting back to Council by August 3, 1983, meeting. Council will contact the neighborhood as to findings at that time.

ARCHITECTURAL AND ENGINEERING SELECTION PROCEDURE

Upon motion by Councilman Pacheco, seconded by Councilman Dunn and carried, the Architectural and Engineering Selection Procedure was approved and accepted. Others commenting on the subject procedure were: Chuck Renner, member of American Institute of Architects, Colorado West Chapter, Ron Rish, 2265 Kingston Road, representing Project Management Services; and Greg Robison, 950 White Avenue.

Mayor Pro Tempore Betsy Clark appointed Ray Phipps, Gary Lucero and Mike Pacheco to the Selection Committee for Local Business Person to serve on the Architectural and Engineering Selection

Committee.

MISCELLANEOUS DISCUSSION

Councilman Holmes discussed the policy of Two Rivers Plaza. He felt it is inappropriate for a facility such as Two Rivers to be used by businesses that would be in direct competition with established local businesses who are supporting the subsidy of Two Rivers through their tax dollars. City Attorney Ashby will reply to this concern at the next meeting of Council or the next Council workshop.

Mr. Holmes was concerned about the traffic situation on 5th Street while under construction. He felt that Police patrol of the area at crucial times of the day is needed badly, particularly where the southbound traffic is concerned. City Manager is to respond regarding this matter at the next Council workshop.

Mr. Holmes recommended that Mayor Lucero write letters encouraging the State Legislature to continue the Organized Crime Task Force. The continuance of the function is in question because of funding. Council was in agreement with Mr. Holmes, and encouraged its members to contact the local legislators regarding this concern.

Mr. Holmes commended the Fire Department paramedics on their actions and efficiency during a recent emergency situation at Mesa Mall during the past week.

Councilwoman Clark reported on the Energy Impact Committee meeting she attended during the week. Ms. Clark also attended a Tourism Commission meeting at the Chamber of Commerce building.

Councilman Pacheco reported on the AIM Committee meeting held earlier this month. He also reported on the PIAB Committee. The Committee received a report from the JUCO Tournament which resulted in the question of additional restroom facilities at Lincoln Park. Additional discussion regarding possible funding of these facilities will take place at the next Council workshop.

He commended the selection committee and Personnel Director Claudia Hazelhurst for work in regard to the hiring of a new Airport Manager. Mr. Dunn stated he is aware of all the problems concerning construction of the airport, and is working with the contractors and architects regarding these matters.

IDI (INDUSTRIAL DEVELOPMENTS, INC.) PARTICIPATION

Upon motion by Councilman Pacheco, seconded by Councilman Phipps and carried, the appropriation of \$12,500 for use by IDI in advertising the Grand Junction area for economic development was approved.
