1986 PARKS & RECREATION BOARD SERVICE AWARDS TO DR. RICHARD GILMORE AND ORCHARD MESA MIDDLE SCHOOL STAFF

Mr. Jack Kammerer, Chairman of the Parks and Recreation Advisory Board, presented service awards to Dr. Richard Gilmore and Orchard Mesa Middle school for their contributions to the Parks and Recreation programs.

HEARING - ID ST-86, PHASE B (MOUNTAIN VIEW COURT N OF CHEYENNE DR; 17TH ST S OF MAIN ST; AND B 3/4 ROAD E OF 27 RD

A hearing was held after proper notice on Improvement District ST-86, Phase B (Mountain View Court north of Cheyenne Drive; 17th Street south of Main Street; and B 3/4 Road east of 27 Road. NO. 30-86 - DECISION RE: CONDITIONAL USE FOR A CHURCH IN A RESIDENTIAL SINGLE-FAMILY (RSF-4) ZONE ON APPROX. 2.6 ACRES (BOOKCLIFF CHURCH OF CHRIST)

The following conditions of the Planning Commission regarding a petition by Bookcliff Church of Christ for a conditional use for a church in a residential single-family (RSF-4) zone on approximately 2.6 acres were read:

- 1. Full street improvements except sidewalk be completed for half the length of the church property;
- 2. Parking lot be constructed with a dust-free surface (not necessarily asphalt paving);
- 3. That the petitioners appear before Planning Commission at the time final development plans are complete and they are ready to commence with construction.

Upon motion by Councilman Nelson, seconded by Councilman Kirkhart and carried with Councilman RAGSDALE ABSTAINING, the conditional use for a church in a residential single-family (RSF-4) zone on approximately 2.6 acres was approved subject to the conditions of the Planning Commission, and is to be used as a church only, and that any other use require further Planning Commission and City

Council action.

Upon motion by Councilman McCurry, seconded by Councilman Nelson and carried, the proposed ordinance was passed for publication.

ORDINANCE NO. 2320 - SETTING THE SALARY OF THE CITY MANAGER

There were no comments. Upon motion by Councilman Theobold, seconded by Councilman Bennett and carried by roll call vote, the Ordinance was passed, adopted, numbered 2320, and ordered published.
