WHEREAS, the City Council believes that the conduct of the police officers in relation to the Cooks not only does not warrant punitive damages being awarded but the entire action is without merit;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That it is in the public interest to defend the police officers against a claim for punitive damages in the Cook action and pay any punitive damage award made against any of them.
