WHEREAS, C.D. Smith Company has petitioned the City Council of the City of Grand Junction, Colorado, for a Revocable Permit for location of a planter, sign and sod within the existing road right-of-way (see site plan attached) west of the real property described as:

Smith Company as recorded in Book 1571, Pages 84 and 85, in the Office of the Mesa County Clerk and Recorder, to wit: Beginning at a point on the N line of the right-of-way of the Rio Grande Junction Railway, 50 ft N of the center of the track where the same crosses the E line of 7th Street extended in the Grand Junction ????; thence 319 ft more or less to a point 30 ft N of the NW Cor of Lot 2 in Blk 5 of Milldale Subdivision; thence E 133 ft; thence S 88 ft; thence E 22 ft; thence S to the N line of said Railway right-of-way; thence Southwesterly to the point of beginning; and

WHEREAS, such action would not be detrimental to the inhabitants of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

That the City Manager, on behalf of the City and as the act of the City, be and he is hereby authorized to grant such Revocable Permit to the above-named petitioner for the purpose above described upon the execution by the petitioner of an agreement that he will save and hold the City harmless from any claims arising out of the encroachment and use granted, and that upon revocation of such permit, the petitioner will discontinue said encroachment and, at his own expense, restore the right-of-way to its original condition.

REVOCABLE PERMIT

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

There is hereby granted to the C.D. Smith Company a Revocable Permit to allow location of a planter, sign and sod in the road right-of-way in accordance with the attached site plan as described above; provided, however, that said permit may be revoked by the City Council at its pleasure at any time; provided, further that the above-named petitioner shall agree to indemnify the City and hold it harmless from any and all claims, damages, actions, costs and expenses of every kind in any manner arising out of, or resulting from the permitted use; and further provided that said petitioner shall agree that upon revocation of such permit, he will, at his own expense, remove said encroachment and restore the right-of-way to its original condition.
