The City Council of the City of Grand Junction, Colorado, convened in regular session the 15th day of July, 1987, at 7:30 p.m. in the City/County Auditorium at City Hall. Those present were John Bennett, R.T. Mantlo, Bill McCurry, Paul Nelson, and President of the Council O.F. Ragsdale. Council members LeRoy Kirkhart and Reford Theobold were absent. Also present were City Attorney Gerald Ashby, City Clerk Neva Lockhart, and Acting City Manager Steve Anderson.

Council President Ragsdale called the meeting to order and led in the Pledge of Allegiance.

MINUTES

There being no corrections or additions to the minutes of the regular meeting July 1, 1987, they were approved as submitted.

HEARING - PROPOSED ORDINANCE - ZONING TEXT AMENDMENTS SECTION 4-3-4

A hearing was held after proper notice on the petition by the City Attorney and the Planning Department to amend Section 4-3-4 Use/Zone Matrix under the heading of Amusement Business - Inside providing the use category Health/Athletic Clubs and Services (swimming pools as accessory use) be permitted in the Light Industrial (I-1) Zone as a Special Use, and to amend Section 4-3-4 Use/Zone Matrix under the heading of Retail Business Unlimited - Outside providing the category Automobiles, Pickup Trucks, Vans be permitted in the Light Industrial (I-1) Zone as a Special Use. There were no opponents, letters or counterpetitions.

RESOLUTION NO. 32-87 CONCERNING THE REMOVAL OF MILL TAILINGS BY THE UNITED STATES DEPARTMENT OF ENERGY

The following Resolution was read:

RESOLUTION NO. 32-87

CONCERNING THE REMOVAL OF MILL TAILINGS BY THE UNITED STATES

DEPARTMENT OF ENERGY.

WHEREAS, the United States Department of Energy is currently involved in a site selection process and transportation corridor selection process for the relocation of the mill tailings pile currently located near the Colorado River in Grand Junction; and

WHEREAS, the City Council strongly believes that the impacts to the residents of the area should be minimized; and

WHEREAS, the City Council strongly believes that the benefits to the citizens of the area should be maximized; and

WHEREAS, certain alternatives negatively impact the area to a much greater degree than others; and

WHEREAS, the City Council believes that the United States Department of Energy should consider community impacts and not merely bottom-line cost considerations when making its final decisions; and

WHEREAS, the City Council is absolutely opposed to the Department of Energy's preferred alternative of the Ninth Street and Fourth Avenue transportation route, inasmuch as said route would negatively impact the businesses and residents along and within said transportation corridors.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

- 1. That the Department of Energy include all social and economic costs of the truck alternatives in their preparation of bid documents; and
- 2. That transportation by piggy-back rail be the method of transporting the tailings.
