President Ragsdale stated that Council wishes to review the Chlorine Storage Building Project at the Water Treatment Plant a little closer before considering bids for the project; therefore, this item was tabled.

MODIFICATION OF INTERSECTION AT 28 ROAD AND ORCHARD AVENUE - BIDS REJECTED

WHEREAS, the Transportation Policy Advisory Committee has recommended the revision for approval to the Mesa County Board of Commissioners and the Grand Junction City Council; and

WHEREAS, the proposed revision would benefit the citizens and governmental agencies of the Urbanized Area;

NOW, THEREFORE, BE IT JOINTLY RESOLVED BY THE CITY COUNCIL OF GRAND JUNCTION, COLORADO, AND THE BOARD OF COUNTY COMMISSIONERS OF MESA COUNTY, COLORADO;

That the revised Urban Area, Function Roadway Classification and Connecting Link Maps, hereunto attached be adopted, showing an adjustment in the Urbanized Area Boundary that removes Interstate 70 from the Urban Area.

PROPOSAL FROM CHADWICK, STEINKIRCHNER, DAVIS & COMPANY TO PERFORM THE 1987 AUDIT OF CITY RECORDS - \$20,750

Upon motion by Councilman Kirkhart, seconded by Councilman Bennett and carried, the proposal from Chadwick, Steinkirchner, Davis & Company to perform the 1987 Audit for the City in the amount of \$20,750 was accepted.

CHANGE ORDERS FOR STREET PATCHING AND CURB, GUTTER & SIDEWALK CONTRACTS

City Manager Achen stated there are two existing contracts. This will be the fourth change order for both contracts.

Upon motion by Councilman Mantlo, seconded by Councilman Kirkhart and carried, the change order for Street Patching 1987 in the amount of \$20,273.75 was approved, and the change order for Curb, Gutter and Sidewalk Repair 1987 in the amount of \$22,588.09 was approved.

APPROVAL OF EMPLOYEE DENTAL INSURANCE CONTRACT WITH DELTA DENTAL SERVICE

Upon motion by Councilman Theobold, seconded by Councilman Nelson and carried, the Employee Dental Insurance Contract with Delta Dental Service, with the Employer's share being \$63,152, and the Employees' share being \$52,672, increasing the Employees' share approximately \$4,000 over 1987's figure, was approved.

IMPACT ASSISTANCE GRANT FROM COLORADO DEPARTMENT OF LOCAL AFFAIRS - \$200,000 - TABLED

Upon motion by Councilman Bennett, seconded by Councilman Kirkhart and carried, the Impact Assistance Grant from Colorado Department of Local Affairs in the amount of \$200,000 was tabled until such time as Council has had an opportunity to review the Grant more thoroughly.

APPROVAL OF GENERAL FUND CONTINGENCY TRANSFER FOR MCEDC INCENTIVE TO MESA EGGS, INC. - NOT TO EXCEED \$36,895

Upon motion by Councilman Bennett, seconded by Councilman Mantlo and carried, the General Fund Contingency Transfer for MCEDC Incentive to Mesa Eggs, Inc., in an amount not to exceed \$36,895, was approved.

APPROVAL OF COLORADO DIVISION OF TRAFFIC SAFETY GRANT RENEWAL FOR DUI ENFORCEMENT

This Grant is a matching grant. In 1987 the State provided \$30,000, and the City's match was \$5500. In 1988 the State Grant will be \$29,000, and the City's match will be \$4900.

Upon motion by Councilman Theobold, seconded by Councilman Nelson and carried, the Contract with Colorado Division of Traffic Safety for Grant Renewal for DUI Enforcement was approved and the President of the Council was authorized to sign said Contract.
